ACTION TAKEN:

On May 6, 1999 at 1800 (6 p.m.) the Reporting Agent Linda R. HOLLOWAY went to the Larson residence in Littleton to interview Eric LARSON. He gave the following accounts of the events of April 20, 1999:

Eric was picked up at his residence by Nichele DUNN at 7:05 a.m. They drove to school and parked in the Clement parking lot off Pierce Street at 7:25 a.m. He went to his locker and then straight to his first hour computer class in the business area of the school. He then went to the cafeteria at 7:30 a.m. because he found out that there was a substitute teacher. He remained in the cafeteria with Daniel YAGER until first hour was over at 8:25 a.m. He sat near tables PP and QQ however he did not notice anything unusual, like duffel bags, while he was there.

LARSON then left the cafeteria and attended his second period science class, his third period algebra class and fourth period language class. He went outside and down the west stairs into the cafeteria. He sat at table UU which is close to the door he had just entered. He was with Mike LAVAN, Brenden TRUJILLO and Dan RIECKS who are also all sophomores. He sat and talked, not eating lunch because he had forgotten to bring any money for food


Eric LARSON looked out the windows and first noticed another student bleeding. He next recalled that a female teacher came in and told them to get down. He got down for a short period of time and then crawled toward the stairwell that leads to the second floor.

He got up and ran the rest of the way up the stairs. He heard what he thought were six gunshots and an explosion when he got to the landing and he ran down the hall to the front door (that open toward Pierce street). He marked on the provided maps his route out of the building. Once across the street he went to a friend's residence and called his mother.


The only other significant information that he could recall was that he noticed a "kid", probably male, running from the school just before he notice the student that was bleeding. He was wearing a light gray or white shirt. He was running past the baseball fields when he saw him. He did not know if he was running because he may have heard gunshots or if it was before the shooting started.

He did not see any of the shooters or have any other significant information to share.

INVESTIGATION:

On April 27, 1999 at 1100 hours I contacted Stephanie Larson at her home for an interview. Her father, Ken, had just left for a few minutes. He returned home after we were 10 minutes into the interview. Stephanie then told me the following:

- She is a sophomore at Columbine High.
- * She explained that she has 4th hour off. That class period is from 10:20 a.m. to 11:10 a.m. She usually goes to the cafeteria during that period, as she did on the shooting day. She said that there could be 100 to 150 students in the cafeteria area for 4th hour. Many of those students do not have the first lunch hour when the shooting began.

After her 3rd hour science class, she went to her locker by the library. She got to the cafeteria around 10:30 a.m. She was with fellow students David Eagle, Jessica Stephens, Jackie Carroll, Scott

Parker, and a Brock (last name unknown.)[editor's note: possibly Brock] She also noted that several student were in the cafeteria around where she was; Nikki

Lawson, Katie Vicek, Lindsay Swanson, and Andrea Launer.

- * She pointed to the cafeteria diagram and said she spent the 4th hour at table HH. She said there were about 15 to 20 students by the windows, another 20 to 30 by Rebel Corner, and the rest of the students she saw were in the cafeteria.
- * When asked, she never heard of Eric Harris and did not even recognize him in news photos as a student at Columbine. She might have seen Dylan once or twice in the hallways during the school year. She did not know Dylan by name. She did not have any information on how Eric or Dylan dressed.
- * She knows of the trench coat students more from last year than this year. She does not know names of these students. She said that she has seen some of the trench coat students getting into a red and gray Suburban for a ride earlier in the school year.
 - i After 4th hour, she moved to a table nearby. She pointed to table CCC and this was confirmed with the location her backpack was located.
 - i She thought an Angie Urquhart was the only one at that table as she went to get in the food line at the kitchen. She was with Jadara Taliaferro, Cassie Sadusky, Jill Chiakowski, Margaret Burns and Denae Pedersen in the food line.
 - i She was wearing a white long sleeve shirt, khaki shorts and black sandals.
 - i She then heard two to three boys yell, "Everybody get down, get down. She also heard the mention of a gun.




- * She went back to her table an hid under it using her backpack for protection. She said a female Spanish teacher started to yell, "Get down." This teacher was also in a food line.
- * After a few seconds, she said that all the students in the cafeteria started to run to the stairs area.
- * She went toward the food line and turned right to the elevator and bathroom area. She said there was a black door that a teacher, the younger Mr. Andres, opened. This door led to a small set of stairs up to the stage in the auditorium. She was on the stage with some other students for a few seconds and then they all ran up the left aisle (north) to the exit door that is at the main hallway.
- * She said a huge group was going out the main doors. She saw that the windows to the main doors were shot out. She went with a group of students north down a hallway and out a set of north doors. She then went to Clement Park.
- * The only reports she heard were sounds like "banging against metal" when she was under the table in the cafeteria. She thought it sounded like paint balls striking something metal from the kitchen.
- * She did not see any trench coat students in the school or cafeteria that day. She saw nothing but backpacks in the cafeteria. When asked specifically about a duffle bag, she said she did not see any.

This concluded my interview with Stephanie Larson.

On May 6, 1999 the Reporting Agent Linda R. HOLLOWAY went to the residence of Columbine Student Andrea LAUNER, arriving at 7 p.m. Present during the interview were her parents, Deb and Russ LAUNER and her sister, Amanda (13 yoa). She related what she did on April 20, 1999:

Andrea's father took her to school and dropped her of in the teacher' parking lot before school started. She went to her locker and met with friends on the east side of the High School (inside) prior to first period. During 4th hour, she has to classes so she went to the commons (cafeteria), arriving at between 10:20 a.m. and 10:25 a.m. She sat at table DDD with friends Katie VICEK, Nikki LAWSON, Lindsay SWANSON and Lindsey PORTINCASO. Lindsay SWANSON and Lindsey PORTINCASO were there only through 4th period, not the A Lunch period.

Andrea escorted Lindsay SWANSON outside the northwest door of the cafeteria was she took a roll of film for a class project. This would have been just prior to the A Lunch period beginning (10 to 20 minutes). She was photographing her friends and other unknown objects. Lindsay SWANSON'S home phone number was given as (303) 978-1045. She was contacted a shortly after the interview with LAUNER was finished by me and it was learned that the roll of film was taken out of her SOR Pentax camera and put

inside a small black or clear film case and placed in the front pocket of her backpack. Her backpack is a green Eddie Bauer pack that was left in Mr. JOHNSON'S science room in the science wing of the building.

Sheriff's Department who was in charge of the crime scene at that time. He later reported that the roll of film had been located and was in the process of being developed. Andrea then named the people who were at her table NN during A Lunch. They are: Nikki LAWSON, Lara KENNEY, Lauren BONIN, Katie SULLIVAN, Becca GOODWIN, Kristin SHEFFIELD, and Sarah Dodrill.

Andrea related that she had gone through the food line about 5 minutes before the lunch period began and got her meal. She recalled having breadsticks and cookies. She was sitting at the table, facing the stairs when she saw Mr SANDERS coming into the cafeteria and telling everyone to "get down". She thought he may have come from the teacher's lounge area. She got under her table and waited a short while.

She and other then ran to the elevator and got in and began ascending to the floor where the library located

when she heard three gunshots. She estimated that there were 15 children in the elevator at that time.

Upon hearing the gunshots the elevator was sent back down to the lower level and she and the other children

ran into the auditorium. Someone locked the auditorium door and she laid on the cement floor. She was with Kane SULLIVAN, Dan RIECKS, Jeff BARRETT and Andy ANDERSON while she was in the auditorium. She recalls hearing "bangs and explosions"


The next thing she remembers is Mr. ANDRES SR. or IR. coming into the auditorium and told the children to run through the door by the cafeteria downstairs and through the Foreign Language halls and eventually to the outside. She ran to Lara KENNEY'S residence and called her mother. It as about 11:30 when her mother received the call from Andrea.


Andrea left her backpack, a blue Jansport, in the cafeteria. Also in the school in her locker are other books and school material. Her lacrosse items are in Mr. Eric FRIESEN's room. She was wearing a gray lacrosse polo jersey with the big number "22" in it. She also had on blue jean shorts and white tennis shoes. When asked about knowing any of the members of the TCM she stated that she knows who Brooks BROWN is. When asked if she know anyone who has a double pierced eyebrow, she stated that Bree Pasquale may have one.

When asked if she recalled the phrase of the day given after the announcements on April 20, she remembered it was something like "THIS IS GOING TO BE A BAD DAY."

She did not remember anything else of significance in this case. The interview ended at 2000 hours.

INVESTIGATION:

On 05-05-99, at about 8:55 a.m., I interviewed CHS student Michael Lavan as follow up on DN2488. The interview was conducted at Michael's home, in the presence of his mother, Cheryl Lavan.

Michael told me that on 04-20-99, at about 11-10 a.m., he had just finished his fourth period science class, which is located on the upper level of the school. After leaving class, Michael said that he went to his locker and retrieved his sack lunch. Michael said that he then walked downstairs to the cafeteria, and sat down at table UU. Michael estimated that he arrived at said table at about 11-17 a.m. Michael said that while walking to table UU, he did not notice any duffle bag(s) or anything else that he might consider unusual or out of the ordinary. Michael said that he walked past several tables, at which there were students and/or backpacks, as normal. Michael described table UU as being "about three tables from the door," referring to the door located in the northwest corner of the cafeteria. Michael said that he sat with students Daniel Riecks (10th), Brenden Trujillo (10th), Eric Larson (10th), and Brian Soderberg (10th). Michael said that he remembered facing southwest while sitting at the table.

Michael said that he finished his lunch at about 11:25 a.m., whereupon he saw a group of students gathering along the west windows and near the door in the northwest corner of the cafeteria. At that time, Michael said that he saw a "kid" lying outside

the northwest door. Michael said that he thought this individual had been hit by the door or had had a seizure. Michael said that he then heard his friend. Brenden Trujillo, say that he saw blood on this individual. Michael said that he was still sitting at table UU at this time, and could not see up the stairway outside the northwest door. Michael said that he then got up and walked to the west windows to see what was going on. At that time, Michael said that he saw another individual lying outside, near the base of the stairway. Michael said that this individual was attempting to move around and was screaming. At that time, Michael said that he remembers teacher Dave Sanders, who he thinks came from the area of the faculty lounge, run outside to check on the kid lying by the door. Michael said that Dave Sanders then told everyone in the area to "get down."

Upon hearing this, Michael said that he then moved behind a large post located on the west side of the cafeteria, between tables UU and VV, and ducked down. Michael said that at that point, he was no longer looking outside through the windows, and remembers seeing student Leiha Murphy (10th) under table VV, and student Matthew Katzenmeier ((10th) near the southwest corner of the serving line. Michael said that up to that point, he had not heard any gunshot(s) and still did not know what was going on. Michael said that he then noticed several students elsewhere in the cafeteria began to run toward the interior (east) stairway and run up the stairs. Michael said that upon seeing this, he also began to move eastward, toward the interior stairway. Michael said that for the first time, he heard what he thought were gunshots while approaching the stairway. Michael said that because of the large group of students crowding the stairway, he decided to take the elevator located near the bathrooms in the southeast corner of the cafeteria. Michael said that he got onto the elevator "with about twenty other kids." Michael said that the elevator then took them to the upper level, whereupon he saw a lot of smoke when the doors opened. Michael said that he thought there was a fire on the upper level and that it might not be safe to get off. Michael said that he remained on the elevator, which took he and others back down to the cafeteria level.

Upon exiting the elevator back on the lower level, Michael said that teacher Leland Andres led he and others into the auditorium and locked the auditorium doors. Michael said that he remained inside the auditorium for approximately ten minutes, during which time he heard both sporadic gunshots and explosions, but was unsure of where they were coming from. Michael said that a janitor then entered the auditorium through the bottom doors, at about the same time that Leland Andres was approaching

the upper portion of the auditorium. Michael said that the janitor was yelling to the students not to approach the upper portion of the auditorium. Michael said that he and other students then returned to where this janitor was, near the lower portion of the auditorium. Michael said that the janitor then ushered he and others out the bottom doors of the auditorium and told them to exit the building through the south doors near the foreign language area on the lower level. Michael said that he and others then ran east down a hallway, and then south down the hallway near the foreign language classrooms, and finally out of the school through the southeast doors. From there, Michael said that he ran down a steep grass hill and then southward across the junior parking lot. Michael said that he did not see any police officers on the south side of the building when he ran out, but remembers seeing some ambulances. Michael said that upon exiting the school grounds, he ran across Pierce Street to Leawood Park.

Michael said that at no time did he see any shooter(s) or anyone wearing a trench coat. Michael said that while sitting at table UU, he remembers seeing the following students sitting (he thinks) at table TT: Daniel Palmeter (10th), Brian Rathbun (10th), Aaron Brown (10th, Brooks Brown's brother), Adam Sands (10th), Matthew Depew (10th), and Jacob Bauer (10th).



Nicole's mother was present during the interview.

Nicole told me the following:

She was in school and attended all of her classes on April 20th. She went to the cafeteria during 4th hour. 5th hour is her lunch. She was in photography prior to that. She and her friend were sitting at table NN. (See diagram) With her was Andrea Launer, 8861 W. Progress Place, Littleton 80123 303 979-3705. Parents are Deb and Russ Launer. The bell rang for 4th hour to end. She and Andrea were just talking and waiting for their friends to get down to the cafeteria for lunch. Andrea noticed nothing unusual in the cafeteria at that time.

Their friends came down and sat at the table. The friends were:

Kristen Sheffield, 7556 Park View Mountain, Littleton. Parents are John and Alana Sheffield 303 979-4308, Becca Goodwin 7754 W. Plymouth Place, Littleton, Mom is Margo Goodwin 973-2746. Sarah Dodrill 6380 S. Kendall St., Littleton 80123 Parents are Lynn and Kathy Dodrill 303 795-3383, Lara Kenney 6073 S. Lamar Drive, Littleton, CO 80123 Parents are Fran and Glen Kenney 303 795-1547 and Katie Sullivan (no info. available).

Nicole heard Mr. Sanders come in and yell get down and everybody got under tables. She thought it was a senior prank. The girls at her table were laughing because they thought it was a senior prank. While they were under the table, she heard shoes squeaking. After about 30 seconds everybody started to run. She didn't hear any bombs until they were all running. She saw Mr. Sanders running in the middle of the cafeteria.

Nicole said that there was pop spilled on the floor and people were slipping. There were chairs sprawled on the floor from people knocking them over. People had to run around the chairs.

Nicole ran past the maintenance elevator and Mr. Andres, Jr., the music teacher. She ran through the auditorium. She was hearing bombs going off and could feel shaking, like a vibration on the floor. She ran out the main hallway by the counseling office and ran outside. Outside she heard muffled bombs. She looked back at the school and she didn't see any smoke. She hopped a fence by Clement Park. There were teachers leading kids.

Nicole said that TCM were abundant last year. She said that she had heard from an unknown source that if girls wanted to join the TCM, that the had to sleep with an unknown guy who wore a beanie hat with a propeller.

Nicole said that a girl named Kelly Schwab in her history class always wore a black trench coat to class. (7593 W. Elmhurst Drive,

Littleton 80123 979-5811 or 8676 W. Progress Place, Littleton 80123 same phone number. Tommie is a parent.)

Another girl who wore a trench coat is Stephanie Kenney, 7029 W. Chestnut Drive, Littleton 303 973-7886 Marie and Steve Kenney are parents. Stephanie wore a red head band with devil horns and a trench coat.

Stephanie and Kelly would draw "fnords" on the black board. Fnords are little symbols that were servants of the devil. They would draw a whole bunch of them. They did it when no one was looking. They hadn't been around this year.

Nicole said that she heard that Ashley McKenna was in a science room with Mrs. Williams, by the main hall. Ashley heard somebody say, "Come on Joey." (7767 S. Depew St., Littleton, CO 80128 303 904-2755 Brian and Ilsa are parents.)

Nicole never saw the shooter(s).



With the permission of LAWSON's father, STEVE LAWSON, a witness interview was conducted concerning LAWSON's knowledge of the shooting and bombing incident at Columbine High School on April 20, 1999 at approximately 11:15 a.m. LAWSON stated that at approximately 11:20 a.m. on April 20, 1999, he dropped off his backpack in the Tech lab and then proceeded to the school cafeteria. LAWSON went through the lunch line and proceeded to find a table in the northwest corner of the cafeteria near the exit door (approximately 10-15 feet from the door). LAWSON was sitting at the table with a friend whom he identified as IAN HALES. At approximately 11:30 a.m., LAWSON hears seven or eight shors from a semi-automatic weapon and all the people inside the cafeteria stand up to find out what is going on. LAWSON states he heard someone yell, 'he's got a gun." At this point all the students and teacher in the cafeteria fall to the floor arid take cover, except LAWSON. He remains standing and looks out the window and observes DYLAN KLEBOLD standing near the door to the cafeteria. LAWSON stated he has known KLEBOLD for approximately one half of a semester and is positive it was he. He is approximately four feet from the window and stated he saw what appeared to be two male students, one wearing a black shirt (no further description available) and one wearing blue jeans (no further description available) running up the hill in a northerly direction toward the tennis courts. KLEBOLD then turns his attention from LAWSON to the two individuals running up the bill and shoots at both of them. LAWSON believes KLEBOLD shot one of the individuals twice in the legs and the second individual appeared to be shot in the back Both continue to run up the hill, away from KLEBOLD leditor's note: pos s ibly: Michael Johnson and Mark Taylor]

KLEBOLD after shooting at the two individuals running up the hill, reaches into his backpack and produces a pipe bomb approximately 12"-18" in length, both ends were larger than the diameter of the pipe, appeared to be painted silver. KLEBOLD lights what appears to be a red piece of cloth, which appears to be a wick attached to the pipe bomb and throws it with his right hand into the student parking lot. KLEBOLD's left hand still contains the semi-automatic pistol. While he is throwing the pipe bomb he is laughing out loud. After throwing the pipe bomb LAWSON and HALES run out of the cafeteria and outside LAWSON does not see KLEBOLD again or any other shooter. While running to exit the building, LAWSON heard approximately five more shots and one loud explosion from inside the school and from where he last saw KLEBOLD.

LAWSON described KLEBOLD as 6'5"-6'7" in height, skinny, blond hair collar length, wearing a black ankle length trench coat, buttoned up, wearing a black baseball style cap with a red emblem in the front (worn correctly), a black backpack worn on KLEBOLD's back and nothing covering his face

LAWSON stated although he has only known HARRIS and KLEBOLD for one half of a semester he has talked with them both. He describes HARRIS as a thinker, very smart and something always on his mind. He believes HARRIS planned the entire operation and KLEBOLD only followed instructions from HARRIS

LAWSON stated HARRIS frequently told racist jokes and stated he admired Adolph Hitler for his intelligence but didn't like him because he took the easy way out. HARRIS also told LAWSON that he was not a racist. LAWSON stated this action by HARRIS and KLEBOLD did not really surprise him based on some of their beliefs and actions. LAWSON stated he believed HARRIS and KLEBOLD made a movie depicting people running down hallways and catwalks shooting at each other. This movie is on a computer in the computer tech lab on a computer next to the scanner. The movie is contained in My Documents file.

LAWSON stated that only two individuals shown in the photograph contained in the 1998 Columbine High School Yearbook of the Trench Coat Mafia are actually members. LAWSON identified them as JOE ST AIR and CHRIS MORRIS. LAWSON stated the group was formed because the members were considered outcasts and were called names by others in the school. LAWSON advised that the following personnel could provide additional information on the members and associates of the Trench Coat Mafia:



No parent was present during the interview. Martin and his mother said that Martin wanted to speak with me without her present.

Martin told me the following:

He had been to all his classes on the morning of the incident. He went to the cafeteria a little early because his choir class got out a few minutes early. He was sitting in the cafeteria at table XX (see diagram) with Aaron Brown, Brian Rathbun, David Smith, Jake Maes and some other people, but he forgot who they were. He noticed nothing unusual in the cafeteria.

Martin said that he heard some commotion outside of the cafeteria, like people wrestling around. (He then said, like something going on.) He said that he got up from the table and looked out the window by his table. He thought maybe there was a fight. He didn't look into the parking lot. He saw someone running. This person was wearing shorts and a white tee shirt. It was a white male who didn't have a hat on. That is all Martin could say about this person. Martin said that someone had fallen down. He couldn't see. People were saying that the person was bleeding.

Martin said that right about then, Mr. Sanders ran into the cafeteria and told everybody to get down under the tables. A couple of seconds after that, everyone started crawling through the tables and chairs and in the middle of the cafeteria. Martin got up and ran up the stairs.

Martin said that he heard a whole bunch of guns going off. It sounded like the shots were coming from outside. When he got by the stairs, it sounded like the guns were going off inside the cafeteria. When he got to the top of the stairs, the guns sounded like they were rapid firing. He said that some people fell down, but got up again. He ran down the hall that goes past science and math, and then out the door by the math hall.

Martin ran down the stairs and hopped the fence to a brick ledge and then went across the street and hopped a fence to the park. He said that he could hear gun shots going off the whole time.

Martin never saw the shooter(s). He said that he heard from "a bunch of people" that the shooters were TCM. He said that a student named Dan Riecks told him that they saw more people in trench coats at the top floor elevator.



INVESTIGATION:

On May 7, 1999, at about 0900 hours. I responded to 8132 West Portland Avenue, where I met with witness Michael Leary and his step-father, witness Keith Pearce. I interviewed Leary about the shooting incident at Columbine High School that occurred on 04-20-99.

Michael Leary said on 4-20-99, at about 1020 hours, he went into the cafeteria at Columbine High School to eat his lunch. He said he had fourth hour off from any classes so he was in there earlier than some of the other students. Leary said he was at a cafeteria table at the east side of the cafeteria, in about the middle and near the stairs that lead upstairs to the second floor of Columbine High School. Leary said he was with the following students at this table (table either number II or number U on the cafeteria map) Jonathan Caruso, Pat Simington, Danny Gonzalez, Dusty Hoffschneider, Craig Scott (victim Rachel Scott 5. according to Michael Leary), Jason Jones and Eric Trujillo. Leary showed me on a map of the cafeteria of Columbine High School where he had been sitting, and where Jonathan Caruso, Pat Simington, Danny Gonzalez, and Dusty Hoffschneider had been sitting at this table, and the direction that they had been facing. Leary did not recall where the other students present with him had been sitting. Leary said he was facing an easterly direction. Leary said he "heard a couple pops." but did not think much about it because he believed it was a senior prank taking place. Leary said suddenly a student. Justin Norman, ran from outside of the cafeteria, through one of the doors on the south side of the cafeteria, to the inside of the cafeteria where he said that someone had got shot. Leary said he still did not take any of this seriously until a janitor ran into the cafeteria and told everyone there to get down on the floor and under the tables. Leary said he got up onto his knees to try to look out of the cafeteria windows to see what was taking place, and said he saw smoke outside of these windows. Leary said the students inside the cafeteria suddenly got up and began to run towards the stairs that lead up to the second level of the high school. Leary said he and about 15 other students got onto the elevator, and went up in it to the second level. Leary said when it got to the second level and the elevator door opened he heard a loud explosion and said it was caused by a bomb going off just outside of the library. He said the students went back down on the elevator to level 1. When the elevator door opened on level 1 a teacher, Mr. Andres, Jr., was there and told the students to go into the auditorium. Once inside the auditorium the doors were locked and Leary said they stayed in there for about 15 minutes. Leary said at one point they heard other kids trying to get into the auditorium, but they did not open the door for them. I asked Leary how he knew it was students and not the suspects, and he said he did not know. He

said nothing was said that he could hear, and after knocking a couple times the people outside this door left

Michael Leary said the students lined up, and then all ran out of an auditorium door, down the hall in an easterly direction, past the foreign language department and exited the school.

Michael Leary said he was wearing a white polo shirt, khaki colored cargo pants, and a white "Uconn" baseball hat on 4-20-99 Michael Leary said he did not know who Eric Harris was, and said he knew suspect Klebold about 6-8 years ago when they played on the same baseball team. Larry said he had not spoke with or associated with suspect Klebold since and in fact did not remember anything about Klebold, either from the present or from the time they played baseball together. Leary said he had seen suspect Klebold in the hallway of Columbine High School, however, he did not see him on 4-20-99. He said the last time he saw suspect Klebold he wore a baseball hat with the letter "B" on the front of it and had a Colorado Avalanche patch on the back of this hat. He said Klebold wore the hat backwards. Leary also said suspect Klebold wore an ankle length black trench coat that the believed was made out of cloth. Leary could not provide a description on the shirt, pants, or footwear that Klebold wears

Michael Leary said he did not see any duffle bags, or the propane tank in the cafeteria of Columbine High School, nor has he seen anyone carrying any of these items. He said he has no knowledge of anyone that may be manufacturing any explosive devices and/or possessing firearms. Leary could not provide any information about "Trench Coat Mafia."

ADDITIONAL INFORMATION:

Michael Leary said on 4-20-99, both prior to and during the incident, he did not see suspect Klebold, suspect Harris or any other people with firearms, bombs, etc. Since the incident and upon returning to school at Chatfield High School, Michael Leary advised me that he heard the following information. Leary said a female friend of his, Tara Zobjeck was told by Jennie Paavilainen (unknown spelling)

as involved in the Columbine shooting incident. Leary said that Jennie was told by "Yes, and he had every right to be." No further information was given to Leary about this conversation. He advised that if he hears any more information he will contact me in the future





Stephanie stated on 4-20-99, at around 1110 hours, she was released from her geometry class MA-11, class was being taught by Ms. Leslie Layman. After she was released from geometry she went to her locker which is located in south/east area of the school, her locker number is 307. After she was finished at her locker she went to the cafeteria area where she arrived at 1115 hour, and after she was shown a diagram she stated she sat at table "OO." Also at the table were her friends, Jamie Thurmon, Jenny Naifeh, and Laura Bickmore. She also provided me with Laura's telephone number 303-978-0066.

Stephanie stated once she arrived at her table she placed her backpack on top of the table at which time her and Laura went over to the south/east corner of the cafeteria which is called "Rebel Corner" where they have a school store and she purchased a pop After she got her pop and Laura got her lunch they proceeded back to their table, but never made it to the table. She described when they reached the commons area, near the stairs, a janitor came running in the south doors of the cafeteria telling the students to get under their tables. She described the janitor as small with a buzzed head, he was wearing a white t-shirt which had Columbine Rebel's Baseball on it. Stephanie said that her and Laura were out in the middle of the commons area and they crouched down at which time she observed students over near the west side of the cafeteria start to move east towards them Stephanie stated as the students started to move from the west side of the cafeteria that is when she heard one gunshot, it sounded like it was in the senior parking lot, west of the cafeteria. Stephanie stated she did not see any gunmen outside or in the cafeteria area when she was in the building. Stephanie stated again the students were told by the janitor to get down at which time several of the students started to move out of the cafeteria area. Stephanie stated she followed a group of seniors who moved east from he cafeteria down to the business and foreign language hall, about halfway down the hall she stopped with the group she was with at which time one of the unidentified males in the group said he saw an individual outside the school who was shooting and the party stated that he thought the gunman was coming towards them and they needed to continue to move, at which time the group proceeded down the foreign language hall where they sought refuge in a classroom located in the south/east area of the school, in the lower level.

Stephanie stated while they were in the classroom she heard three additional explosions and believed they were coming from the upper level near the library, and they could feel the shock waves from the explosions. Stephanie explained that they stayed in the classroom from about 10-15- minutes at which time one of the seniors she was with, a Leigh Kamens, told the group they couldn't stay in the classroom that they probably weren't safe. Stephanie stated there were five teachers also in the classroom. She stated that the teachers were Cheryl Lucas, Jason Webb, Rudy Martin, Judy Kelly, and an unidentified substitute teacher who was teaching one of the business classes. Shortly after the fire alarms went off she stated that the group, lead by Leigh Kamens, exited from an emergency exit just outside the room they were concealed in, at which time they ran through the junior parking lot located on the south side of the school, and that all the individuals ran to the Mormon Safe House, located at 6805 West Poke Avenue, where they sought help. Stephanie stated about 1150 a.m. they were joined by an individual by the name of John

Savage, and that John had told them that Eric and Dylan, his two friends were the gunmen, and that Eric had located John, hiding under a desk inside the school, wherein Eric pointed a gun at his face and upon recognizing John Savage told John, "You can go," at which time John fled from the school and ran to the Mormon House. Stephanie stated that John was chalk white in color and he was very scared and she believed his story.

Stephanie was asked if she knew Eric Harris and Dylan Klebold. She stated she did not know any of the individuals nor did she know any other members who are involved in the Trench Coat Mafia. Stephanie was asked if she had heard about any rumors about an incident such as this occurring. She stated there were no rumors around school. I had Stephanie describe her dress during the incident date. She stated she was wearing a black skirt, a maroon short sleeve shirt, a pair of black shoes, and a black leather coat. Again, I verified that Stephanie did not see any gunmen at Columbine H.S. nor did she see the two large duffel bags. I described earlier in the cafeteria.

Stephanie was provided a map of the cafeteria at which time she diagramed where she was seated in the cafeteria, and her movements out of the cafeteria. A copy of that map is attached to that report.



On 5/19/99 at 1000 hours, I interviewed Patrick Leiker in the presence of his father at his home. Patrick stated he recognized Harris and Klebold's faces from passing in the hall, but he did not know their names. Patrick stated that, in his freshman year, he had talked to some of the trench coat mafia members, Tad Boles and Chris (he could not remember Chris' last name) [edited: likely Chris Morris]. He stated they didn't talk very much because one conversation they had concerned Religion and Tad and Chris were very closed-minded about that.

Patrick stated he drove to school the morning of 4/20/99. He arrived between 0700 hours and 0710 hours and parked in Clement Park. He stated he was with another student, Adam Kyler. He stated it was a typical day and he didn't notice anything unusual. Patrick has Chemistry first hour, Journalism second hour, German third hour, Algebra II fourth hour. He stated he did not see Harris or Klebold that day at all. After his fourth hour class he went to his locker then walked to an art class on the upper level, then he went to the cafeteria. He stated he left the school out the doors north of the library and walked down the stairs outside. He did not see Harris or Klebold outside. He entered the cafeteria through the west door. that usually for breakfast there is one window open and that there is a cashier that works the window.

Liane said that on 4/20/99 she was working a cashier for the lunch line. She said that she remembers a student

running in from near the faculty lounge area, running across the north side of the cafeteria yelling to get down!.

She said that she began to observe people getting down on the floor. She said that Mr. Sanders then came from

the same general area; she didn't see where he'd come from but first noticed him coming near the faculty lounge

see where he went. She said that at about the same time, numerous students started for the stairs. She said that a student named Matt [editor's note: Matthew Depew], who she believes his father is a police officer, came running across the cafeteria to her and asked her if there was a phone. Liane said that she had just kind of frozen in her position, and then helped Matt into the kitchen, and pointed him to a back room where there was a phone. She said that there was a wave of people that came through the kitchen, and that she ended up going into the storage room. 



She indicated that on 04-20-99, at approximately 1120 hours she was in the cafeteria standing on the west side by the windows, talking to some students when she saw another teacher identified as Dave Sanders come into the building and yell, "Get down, he's got a gun." She advised that she looked outside and saw a male subject, description unknown, throw something into the parking lot of the south side of the building. She advised this same individual pulled what she described as an automatic pistol from under his coat. Witness Lucas advised that she could not identify this student, but by all accounts she had heard and read about this individual was later identified Dylan Klebold, according to witness Lucas. She indicated that Dave Sanders yelled once again for students to get down and out of the area, at which time she advised that something very serious was happening. She also began yelling at students to get out of the cafeteria She advised that most students exited the cafeteria by way of the stairs on the east side of the cafeteria. This time frame was approximately five minutes for all this to occur. She said that she and other teachers and students attempted to go up the stairs, as they were rounding up what she believed to be the last group of students, when she heard an explosion coming from the top of the stair area and smoke bellowing down into the stairwell. She advised that her and two other teachers, Mrs. Park and Mrs. Kelly, took these students and went down the Foreign Language hall. It was at this time she heard the fire alarm sound. Witness Lucas indicated the only thing she could think of was the incident in Jonesboro, Arkansas, where the fire alarm had been activated by one of the suspects, and as students exited the building, were shot. With this in mind, she told kids not to go outside when she heard the fire alarm go off, as a potential ambush may be occurring. She indicated that she went into the last Foreign

She indicated that she lived in the area and had made arrangements with her husband to pick her up at the end of the block. Witness Lucas did not provide any additional information to this incident.





Today we got out of school really early only because some people wanted to blowup the school. I was in the cafeteria, or commons as we call it, when this whole thing started. At first every one thought it was a senior prank only because the seniors were talking about a really big prank that they were going to pull. We all heard an explosion and then saw smoke. We all thought they put a smoke bomb in one of the seniors or juniors cars, only as a joke. Then there was another explosion, only louder this time and even more smoke so we all started to wonder what was really happening. Then Mr. Cram came running in yelling at every one to get down. We all got down and then some one said to my friend. Sarah Gillings, and me that there was a guy in the parking lot throwing pipe bombs around. One of the janitors came running in and told us to go with thim so we followed because we knew then that this was not a joke: We hid in the entrance of the kitchen. Then that is when the loudest of all the explosions for me was, only because it was the closest and it was inside of the building. Then Mr. Andres Jr. opened some doors that led to the stage of the auditorium. Everyone that went through that door went really fast. Sarah and I were holding hands to make sure we knew where each other were. We lost each other when we were running through those doors. We found each other on the stage and linked up again. We started running again. We ran up the stairs that was in the auditorium in order to get to the second floor. We ran down the hall, past the main office, down the counselor's hall and out the door to the smoker's pit. The smoker's pit has 3 fences. On the left is a baseball field, on the right there is a tennis court. In the center is a fence about 4 to 4 ½ feet tall. Sarah was starting to get hysterical saying "they're comering us in, they're comering us in." We jumped the fence and ran towards Clement Park. I told Sarah "if we got separated to go to the car." We found Shelly [editor's note: Shelly Jenkins] and the 3 of us held hands running. When we got to the car we found a lot of people and we just piled into the car. Then some people were looking for an inhaler and Shelly had one. We then were told to not go home because they wanted a head count. We then went and sat down on the

people and we just piled into the car. Then some people were looking for an inhaler and Shelly had one. We then were told to not go home because they wanted a head count. We then went and sat down on the grass by the street Pierce. We saw a lot of police cars. Shelly was really worried about her brother[editor's note: Brad Jenkins] only because he was in his truck in the student parking lot. He was in the direct line of fire. So Shelly was also pretty hysterical and worried about her brother. We then started walking home and my 7th period teacher, Mrs. Waseko, told us that we should go home if we could. I asked Sarah and Shelly if they wanted to go to my house and they said, "it would be a lot better than staying here." I told Sarah that I was going to go get the car. She gave me a big hug and said, "you better come back and in one piece." I went back to get my car and people were yelling at me because they thought I was going back inside of the school. I got into my car and they stopped yelling at me. I then drove up on to the grass looking for Sarah and Shelly. I didn't find them but I did find Mrs.

Waseko, She said, * how did you get your car?* I told her that I went back to get it. She said "Stupid, Chris, that was really stupid." I didn't find Sarah and Shelly in that part so I went to the other sidewalk. I found the two of them and honked the hom. They really jumped and I really did not mean to scare them. They got in the car and we went to my house. When we got to the stop light Sarah turned on the radio to see if there was anything about this event on the radio. When we got to my house Shelly and Sarah called family members. I took Shelly to the Governors Ranch Elementary school to wait for her brother. When I got home from waiting with Shelly, I found out that my mom had taken Sarah to her cousin's house. After my morn got home from taking Sarah, we watched the news. About 1:30 Ashleigh and her mom arrived at our door. We all watched the news. Later Larry showed up after Linda left. Later Linda showed up and we ordered 2 pizzas. We ate and then Larry, Linda, and Ashleigh left. That night I'was unable to go to sleep only because I was paranoid about some one standing there in the dark waiting for me to go to sleep, and then kill my dog Charlie and I. I had to turn on the lights; I can't sleep with the lights on, in order to make sure that I was safe. I have never been more scared in my life. I was never afraid of the dark until now. I was also afraid to be alone, so I made sure I had someone alive, my dog Charlie, I did not sleep much.





Naomi proceeded to tell me that she was seated at table V and also seated at the table were her friends, Lauren Beyer, telephone number (303) 979-8636, Lindsy Blair, telephone number unknown, Brandi Malonson, telephone number (303) 933-3269, Sarah Filipiak, telephone number (720) 981-0823, and Alex (last name unknown) [editor's note: Alexandra Goldberg]. Naomi stated after she placed her backpack at her lunch table she proceeded to the food service line and shortly returned, where she began to eat her lunch.

Naomi describes seeing Mr. Sanders come into the cafeteria area, at which time he was telling the students to get down, somebody had a gun. She describes Mr. Sanders as being near the south doors of the cafeteria. Naomi advised that she then started to hear popping noises coming from outside and that she could see people running back and forth outside directly south of the cafeteria. Naomi grabbed her friend, Lauren Beyer, and the two of them ran to the stairs and proceeded up the stairs to the main level of the school and ran east down the science/math hallway, exiting from the school where they went to Leawood Park. After they reached Leawood Park they went to their friend, Lindsy Blair's house, where they remained,

Naomi was asked while she was in the cafeteria if she saw two large duffle bags or sports bags, one being described as being blue in color and the other one is an orangish/red, which were located in the central core area of the cafeteria. She stated she did not see the bags and could not provide any additional information about them. Naomi was asked if she saw any gunmen while she was in the cafeteria area or if she saw any gunmen after she exited from the school. She stated she did not.

Naomi could not provide any additional information reference the "Trench Coat Mafia," specifically Eric Harris or Dylan Klebold, nor could she tell us any possible associates of this group.

I asked Naomi to describe what she was wearing on the incident date. She told me that she was wearing a light blue short sleeve shirt with a long plaid dress on. I had Naomi describe the backpack that she left in the cafeteria. She told me it was a navy blue Eddie Bauer backpack and that she didn't leave any additional items in the cafeteria. Naomi was asked if there were any rumors about school in reference to April 20th. She told me that she didn't have any additional information to provide.



Once in the math room she ran out another door and went down the stairs, exited the building and ran toward Leawood Park. I asked Brianna if she ever heard any explosions and she said she did hear an explosion while she was running through the school. I asked Brianna if she saw who was doing the shooting or who made the explosion and she said no, she did not. I asked Brianna if she saw any backpacks in the cafeteria that appeared to be suspicious or out of place and she said no, there's always backpacks in there and it would be hard to determine if they were suspicious or not. 

Into the store office and then into the classroom where they hid for 3 ½ hours. Shots and explosions were heard during that time. They stayed until the SWAT unit came and directed them out the window in the teachers lounge.

Ms. Madden added that she did not see any large duffel bags in the Commons, as she never went into that area. She did not recall anyone carrying such items on Monday or upon her arrival on Tuesday. Liza did explain that from Friday afternoon the school prepared for 'Prom' and 'After Prom Party'. Students from school, parents, volunteers, + faculty brought stuff in to prepare for the party. Anyone had access to most of the school.

This witness does not recall seeing either suspect or others that wear trench coats at school on Tuesday. She does know Eric Harris, as he worked w/ Liza's friend, Kristen Quikien at the Blackjack Pizza Parlor and would often ask her out. She never did go out with him.

Reportedly, Pauline Colby, a friend of the suspects, was at the marketing banquet in the morning, but got ill on the way home and didn't show up to work at Rebel Corner.







MAES began by saying she had been previously interview by an investigator from the Columbine Task Force about three weeks ago.

MAES reiterated having been by the Rebel Corner sitting with fellow classmates Crystal ARCHULETA, Janell and Aleia RUSSELL, and Veronica NUNCIO on a window ledge at about 11:20am on April 20, 1999. She describe hearing a "commotion" coming from outside so she went outside exiting through the doors by Rebel Corner with NUNCIO and ARCHULETA.

When they got outside an unidentified student told them to get down, which they did. She recalled seeing a tan colored, possibly 1980's "beat-up" compact pick-up truck driving around in the parking lot briefly, then drove from the lot turning possible right leaving the area.

She said at this point she looked to the area at the top of the exterior stairs on the west side of the cafeteria and saw a suspect whom she thought was student. She clarified that this could have been Dylan Kleboid, as she did not know either one of them prior to the shooting. She described this person was wearing a black trenchcoat, a black baseball style cap on backwards, black pants and black boots with possibly a white shirt. She said she saw this person walking down the grassy hill, but could not recall on which side of the stairs he was walking.

MAES said she thinks she recalls this suspect carrying a "long gun," as she thought he fired at some point toward the soccer fields. She went on to say at some point this person retrieved a pipe bomb from his coat and threw it into the student parking lot. They then turned and ran back into the cafeteria through the long row of doors when she heard an explosion from the area of the parking lot. After this they exited the school where she ran toward Pierce Street where she stopped a white pick-up truck driven by an female student not known to her. This person drove her from the area.





She indicated where the gunmen were in the cafeteria and then where one of them moved toward table "RR".

Brandi ran up the stairs to the top floor to the area by the choir room. She stated she then ran into the auditorium from the south side. She ran through the auditorium to the top floor and ran out the north east door into the hallway. Brandi stated she saw blood on the lockers outside of this doorway. She heard gunfire and saibly some explosions. She ran east out through the front door and as she was approaching the front doors, she heard gunfire coming from behind her and the glass in the doors were shot out at that point. Once outside she ran to Clement Park and to the Jefferson Apartment complex on the north side of Bowles, and from there she called her mother who came to pick her up.

Brandi had a maroon Jansport backpack that contained her math book, Spanish book, notebooks, an agenda book, and her jeans wallet that had a Winnie-the -Pooh on it. Also in the bag was a make up bag that look similar to the wallet. Brandi was wearing a black dress with a flower design and she had on black sandals

Brandi stated she does get on the Internet a lot. She stated a couple days after the shooting she brought up ERIC HARRIS' profile and printed on it. (See attached) She stated this was his AOL profile and she had never brought up any of his information or KLEBOLD's information before. She stated she brought HARRIS' profile up because she was curious.

Brandi remembered the thought for the day as being something to the effect of "I bet you wish you weren't here", which was in real small text.

On the morning of 04-20-99, Brandi stated that she heard a freshman by the name of Courtney remark to another unknown girl that she was going to "go get high because something big is going to happen at lunch" Brandi stated Courtney emphasized "Big" a lot. Brandi stated Courtney is a Gothic-looking girl with long black hair.







INVESTIGATION:

On May 6, 1999 at 1829 hours I contacted Valeria Mar at her home for an interview. Her mother was present. While at the home, I also interviewed Valeria's twin brother, Arty [editor's note: Arturo Mar], who was in a science room during the incident until rescued by SWAT. Valeria then told me the following:

- * She is a freshman at Columbine High School.
- * When asked about Eric Harris, she said that she does not know him by face or name. She may have seen him in a trench coat once or twice in school, but she was not sure.

- * When asked about Dylan Klebold, she said that she does not know him by face or name.
- * When asked, she did not know



- * She did not know any other trench coat students or associates. She has only seen the one student once or twice in school this year.
- * She has never heard of the name "Trench Coat Mafia."
- * She did not see any suspicious objects in school that day. When asked specifically, she did not see any duffle bags.
- * On the day of the shooting, she had a 4th hour ceramics class in the art area of the school. She stayed a few minutes late in that class to help clean up. At about 11:15 a.m. she walked down to the library with Margot Brown. Margot was going to spend the lunch time in the library.
- * She then walked down to a table in the cafeteria and dropped her backpack off on a chair to reserve her spot. She did not know who else may have been at that table as she and her friends usually sit at three tables that are grouped together. She looked at the diagram and said she dropped her pack off at table KK. This was the location her pack was recovered from. She and her friends sit at KK, LL, and FFF.
- * After she dropped her pack off, she went to Rebel Corner to get a meal. She was joined by Margot Brown who decided not to spend the lunch hour in the library.
- * While in the line to get her food, she saw several students going out the south doors. A few minutes later she saw the students come back in. She then saw everyone in the cafeteria getting down under the tables. She then moved over to one of the tables by Rebel Corner and got under it. She then followed a group out of the

cafeteria that went down to the foreign language area. She wound up in a Spanish class that is in the far southeast corner of that area. She went under a desk for about 5 minutes. She heard 3 or 4 gunshots or explosions. Two unknown teachers then had them run out the south exit door by that classroom and through the lot to a Mormon house on Polk Street. She said that she stayed in the garage to that home. She did not hear anything else.


- * She did not see any suspects.
- * She was wearing jeans, a cream colored vest, and black sandals on the day of the shooting.
- * She added that a girl who sits in front of her in her 1st hour geometry class told her on the morning of the shooting that a lot of people were going to get "high" that day. She said the girl said it was "4-20 day." There was also a mention about police. (This is consistent with information about "4-20" being the code and a date for marijuana smokers.) She thought the name of this girl was Michelle.

QBSERVATION/INVESTIGATION:

On 051499 Sgt. Webb and myself contacted Joey Marcotte at Charfield High School, where I told her I needed to speak to her about some information regarding the shooting incident. Joey stated that she had no problem talking to us. I told Joey that I needed to ask her questions about her description of one of the shooters. Joey stated that she had seen the suspect come into the cafeteria wearing a black baseball hat, but she couldn't see his face very clear because it was covered up, but he was wearing an orange or white Tshirt with some kind of writing on it, then he had a trench coar on, with some kind of automatic weapon. I asked Joey if she saw his hair, and she stated that she remembers that he had long curly black hair. I asked Joey if she could describe his pants and she stated that they were "real baggy" black jeans. { asked if the pants were some other type of material or jean marerial. Joey was certain they were jean material I then asked Joey where she was when she saw this individual,, and she stated that she was down on one knee (which she demonstrated), under table "E", Joey stated that she was under the table about an bour and a balf, and that she heard a lot of angry yelling and cussing form someone with a "deep dark mean and scary voice". I asked Joey if she could tell me what they said, and she stated that the voice stated "Today is the day the world comes to an end, today is the day we die. I asked Joey what else she remembered and she stated that she heard lots of explosions, and gunfire, and that the smoke started getting thick in the cafeteria, that's when she started crawling to the door to get out. I asked Joey which door she went out, and she stated that she went out by the "Rebel Store" doors, then she ran out into the parking lot and hid by some cars on the south side by a "big" fence at the last row to the west in the Senior lot. Joey stated that she was hiding next to a tan colored car. Members of a SWAT Team rescued her.

I asked Joey if she had seen anyone else, and she stated that she had. I asked her to describe that suspect for me. Joey stated that he was wearing a blue baseball cap, and that he and blonde hair. The suspect was wearing a white T-shirt with some kind of ammunition vest that was black, and he had regular blue jeans on. I asked her if there was anything else she could remember about him and she stated that his T-shirt was splattered with blood. I asked Joey who she thought that was, and she stated that she thought it was Dylan.

I asked Joey what time she first saw these guys, and she stated that she believed it was 11:20 AM. That was when she first saw "Eric" run by the window of the cafeteria, headed toward the stairs. He put down a black duffel bag with 2 handles, she remembers him having on a trench coat and seeing pipe bombs and shotgun shells hanging on his chest, and he had a small handgun in his hand. Joey went on to say that all this had occurred before the sprinklers went off, and during that time both of them were shooting when they

came down the stairs into the cafeteria. Joey believed that she was about 2 or 3 feet from them while they were shooting. I asked Joey what they were shooting with and she stated that they both had shotguns, but thought they were shooting with something else, Joey stated that she could smell gas and saw the propane tank, that was what they were shooting at.

I asked Joey if ther was anything else she could tell me about the incident and she stated that she remembers that during prom week someone had put super glue in all the door locks of the school and none of the doors would lock, everything was open. I asked Joey if she knew who had done that or if any one had taken responsibility and she stated no.

Joey was unable to provide any further information.



She entered the Commons via the main stairs, at about 1116 hours. She was wearing blue jeans and a bright blue Nike jacket. She sat at Table P with her sister Letisha and another unknown student.



Christopher Shan Markham, DOB 02/06/1984, 7156 South Pierce Court, Littleton, Colorado, telephone (303)904-3538, a freshman at Columbine High School, was interviewed at his home in the presence of his mother, Sherry Markham, by Special Agent(SA) Ricky V. Wright regarding the incident that took place on 04/20/1999 at Columbine High School. After being advised as to the identity of the interviewing agent and the nature of the interview, Markham provided the following information:

Tim Mulcahy Bartholomew "Bear" Foster Nate Vanderau At approximately 11:10 am, Markham got out of French class and left the foreign language department and went directly to the cafeteria. Markham set his bookbag down at a lunchroom table (marked SS on diagram sketch), got his lunch, and sat back down. Markham remembers that Tim Mulcahey, Bear Foster, Nate Vauderau, Jon Fries, Patrick Caruso, Erik Sunde, and Jesse Maddox were also sitting at his table. Markham was sitting facing northeast. Markham thinks that Vauderau was sitting to his right. Markham does not recall who was sitting to his left.

Markham was eating his lunch, when he heard what sounded like shots and an explosion outside the cafeteria to the northwest. Markham stood up and ran to the cafeteria door by the teachers' lounge and opened the door and looked outside. Markham saw Lance Kirklin, Dan Rohrbough, and Sean Graves all lying just outside the cafeteria door. Sean graves was the closest and said that he had been shot. Matt Katzenmeier was also at the door looking out. Mr. Sanders, another teacher, and a janitor helped pull Graves inside the cafeteria. Markham turned and ran down the west side of the cafeteria and began yelling that someone was shooting. Markham huddled down in the northeast corner of the cafeteria for a moment and then started to crawl toward the stairs. By this time, most of the students in the cafeteria were also huddled down. Markham had been carrying a sandwich in his hand and paused to throw it in the trash can at the foot of the stairs. Markham then jumped the rail to the stairs and ran up the stairs to the choir room next to the stairs and pounded on the door. The choir teacher, Mr. Andres, came out and Markham told him what was going on. Markham then tried to knock on a door on the south side of the main hall, but no one came. Markham then ran east down the main hall and then north down the language and history hall toward the school offices. Stephanie



Lohrenz and Katie Beer were also in the hall and ran toward the school offices as well. While they were running, they heard five or six shots coming from the direction of the school offices. Markham did not see anyone, but they turned around and ran back to the south main hall and then east out the exit at the end of the hall. Once outside Markham jumped over a fence and ran across Pierce Street to Leawood Park.

Markham was in the cafeteria for about 20 minutes at the end of first hour. Markham was sitting in the vicinity of the table marked YY on the diagram sketch with Tim Mulcahy, Brenda Kelly, and Kacey Fisher. Markham did not see the gunmen during the shooting. Markham did not remember seeing any large duffle bags sitting in the cafeteria during lunch or first period. Markham knew Eric Harris and Dylan Klebold, because they would come over to Markham's residence with Chris Morris, who was the boyfriend of Markham's sister, Nicole Markham. Markham has known Harris and Klebold since December 1998. Markham estimates that they came over approximately 20 times. Sometimes they would play Nintendo or play Monopoly. Markham would sometimes go to midnight bowling at a bowling alley located at Belleview and Federal with Harris, Klebold, Nicole Markham, Chris Morris, Krista Hanley, Robyn Anderson, and Tiffany Last Name Unknown (LNU) [editor's note: likely Tiffany Typher] . Markham never knew Harris or Klebold to talk about guns or bombs. Markham does not have an Internet screen name.

On the day of the shooting, Markham was wearing a green t-shirt, blue jeans, and brown shoes.





Martin stated that on 4/20/99 her mother drove her to school and that she arrived at the school at approximately 0725 hours. She said that her mother had driven her and her two sisters, Jennifer and Stephanie, to school and dropped them off at the main entrance. She said that she then went to her locker to pick up several notebooks and went to her first hour class in the Science wing upstairs. After her first hour class she went to her locker and then her second hour class which is American Studies, which is upstairs in the language department. After her second hour class she went to her History class, her third hour, which is also located in the same room. She said that between second and third hour she went to her locker. She said from third hour she went to her fourth hour Spanish class which is located in the lower level. She then went to the "A" lunch. She said she's actually scheduled for the "A" and "B" lunch together. She said that she had her pack with her and that she went to table number "Z", as she looked at the cafeteria map. She said there were already students at the table, and identified those students as Stephanie Wise, Carmie Deihl, Nicole Janda, and three other unknown named females. She said that she went to the food service line and purchased a taco salad, went back to the table and began to make the salad, and began to eat which she believed to be about 11:25. Mr. Sanders came running into the cafeteria from near the faculty room, yelling "Get down! Get down!" She said that at first she didn't get under the table and remained seated; then she noticed that people were under the table and that something appeared to be wrong. She said she then heard something that sounded like firecrackers and she began to crawl away from the windows. While interviewing Jean Martin, the parents advised that Jennifer Martin, dob: 1/3/81, is a Senior at school; was in the gym class and was immediately evacuated out of the building to Clement Park, and then to the Library. Their conversations with her indicate that she has no information on the suspects, didn't see anything, only heard the shots. They also have a daughter who is a freshman, Stephanie Martin, dob: 4/6/84. She had been in her science class, teacher Mr. Mosier. She said that they stayed in the science class during the entire incident and she can describe what she heard, the gunshots and the explosions, but did not see anything and was eventually evacuated from the school by a SWAT team. Stephanie Martin did not wish to speak with me about the incident and, at her parents request, was not interviewed. Jennifer Martin was unavailable. They appeared to have no further information as far as additional leads in this case,







at Columbine High School. This interview was in reference to the shooting that occurred on 4-20-99 at Columbine High School

I interviewed Robert Massie in the presence of his grandmother, Pat Massie. Robert Massie told me on 4-20-99, at approximately 1110 hours, he got out of his math class, which is in the math hall on the second level at Columbine High School. Robert said he proceeded to go downstairs by himself and entered the cafeteria at approximately 1115. Robert said that he saw several friends of his that were in the cafeteria at a table so he joined the friends at this table. Robert said these friends were Lance Kirklin, Anthony Sammauro, Sean Graves, Steven Curnow, and Daniel Rohrbough. I showed Robert Massie a diagram of the Columbine High School cafeteria and he told me that the table he was sitting at on 4-20-99 was table "YY". This table is located on the far west side of the cafeteria and just south of the faculty lounge. This table is also due east of the door from the exterior of the Columbine High School cafeteria to the interior by the faculty lounge, [editor's note: Curnow was in the library before the attack started according to Kacey Ruegsegger's book. He was sitting in a chair near her initially, then hid at desk beside hers.] Robert Massie said that after talking for a few minutes at the table Lance Kirklin, Sean Graves, Daniel Rohrbough, and Steve Curnow got up from the table and exited the cafeteria through the far west door near the faculty lounge. Robert said these friends went outside the door and then began to go up the stairs. Robert said that he heard several noises that he believed were fireworks going off, however, he did not know how many of these noises he heard. Robert said that when he looked outside of the cafeteria towards the parking lot he saw smoke near a vehicle that was parked in the lot. Robert said then he heard approximately 10 to 15 more noises that were apparently gunshots. Robert said a student came running into the cafeteria through the far west door by the faculty lounge, and said that there had been shots fired outside. Robert said at this point several teachers entered the cafeteria and told all the students to get up and run out of the cafeteria and upstairs to the second level of Columbine High School. Robert said when he began running, he said it took approximately five minutes to get from his table to the second level of the high school due to the fact all the students were trying to run at the same time and were running into each other and knocking each other down in the cafeteria. He said when he got to the top of the stairs, he went towards the science hall where he saw a teacher waving students into a classroom at that location. Robert said he ran into a science class and it was the science class where Mr. Sanders was. Robert said once inside of this classroom, someone locked the door between the classroom and the hallway and he said all the lights were rurned off. The students sat up against the wall so that if one of the suspects looked through the window in the door, they would be unable to see anyone inside. Robert said the students did take the tables that were in this classroom and lay them on their sides to hide them further while in the classroom. Robert said that there were two classrooms

which had students hiding in this manner, and said there is a door between the classrooms. He also said while he was sitting in the dark against the wall he heard "real loud booms" and believed they were bombs going off. He said it sounded as if these explosions were coming from directly below the science classroom on the first level and said when one of the bombs went off everything in the science room shook. Robert said he believed he heard four to five of these bombs detonated in the school Robert said that while waiting in the classroom, one of the teachers was watching a television set so they could follow the events taking place at Columbine High School through the media. Robert said at approximately 1530 to 1545 hours, all the students he was hiding with in the science classroom were rescued by SWAT, and then taken from the school to Leawood Elementary School, Robert said at Leawood Elementary School he met with his mother, his father, and his step-father at that location

I asked Robert Massie if he knew either one of the suspects prior to this incident. Robert said that he had Eric Harris in his gym class during the first semester of 1999. Robert said that Eric Harris would stay to himself and when he came to and left the gym class he always wore black clothing. Robert said Eric Harris wore a black trench coat in the school and said that he did not believe this trench coat was made out of leather, saying it was probably made from cloth. Robert Massie said he never talked to Eric Harris or associated with him. Robert Massie said Eric Harris worked at Columbine High School in the Rebel News Network (RNN). I asked Robert Massie if he knew what the "thought of the day" was at Columbine High School on 4-20-99. He said that at the time that the "thought of the day" is broadcasted in the morning, he was in his gym class and therefore did not know what the "thought of the day" was on 4-20-99. Robert Massie said that he did not know who Dylan Klebold was prior to this incident, and does not recall seeing him before, other than photographs in the media since the shooting.

I showed Robert Massie a photograph of the duffle bag and the propane tank that was later recovered in the cafeteria of Columbine High School. Robert said that he does not remember seeing either item, either prior to or during incident on 4-20-99

I asked Robert Massie how he has been coping with the incident since the shooting on 4-20-99, and he said he had some problems, however, he feels he is doing fairly well dealing with the incident. I asked his grandmother, Pat Massie, and she said she agreed that he was doing fairly well, however, in the beginning, after the shooting, for about the first one to two weeks, Robert was having some problems dealing with the incident. I gave both Pat Massie and Robert Massie my business card and asked them to contact me if they wanted to talk with a JCSO Victim Advocate in the future. I advised I would make the necessary



He goes by the name of Tim. His mother was present for part of the interview. He told me the following:

Tim attended all his regular classes. During his second hour, he has Student Senate. The Senate met in the cafeteria and he sat

at one of those tables by the student store which are not on the diagram. He was in the cafeteria from around 8:45 to about 8:50. He didn't see anything at that time that didn't seem to belong in the cafeteria. He saw no one wandering around that didn't seem to belong there.

Tim said that 4th hour is his off hour. He went to lunch and had passed through the cafeteria on his way to the mall. His 4th hour is at 10:20. He got back at about 11:10. He walked back in to the cafeteria by the student store. He usually waits for some friends, didn't see them. Those friends are Joseph Marino and Brian Blaskovich. He walked back outside the door by the student store. He saw a car that Joseph or Brian had been driving. That car was parked along Pierce Street in the Junior parking lot on the east side of the school. Tim didn't remember who's car it was or what it looked like. No one was in the car. Tim went back in through the same doors by the student store. He went in and sat at table X. Also sitting there were Tom Clagett, Dan Yager, Zack Thompson, Scott Streeb and Joe Tran.

Tim was sitting there talking to the others. Coach Sanders and a custodian ran in the door by the teacher's lounge. He said they were yelling for everyone to get down. Tim dropped down by his table. He heard one or two gun shots. They sounded like bang. Bang. He said that it didn't sound like an automatic, just the two shots. He said that the shots sounded like they were coming from outside, up on the hill. He said that he heard an explosion. He looked up and saw a big cloud in the parking lot, from out of the windows.

Tim said that all of a sudden, all the kids around stood up and started screaming and running toward the east side of the cafeteria. Tim said that he thinks when he got up, he tried to grab his back pack, and it may have ended up at another table.

Tim ran up the stairs to the top of the steps. One of the teachers came down and at the science hall, told the kids to calm

down. He then heard five gun shots right in a row, five quick shots. The shots sounded like they were coming from down stairs, like echoing from somewhere. He sprinted down the hall, going east. He went through the double doors and outside down the cement stairs. He said that he got out before the fire alarm went off. He went to Tom Clagett's house.

Tim never saw any shooter(s).

Tim said that he saw no duffel bags and no one carrying anything suspicious. He said that Eric Harris was in his gym class last semester, but Tim didn't know him. He knew Dylan Klebold by sight, but didn't see Dylan or Eric at school on Monday or Tuesday.

Tim left his Black Sport Plus back pack in the cafeteria. There was papers in it and a calculator.

Tim said that he saw in the back of a police car the day of the shooting, but had not seen him around the school. Tim said that he had gone to school with since Kindergarten. He knew by sight.

Tim said that on the day of the shooting, he had been wearing brown sandals, khaki cargo shorts and a long sleeved blue shirt.





- * When asked, she fid not know Eric Harris or Dylan Klebold by name or face.



- * She did not know or or by face or name.
- * She has seen trench coat students hanging out at school. She usually saw them in the morning by the library or in front by the trophy case. She does not know any of their names. The only associates of the trench coat students she knows about are Brooks Brown who she said did hang out with some of the trench coat students, and a senior girl in her 6th hour guitar class who she thought knew Dylan and Eric. She did not know this girl's name but said she has brown hair and has a brother who is a freshman.
- * She never heard the name "Trench Coat Mafia" prior to the day of the shooting.
- * When asked, she said she did not see any of the trench coat students or their associates in school the day of the shooting. She did say that when people were getting down in the cafeteria she saw a male dressed all in black outside the cafeteria in the west lot. About 5 minutes later she saw a male all in black walking up toward the stairs outside the cafeteria. She did not know if it was the same person or not. She could not describe the person any further saying she just remembered black. She did not remember seeing if the person was holding anything.


- * When asked, she said she did not see any suspicious objects in school that day. When asked specifically, she said she did not see any duffle bags.
- * On the day of the shooting, her 4th hour class was choir. After getting out at 11:10 a.m. she went down to the cafeteria and put her backpack on a chair at a table there and went into the lunch line that was the farthest east line. Looking at the diagram, she thought the table was LL as she and her friends usually take the three tables in that area. The backpack list also showed her backpack recovered at table LL. She was in the lunch line with a Jennifer Naifeh.
- * After getting lunch, she returned to table LL and remembered the following students there also; Lindsey Dowling, Candice Cushman, Drew (last name unknown-McCuskey) and Ryan (last name unknown-Chilleli).
- * She then noticed that Mr. Sanders was running around the cafeteria in front of the west windows and then down along the food lines and was saying, "get down on the ground." She then heard an explosion and saw smoke out in the lot west of the cafeteria. She then heard reports like firecrackers.
- * She got down but looked up at times. She saw a male dressed all in black in the lot just west of the west windows walking toward the cafeteria. About 5 minutes later she saw a male dressed all in black going up by the stairs outside the cafeteria. She did not know if it was the same male and had no further description.
- * She thought from the sounds and student reactions that the male in black she saw may have had a gun, but she did not see any.
- * She then got her group to take off running. She ran upstairs, turned left down the hallway, and ran straight out the east door to that hallway. As she was running, she did hear what she thought were gunshots. She ran to Leawood Park and then around the neighborhood until she found a phone at a house.

- * She was wearing a black Calvin Klein shirt, jeans, and large platform shoes.
- * She said that the night of the shooting, she got on the Internet on AOL and pulled information off of Eric Harris' web site. She remembered seeing talk of bombs on that site. She gave that information to her father and step-mother. She does not know if they still have it. (Father and step-mother not home for this interview.)
- * She also heard sometime after the shooting students talking about Dylan Klebold telling a janitor on the day before the shooting to watch the news the next day, that a "big thing" was going to happen.

This concluded my interview with Alexis Mazula.

Erica continued to say that her first indication that there was trouble was when Mr. Sanders came running by telling everyone to get under the table, and the people along the windows began to dive under the tables. Erica said that she got under the table and stayed there until the

people near the windows got up and began running up the stairs. She said that at this time she got up and ran into the choir room. She advised that she went through the upper level of the auditorium and into the north main level hall. From there she went through a hall along the east side of the gym and exited the school building on the north side. She continued to say she ran across the open area on the north side of the school to the tennis courts where she and other students put tables against the fence and climbed over. From there she ran to South Pierce Street and Bowels Avenue, and from there she went to Candice Cushman's house.

Erica reported that while she was in the north hall she heard shots coming from behind her (west). Brica advised that she did not see who was shooting. She further advised that she did not see anyone with guns while she was leaving the school or before the shooting started. Erica advised that she noticed while she was in the north hall way that the glass in the windows in the office area was broken.





Drew said that he was in school all day. His 2nd hour is off, and he went to the cafeteria. He saw nothing unusual at that time. His second hour is from 8:25 to 9:20. He said that he was with friends at table JJ:

Drew went back to the cafeteria for lunch at about 11:15. He didn't get his food. He sat at table LL, he thinks. He sat with:

Nick Antonio, 978-0639, 7619 W. Friend Ave., Littleton 80123 Dad is Greg (Tony) Mom is Janet

Candice Cushman, 5855 W. Leawood Drive, Littleton 80123, 794-9376 Parents are Bill and Barb.

Ryan Chilelli, 8121 S. Lamar Street, Littleton 80123 979-7727. This may be his dad's office phone. Dad is Robert. Mom is Jacueline and Erica McClaugherty 972-7485. There may have been a couple of other people there, but he didn't remember who they were.

Drew said that some people had eaten, and they were just sitting there talking. He didn't hear anything. He said that all of a sudden, there was a big hush over the cafeteria and everyone dove under tables. Then, he saw a janitor and Mr. Sanders telling everyone to get down. He got down. He didn't know what was going on. The janitor ran from the east end of the serving line, running south.

Drew said that it seemed like around table AA, people started running toward the stairs and the student store area. Once they got up, everyone got up and ran.

Drew ran to the railing by the stair and dove under one of the railings. On the second tier, he heard gun shots coming from somewhere inside the cafeteria. He heard a boom. He heard several quick bangs. He has done target shooting with a .22 and a shotgun. He said that the shots sounded like they had more power than a .22 rifle. He heard two shots. He heard one of the shots while on the tier and the next one while he was on the third tier. He said that both of the shots sounded like they were coming from the same area. He didn't hear anything else from the cafeteria.

Drew said he saw no smoke in the dafateria. He did not see anyone shooting. He said that once up the stairs, he ran down the opposite way of the library and out the front door past the choir room.

Drew said that while he was running, he saw shoes and pagers on the ground. He saw a couple of people tripping and falling. Everybody was screaming. He didn't know for sure, but he thought he heard a gunshot or an explosion while he was running. He didn't remember any odors and saw no smoke. When he was running, he didn't see anyone with a gun or shooting, and he saw no explosives.

Drew saw someone in a red car asking what was going on. Someone else said that there had been a shooting inside the school. He thinks that one guy in the car might have been Tyler Jackman. This car was red, a Mustang, older, maybe 1980's. He remembers seeing Tyler later at the park and saw the car. He didn't remember what Tyler was wearing. He didn't remember if he saw Tyler at school that day.

Drew said that he knew Eric Harris from classes. He said that he'd seen Dylan at school, but saw neither Dylan or Eric the day of the shooting. He said that Dylan always wore a black Boston Red socks hat, backward.

Drew said that there was another guy that wore a trench coat. He didn't know this guy's name, but described him at wearing a dark colored beret, dark glasses, having a pale face, thinks he has blonde hair and a smooth face with no acne. This guy would sometimes wear a German shirt. (a black tee shirt with German writing on it.) Drew didn't remember seeing this guy at school the day of the shooting.

Drew had left his red and black Jansport backpack in the cafeteria. He'd been wearing jeans, and a navy blue Old Navy shirt. Inside his back pack were flimsy binders with labels that say what it is and some math books.



Julie did advise that last year someone in an english had written a paper on groups in school, and the Trench Coat Mafia were included.

Julie reported that there had been no rumors about impending trouble at the school prior to the twentieth. The only thing that she could think of that seemed unusual was about a week before the shootings someone had damaged the locks on the doors to the school.

Julie described her pack as a blue and black Jan Sport with a cross sewn on the strap. The pack contained a math book, government book, note book, picture of one of a friend, and a small AM-FM radio.





On May 4, 1999 I was assigned to do an interview with Columbine High School student Jonathan McMaster who was possibly in the cafeteria at the time of the shooting. I contacted Jonathan's father, Tim McMaster, and made an appointment for an interview on May 12th at 1830.

On May 12th at 1830 I arrived at 7273 South Chase Way and began the interview with Jonathan McMaster. Jonathan stated that he is a freshman at Columbine High School. He continued to say that he was in school on April 20, 1999 and was in the cafeteria when the shooting started.

Jonathan advised that he arrived in the cafeteria at about 11:15AM. Jonathan said that he was seated at either table identified as "UU" or "VV" but he thought he was more likely at table "UU". Jonathan said that he was sitting with Tyler Anderson. Jonathan related that he normally does not sit at this table but because the other people who he usually eats lunch with him did not show up. Jonathan advised that he had been there about ten minutes when he looked out the window and observed Dan Rohrbough and Lance Kirklin laying on the ground. Jonathan said that he thought they were messing around and went back to eating his lunch. At this time a couple of other kids looked out the window and commented on the blood. It was believed that a fight had occurred and someone commented that it appeared one of the victims had a "compound fracture". At this time Mr. Sanders came in the west door of the cafeteria and told everyone to take cover. Jonathan stated that he did not hear any shots at first but after the people in the cafeteria got under the tables and it quieted down, he heard possibly three or four shots that appeared to come from outside the

window. Jonathan stated that he did not see who was doing the shooting.

Jonathan said that he and Tyler remained under the table, laying on the floor between 30 to 40 minutes. Jonathan said that they remained in the cafeteria because after there was a large exodus of students up the east stairs there was alot of shooting that sounded like it was coming from the top of the stairs, and Jonathan believed that the students were being shot as they reached the top of the stairs, so they thought it would be safer to remain in the cafeteria. Jonathan related that while he was laying on the floor behind and under the table he noticed legs moving around the cafeteria. Jonathan said that he could not see who was attached to the legs, shooters or students, as the table he was hidding behind blocked his view and he did not want to move around.

Jonathan related while he was behind the table he felt a big ouff and a heat wave moved over him. He continued to say that there was a large amount of flames east of him in the cafeteria. According to Jonathan immediately before, 30 seconds, he felt the puff and heat he heard what he discribed as the sound of running water or a hissing sound. Jonathan said that he did not notice any shooting just before he heard the hissing sound, but he related that there was alot of shooting going on at the time. Jonathan said that he did not see anyone on the stairs just before the hissing sound as he could not see around or over the table. Jonathan also reported that while he was hidding under the table he heard several explosions that seemed to be coming from the floor above him.

Jonathan advised that after about forty minutes they crawled into the hall way leading to the west exit from the cafeteria. They waited near the wall at the west door for a period of time and them observed a police officer in the field to the west of the school. They got his attention, and he directed them to run to the parking lot to the west of the cafeteria. When they got into the parking lot they took cover behind a car and waited there for about another forty to forty-five minutes. He then gained the attention of another officer in a car, and this officer transported them to a cul-de-sac to the west of the school. From there he went to a friends house and called his father.

Jonathan advised that while he was in the cafeteria he did not notice any large duffel type bags that he could recall. He continued to say he does not recall anyone carrying such a bag into the cafeteria while he was there.

Jonathan advised that he was in a math class located on the main level in the south-east corner of the building. Jonathan advised that after class he walked down the hall to the south that leads to the south main hall. He then stopped at his locker (437), and then walked down the south main hall to the stairs leading to the cafeteria. Jonathan advised that from his math class to the cafeteria he encountered no one with a gun and did not see anything that appeared out of the ordinary.

Jonathan advised that he does not know either Eric Harris or Dylan Klebold, nor has he had any contact with either subject. He continued to say that he does not know anyone who belongs to the Trench Coat Mafia, and none of his friends belong to the group. Jonathan does not know what names if any Harris or Klebold were using on the internet.





On 4-26-99, Inv. Reker did conduct an interview with Mears at his residence, in this interview, Mears stated that he was sitting at either table QQ or RR and that he was facing west toward the large windows.

Mears did not see anything but that a janitor yelled to get under the tables, he then heard shots from outside the west door of the lunchroom which is by the teachers lounge.

Mears than ran into he kitchen area and went into a closet next to the kitchen bathroom and was and during the time he was in the closet,he heard someone yell drop it.

After an unspecified amount of time, Mears states that he and the other persons in the closet were then rescued by the SWAT team.



James Alden Medaugh, date of birth 1/27/84, was interviewed at his residence 6674 W. Roxbury Place, Littleton, Colorado 80128, telephone number (303)973-9182, regarding the shooting at Columbine High School (CHS). After being advised of the identity of the interviewing Agent and the nature of the interview, Medaugh provided the following information:

Medaugh is a freshman at CHS. Medaugh has government class during 4th hour and has "A" lunch. During "B" lunch, Medaugh is in German language class. At approximately 11:10 a.m. on the day of the shooting, Medaugh got out of his 4th period class and went to lunch. Medaugh went to the lunch room after first stopping at his friend's, Nick Buhrer (phonetic), locker. Medaugh arrived at the lunch room at approximately 11:14 a.m.-11:15 a.m. and sat at a table near some vending machines (Medaugh identified table YY as the table he thinks he was sitting at from a sketch of the school and lunch room). Medaugh and Buhrer walked to the vending machines to make a purchase at approximately 11:21 a.m.-11:22 a.m. At approximately that same time or one minute later, while standing at the vending machines, Medaugh heard what he thought was three shots or firecrackers outside the lunch room coming from an upstairs area near some transformers.

Approximately 5 to 7 seconds later, Medaugh heard three more shots. At this time, Medaugh looked out a window of the lunchroom, near the vending machines, and saw his friends Sean Graves, Lance Kirklin and Dan Rohrbough. Medaugh saw Graves go down outside the window. He also saw Kirklin crawling on the ground. Medaugh started walking back to his table and arrived there about 15 seconds later. Medaugh told others at the table that he thought Sean had just been shot. At the table were Fletcher Woolsey and Anthony Caruso. (Corey Hager and Billy Arapkiles may have also been at the table that day but Medaugh could not be sure). [editor's note: Corey Hager was off campus during the attack, Billy Arapkiles was outside]. Buhrer and Medaugh parted at the vending machines and Buhrer went outside.

Medaugh stayed at his table for about half a minute before a teacher and a janitor came into the cafeteria and told everyone to get down. Medaugh got down on the floor for about one minute before he and many other students in the cafeteria got


up and started moving towards the stairs. As soon as Medaugh got to the base of the stairs, he heard one gunshot coming from upstairs.

Medaugh then decided to run down the hall to a Spanish language room. Medaugh ran to a Spanish room which was located next to school exit doors which led out to the junior parking lot. Medaugh stayed in this Spanish room with 20 to 30 other students, one teacher (whom he did not know) and one substitute teacher (whom he did not know) for about five minutes. During this time, Medaugh heard approximately three gunshots and one explosion. Medaugh and the others in the Spanish room left the room after about five minutes and fled across the Junior parking lot. Medaugh then ran to a Mormon seminary house on Polk Street where he stayed for the next two hours.


Medaugh has not been interviewed prior to today. Medaugh did not see any shooters in the school at any time. Medaugh did not hear explosions or footsteps on the roof of the school on the day of the shooting. Medaugh kept his backpack with him when he fled the cafeteria and took it out of the school with him when he fled to the Mormon seminary house.

Medaugh has heard of the Trenchcoat Mafia (TCM). He described them as weirdos who always hung out outside, near the stairs by the cafeteria and the senior parking lot. Medaugh only knows one member of the TCM. Robert Perry was in the same debate class with Medaugh for approximately one week. Perry kept to himself during the time he was in the class.

Medaugh stated that the thought for the day on the Rebel News Network (RNN) was words to the effect of, "You shouldn't be here today". Medaugh saw the thought for the day on a T.V. monitor in his second hour class.

On 4/29/99 I interviewed 16 year old CHS student Christine Medina at her home in Littleton, Co. Christine's mother was present for this interview.

Christine advised me she was in the cafeteria at CHS when the shooting began around 11:30am. She stated she had been in the cafeteria since around 10:20am because she has 4th hour free. She stated that her and a few friends usually meet in the cafeteria around 10:20am to do home work and talk. They have 4th hour free, then they eat lunch together at the 11:20am "A" lunch.

She stated on 4/20/99 she came to the cafeteria around 10: 20am and meet up with CHS students Jennifer Tindall, Elisha Encinias, Lyndsie Deyle and Michelle Cowles. They sat in their usual area, which she described as below the stairs near "rebel corner". I provided Christine a drawing of the cafeteria, which depicted all the tables and their location in the cafeteria. I pointed out specific areas, such as food line, kitchen and west windows of the cafeteria to give Christine a better understanding of the lay-out in this drawing. Christine looked at the drawing and pointed to table "U" as the table her and her friends were seated at. She recalled she sat facing the stairs, towards the southeast. Christine cirlce table U on the drawing, and initialed where she was seated.

I asked Christine if there were any other students in the Cafeteria

from 10:20am until "A" lunch arrived at 11:15am. She recalled there

was one other group of boys at table JJ behind her group. She said it is a regular group that meets in the cafeteria for their open 4th hour. She recalled the boys at table JJ were Chad Roybal. Evan Todd, Eric Trujillo and Mike Leary.

I asked Christine if she recalled seeing any large duffle bags in the cafeteria that were left there before the crowd arrived, or recalled seeing anyone bringing down a large duffle bag and leaving. She stated she did not, but was not looking for anything like this. She recalled that her back was towards the cafeteria, and was facing towards the stairs. She did not recall seeing anyone carrying a duffle bag or anyone wearing a trench coat coming into the cafeteria from the inside stairs from 10:20am until the A lunch began. Christine added that see was not really paying attention to who was coming and going from the area.

She stated around 11:05am the kitchen opened up and she and Jennifer Tindall walked over to get a lunch. They took a direct route to She and Jennifer came back to table U and ate their When she finished lunch. The others girls were also eating. her meal Christine walked her trash over to a trash can near the south doors. She stated that when she returned to the table, Cara Sanders asked Jennifer to accompany her to her car in the south parking lot. Jennifer and Cara left the cafeteria through the south doors. A few minutes later 2 unknown girls came in to the cafeteria from the south doors and appeared upset. They appeared to be looking for a teacher. Someone yelled that someone had been Everybody in the cafeteria stood up and looked out the west windows. Christine did not see anything, then she heard pooping noises and a loud boom. Mr Sanders then came down and told everyone to get on the floor. Everyone did.

The crowd waited for a few moments, then began to run towards her as they were heading for the steps. Christine got split up from her table, but ran with another friend, Alexis Wolfe. They ran up the stairs into the hallway and down into the auditorium doors. They cut through the auditorium and into the main hallway west of the

administration area. They were running towards the administration exit doors with about 5 other students when the glass in the exit doors was shot out ahead of them. She believed the shots came from behind them. She and Alexis stopped and turned to the right into a short hallway while the other students continued out the exit doors. They stayed in this short hallway for less than a minute before making a run for the exit doors that had been shot out.

They got outside and were advised by a teacher to stay in Clement Park. Christine did not see the gunman at any time, but was sure she heard shots upstairs near the auditorium when they reached the main hallway.

Christine was wearing Jeans, red tanktop with white short sleeve cover shirt. She left a Gap backpack, black purse and jewelry on the table in the cafeteria.


Christine had no information about TCM or Dylan Klebold and Eric Harris.

She stated that while in Clement park when everyone was "freaking out", she overheard a short (5'2") chubby girl tell another girl that her friend got a call from someone telling her not to go to school today. Christine could give no more description on this person, and did not know who this person was talking about. She was unsure if she would recognize this girl again.

David Michael MESCH, DOB 7/24/83 was interviewed at his residence, 6970 S. Lee Way, Littleton, Colorado on May 11, 1999 at approximately 8:30 AM. MESCH was advised of the personal and professional identity of the writer and the purpose for the interview. David's parents Darlene and Michael MESCH were present during the interview.

MESCH advised that he is a sophomore at Columbine High School, and has "A" lunch period. On April 20, 1999, MESCH recalled entering the cafeteria at approximately 11:10 AM. He waited in line to buy his lunch for approximately 1½ minutes, and then took a seat at a table in the cafeteria. MESCH viewed a diagram of the cafeteria, and indicated that he believed the table that he sat at was "MM". He sat facing toward the west and the windows on that side of the cafeteria. MESCH stated that there were approximately ten other students seated at the table, but he could only recall one, Zach RAUZI.

MESCH stated that he finished eating his lunch and got back into the service line to buy a cookie. While waiting in the line MESCH saw a student running by, and heard what sounded like fireworks exploding. MESCH ducked down in the line briefly, then ran into the kitchen area. He spent approximately 30 seconds in the kitchen, then ran out and eastbound through the cafeteria. He entered the auditorium through the back doors, ran through the auditorium and down the main hall. MESCH stated that Sarah BROWN and Renee PAAUILAINEN ran with him. He then turned north into the hall by the counseling offices and out the north side of the building. He ran through the smoking pit, jumped the fence and ran north into Clement Park, to a parking lot usually used by sophomores. MESCH then got into Zach RAUZI's car with him, and they drove to MESCH's house. editor's note: Renee Paavilainen

MESCH stated that he never saw the gunmen, or any duffel bags or other unusual objects in the cafeteria. He stated that he had been wearing a green short sleeve "T" shirt and khaki-colored shorts.

MESCH advised that he did not know Eric HARRIS or Dylan KLEBOLD, or any other members of the Trench Coat Mafia. He stated that he had seen the group around, occasionally wearing





on the floor. Kids started taking care of them. We were there for about 3 hours and finally got out.

Summary of Statement:

I'm a freshman at Columbine. I had gone to the mall during 4 Period. I arrived back at school for lunch at 5th period. I left w/ Beth Klepper and I came back with Pat Ireland. We arrived back at 11:05- 11:10 am and I went to the tables in the middle of the lunch room. (Poss tables X, GG or PP). I was sitting with Chris Carlstedt (972-3997), Jon Stocking, & Ryan Hasten. I heard Mr. Sanders yelling "Get down". We got down under the table and I pulled my backpack down. Mr. Sanders yelled "Run!" I ran upstairs. I started to hear what sounded like shots. I ran up toward the Science area. I ran into Mr. Friesen (Science) class. He told me to get in his class and I told him shots were fired. I got in to the room and about a minute later Mr. Sanders was brought in. I stayed in that room for about 3 ½ hours. The SWAT unit came and got us out. I was wearing a white Nike shirt & cream colored shorts. [editor's note- Dave Sanders was brought into Doug Johnson's room, not Friesen's).
