Ryan Benjamin HASTEN, date of birth: 03/20/84, was interviewed at his residence, 7842 S. Lamar Street, Littleton, Colorado on April 27, 1999. He was advised of the personal and professional identity of the writer and the purpose of the interview. HASTEN's mother, Terry HASTEN, was present for the interview.

HASTEN advised that he is a freshman at Columbine High School, and did in fact leave his blue Nike backpack in the cafeteria at the high school on April 20, 1999, following the incident there. HASTEN stated that he is on "A" lunch schedule, and had entered the cafeteria at approximately 11:25 AM. HASTEN bought lunch in the cafeteria, and took a seat in the main cafeteria area. HASTEN was shown a map of the cafeteria by the writer, and advised that he believed he had been sitting at table QQ on that map.

HASTEN stated that he was sitting with Kyle MICHELSON, Chris CARLSTEDT and Jon STOCKING, fellow freshman. HASTEN pointed out what he recalled to be their seating location on that date.

HASTEN stated that he had just sat down to eat when he heard a noise outside, which he described as a bang which sounded similar to a firecracker going off. HASTEN saw teacher Dave SANDERS exit out the west door by the faculty lounge to the area outside the cafeteria. HASTEN stated that as he was going out, he heard SANDERS telling everyone to get under their tables.

Within ten to fifteen seconds Mr. SANDERS came back into the cafeteria through the same door, and was yelling for everyone to run. HASTEN did not think that Mr. SANDERS appeared to be injured at that time.

HASTEN stated that he ran up the stairs on the east side of the cafeteria and into the hallway above. An unknown teacher was telling people to go into the auditorium, and HASTEN went inside. Not feeling comfortable there, HASTEN continued to run through the cafeteria, down the main hallway past the administrative offices and out into the faculty parking lot on the south side of the school. He then began running north toward

Clement Park. He saw a marked police unit driving south through the park toward the high school, and as he approached it the deputy driving it told him to keep running.


HASTEN advised that as he ran out the main entry doors, he saw that several of the doors and windows were broken out. He also stated that he heard several bangs while running through the building, which were not too loud. He did not know if the bangs were coming from within or outside of the building.

HASTEN stated that he did not see the suspects at any time during the incident. He also did not see any duffel bags or other suspicious objects while in the cafeteria.

HASTEN stated that he did not know Eric HARRIS or Dylan KLEBOLD. He saw their pictures in the newspaper, and did not think he had ever met either of them. HASTEN stated that he had seen some individuals in the past wearing dark trench coats on campus, and had heard that they were known as the Trench Coat Mafia. HASTEN did not know anything else about the group, and was not acquainted with anyone who belonged to it.

HASTEN stated that he had been wearing a white and green plaid button-up shirt and green shorts on that date.

The person was wearing a black trench coat, had red hair, black baseball cap, jeans, tall. He was shooting a sawed off shotgun and a semi-automatic. Shot a male student in the knee and then proceeded by shooting the shotgun at another student who was laying on the ground at close range. He started shooting outside by the lower parking lot. He then proceeded to come inside. At that time I was told to get down and move. I went into the kitchen and was locked into a laundry room with other students and teachers. The suspect started shooting into the kitchen with the shotgun. One of the students that was shot proceeded to crawl toward the baseball field in an attempt to escape. [editor's note- this was likely Michael Johnson]. I only saw on shooter. The male that was shot in the knee was wearing jeans, was in my first hour class during first semester. Their was a shotgun blast up stairs sounding like it came from the glass window area to the west. I stayed with a custodian and other faculty members until such time as the SWAT team

Entered and told us to get out. I didn't see anything else but continued to hear multiple shots and explosions. I was there for about two hours.

On April 29, 1999 at 1300 hours I met with Joel Hatfield and his father, John Hatfield, at Drive in Littleton, Colorado for the purpose of an interview

Joel Hatfield provided the following information about the Columbine High School incident, which occurred on April 20, 1999:

- Joel was in English class until 11 10 a.m. when the bell rang. He stated that he got out of class and went to his locker across from the Math Department. He stated that he was with "PJ" [editor's note: Peter Capra] for a short time and then "PJ" went to his own locker while Joel went to the cafeteria via the interior stairs. Joel stated that there was nothing unusual at that time.
- Joel stated that he was at the top of the stairs when the second beil (11:15) rang. He stated that he walked along the south side of the cafeteria and then sat at a table along the west windows. He identified where he sat as table "M", "BB" or "CC" as noted in the FBI Evidence Diagram. He stared that he sat down and faced to the east (stairs) with his back to the windows.
- Joel was wearing blue jeans, a dark checkered flannel shirt and a "Amber Crombie" hat (normal direction). Joel did have his eyeglasses on at this time. He stated that he had a purple backpack with the following in it: \$50.00 cash. Math book, Earth Science book, clack binder, red folder, Louis Lamar book and a GMC manual. He left his backpack on the floor.
- . Joel stated that PJ returned to the table and that Jon Owens and Brian Hale were also sitting at the table.
- Joel stated that he was sitting at the table for about 15 minutes and then be heard a single "pop". He stated that it sounded like it was a paint ball gun. Joel stated that moments later he got up to throw something in the trash and as he did so, he looked out the west windows. Joel gave the following account while looking out the window
  - 1 Observed a single gunman described as a white male, about 6 feet tall, with a medium build. An oval face, no glasses, no facial hair and red, ear length hair. He was wearing a black baseball hat backwards.
  - 2. The gunman was standing north of the chain link fence and east of the sidewalk. The gunman was facing Joel.
  - 3. The gunman did not have anything over his face and was wearing dark blue jeans with no holes or patches. Joel stated that he has a white shirt (believed to be a T-shirt) and a light colored vest with pockets. Joel stated that the vest was "weighted down, because it was not flapping like the front of his coat"
  - 4. Joel stated that the gunman had a black trench coat on that went to about the middle of his lower legs. He stated that it was open and "flapping in the wind". He stated that there were no logos or identifiers on the trench coat.
  - 5 Joel stated that the gunman did not have any gloves on and that he could not see his feet.
  - 6. The gunman had a gray, semi-automatic handgun in his right hand. He stated that the gun was "T-shaped" and there was about 5 inches in front of and behind the pistol grip. The gun had a long clip in it.
  - 7. Joel stated that the gunman fired a single shot at Mike Johnson, who was on the hill west of the sidewalk. He stated that this shot was fired at Mike Johnson's knee.

- Joel stated that the gunman turned (unknown direction) and fired "a bunch of shots (rapid fire) while rusning"
- 9 Joel stated that the gunman then fired a single shot at a guy that was standing near the chain link fence (north side) in the upper body. The shooting victim fell to the ground on the east side of the walkway
- 10. Joel stated that he did not have anything in his left hand at this time. He stated that the gunman then "changed clips", but does not know what he did with the clip that he took out.
- 11 Joel stated that the gunman then walked up the hill (north) and picked up a shotgun that was lying on the ground. He does not remember if it was on the sidewalk or not.
- 12. Joel described the shotgun as a "short, side by side, double barrel shot gun". Joel stated that he picked this shotgun up and held it in his left hand.
- 13. Joel stated that the gunman came back down the hill towards the shooting victim near the fence (the chest wound on the ground) and "pointed the shot gun at him and fired two times".
- Joel stated that a janitor then came in to the cafeseria and yelled at everybody to get down at which point he did. Joel stated that his right arm was against the wall and he was facing to the south. He stated that he was "crouched down" and did not see the gunman come into the cafeteria. He stated that he never saw a second or a third gunman.
- Joel stated that he was on the floor for about one minute and does not remember seeing any big duffel bags at that time. Joel stated that he than got up and ran south to the wall and then east along the south wall towards the stairs. He stated that he got to about the commons area and bear "two (2) shot gun blasts from above". He stated that one of the "blasts came down the stairs and the other went down the hall, because he heard it rattle along the lockers" Joel stated that he did not hear any shots from behind at that time.
- Joel stated that everybody started to run back down the stairs at that time. He stated that he ran towards the kitchen and then into the "laundry room" in the rear of the kitchen. (see attached diagrams)
- He stated that the laundry room locks when you close it and can only be opened with a key or from the inside. He stated that there were about 18 or 20 people in the room with him. He stated that the following were in the room with him:

Kristin Garramone (sic)

Austin Mears (sic)

4 lunch ladies (unknown whom)

3 teachers (unknown whom)

1 custodian (unknown who) [editor's note: Tony Arnold]

9 - 11 unknown students


Joel stated that the janitor had a radio and that he communicated to somebody on the outside and they told us to say in there. Joel stated that he heard what he thought was a "fire extinguisher going off a couple of minutes after they got into the room. He stated that they continued to hear gun shots from above.



- Joel stated that "somebody knocked on the door and wanted to come in" He stated that this person "slipped his ID under the door which read Jeremy", but that they "did not open the door for him" He stated that Paul Andrews still has the ID to date.
- Joei stated that the SWAT team eventually got to them and they went from the laundry room, to the teachers lounge, out the window and up the hill to a fire department vehicle. He stated that they did so about three at a time and that they had to hug the wall as they went.
- Joel stated that he did not know the gunman, but could recognize the one shooter in a photo line up if he had too. He stated that he never heard of Dylan Klebold or Eric Harris prior to the event and only saw them on the television or the newspaper.
- Joel stated that be had never heard of the Trench Coat Mafia (TCM) prior to the event. He stated that he has seen trench coats only a couple of times at school. He stated that he has no knowledge of anybody with a "double pierced eye brow".
- Joel stated that he does use the family computer, but does not know what an "ICQ" is. He stated that their family e-mail address is www.hot36chevy.aol. He stated that he doesn't do "anything kooky on the internet". Mr. Hatfield confirmed what Joel had said and asked if wanted to see anything on the computer. He stated that Joel generally uses the e-mail for the Boy Scout projects that he is involved with.
- Joel stated that he did not see or hear the RNN message of the day on April 20th. He stated that he did not hear anything about "guns or bombs" prior to the events on the 20th of April.

I gave Joel Harfield and his father my business card should they need to have a contact regarding this incident. Included with this report is the diagram that Joel drew his location, entrance into and exit out of the cafeteria.

Haulman stated that his lunch period started at approximately 1110 hours and that he went directly to the lunch room, arriving at approximately 1115 hours. When shown a diagram of the cafeteria (attached), Haulman stated that he was seated at table KK.


Haulman said that at approximately 1125 hours, he heard a "bunch" of gunshots. Haulman stated that he immediately got up from table KK and ran through the science and math area hallway and exited out the front doors of the school by the main hallway leading to the east doors.

Haulman stated that once outside on Pierce Street he stopped a vehicle that was driving by and obtained a ride from an unknown citizen.

Haulman stated that he left his blue Jansport backpack in the area of table KK, further describing his backpack as dirty and containing school books. Haulman also stated that his school locker was number 80.

The janitor ran along the windows to make sure everybody was getting down.

Samantha was hiding behind the cart and heard what sounded like fire crackers at a distance. Everybody had started to run. Samantha and her friends ran into the auditorium that had a guitar class in session. The students on stage dropped their guitars and started to run. Samantha and her friends ran up the stairs and hid in a sound booth. They heard 5- 6 gun shots that sounded very close. They thought the gunman had come

Samantha began running across the top of the auditorium and went out the NE door. Samantha reports that she stopped in the hall and observed that the east main entrance glass door was shattered. Sara Martin and brother and sister Jon and Dianna Cohen were standing up against the pillar next to the front door. The group ran into the Counselor's hallway and were instructed by the counselors to not panic and to walk out the N doors to go outside.

Samantha was walking towards the designated smoking pit and heard approx. 5-6 more gun shots while climbing the fence.

Emily Stepp told Samantha later that night that one of the gunmen had fired at her as she was running out of the E main entrance. She realized then that the shots had come from behind her.





On 04/26/99, Det Boatright (IO) was assigned a lead sheet identified by Control #1216, requesting he conduct an interview with Kyle Hayes. The lead sheet information indicated Kyle Hayes was located in the chemistry lab when the incident started and observed one of the suspects fire into that room through the glass window of the door.

On the same date at approximately 1630 hours, IO responded to 8233 S. Quail Way, Littleton, CO, for the purpose of contacting Kyle E. Hayes, DOB: 07/26/84 (phone: 303-979-0856). IO had previously made arrangements to interview Kyle Hayes through his mother, however, she did not remain for the interview. IO would note, just prior to the conclusion of the interview, Kyle Hayes' father, identified as Don Hayes, arrived home and sat through the remainder of the interview.

Upon speaking with Kyle Hayes, IO confirmed he is a freshman at Columbine High School and was present at school on 04/20/99. IO subsequently had Kyle Hayes review his activities on 04/20/99, beginning when he arrived at school Kyle Hayes explained he does not have a first period and usually arrives at school sometime between 0815 and 0820 hours Kyle Hayes confirmed he did arrive at Columbine High School around the time frame provided above on the date in question. Kyle Hayes further verified he was provided transportation to school via his mother and recalled entering the school through the "commons area." Kyle Hayes confirmed the entrance he used was located on the south side of the school, near the cafeteria. Through additional questioning, Kyle Hayes stated he did not observe any unusual activity when arriving at school.

Kyle Hayes next explained, upon arriving at school, he then went to his second period class which began at approximately 0830 hours and lasted until approximately 0920 hours. Kyle Hayes identified that class as "weights" Kyle Hayes stated his instructor for that class was "Mr. Place "When asked where that class was located in the school, Kyle Hayes stated the weight room was located near the "gym" on the north side of the school building.

Kyle Hayes next stated he went to third period class, which began at approximately 0925 hours, which lasted until approximately 1015 hours Kyle Hayes identified that class as language arts and is taught by Miss Bohack. Kyle Hayes explained his third period class was located in the "math hall" and believed the room was identified as "MA7."

Kyle Hayes next reported he attended his fourth hour class which began at approximately 1020 hours and lasted until

approximately 1110 hours Kyle Hayes identified that class as "Spanish," which is taught by Ms. Killion. Kyle Hayes stated that aforementioned class was located in the "downstairs" portion of the school, near the "commons." For purposes of clarification, when Kyle Hayes refers to the "commons or commons area," he is referring to the cafeteria area. As that discussion continued, Kyle Hayes clarified his Spanish class is only approximately 40 feet east of the commons area.

Kyle Hayes reported after the fourth hour bell rang, he left his Spanish class and walked to the commons area with a friend, whom he identified as Austin Steckler (phone: 303-933-1502). Upon arriving in the lunch room. Kyle Hayes stated he along with [editor note: Joseph Austin Steckler, got in line and purchased their lunch, after which both he and Austin Steckler sat down at a table with above). Kyle Hayes reiterated he was only approximately 40 feet from the commons area when he left his fourth hour class and recalled the lunch line was very "short." Kyle Hayes stated he did not believe it took either he or Austin Steckler more than five minutes to walk to the lunchroom, purchase a lunch, and then find a table IO subsequently supplied Kyle Hayes with a diagram of the commons area and asked him to approximate where he sat in the lunchroom. Refer to the aforementioned diagram for details, however, IO would note Kyle Hayes placed himself at a location which appears to be close to the center of the lunchroom area

Once Kyle Hayes had identified his location in the lunchroom, IO confirmed when he arrived at that location, he was in possession of a "east pack" backpack, which he described as blue and black in color. Kyle Hayes went on to state the backpack has a "net" in the front with a "red and yellow drawstring." Kyle Hayes added his backpack has a rubber non-slip shoulder strap. According to Kyle Hayes, contained in his backpack was his student I.D. along with various school books and papers.

When asked to identify other individuals located at the table, Kyle Hayes stated, in addition to himself and Austin Steckler, he recalled the following list of students sitting at the same table. The students were identified as Tim Miller, Jeff Morroni, Devin Casteel, Chris Donnelly, Jonny Stroble, Pat Vassar, Alex Schlosser, and Jacob Hemelstrand IO would note all of the spellings for the above named individuals were provided by Kyle Hayes [editor's note-and corrected by editor] In addition, Kyle Hayes identified all the forenamed students as freshmen. When asked if he could identify any other students located at nearby tables, Kyle Hayes responded in the negative.

IO next asked Kyle Hayes if he was familiar with a party identified as Jordan Grimm. IO would note Jordan Grimm was identified as a party possibly located at the same table with Kyle Hayes per this information provided in the lead sheet. According to Kyle Hayes, he was familiar with Jordan Grimm, but was

relatively certain the forenamed was not located at his table. When asked why he may be associated with that individual (pursuant to the recovery of backpacks), Kyle Hayes stated he did recall having a math paper of Jordan Grimm's in his backpack. Kyle Hayes was unable to provide any additional explanation concerning that point.

When asked if he could recall any unusual activity occurring in the cafeteria during the time he arrived and found a place to sit, Kyle Hayes responded in the negative. When asked if he had observed any individuals carrying unusual backpacks or duffle bags into the cafeteria during that time frame, Kyle Hayes again responded in the negative. Kyle Hayes related it would not be unusual to see students with either a backpack or duffle bag in the commons area. Kyle Hayes pointed out he was relatively certain most students at least carried a backpack when attending school IO again stressed with Kyle Hayes, the possibility of seeing any individuals carrying what could be considered an unusual duffle bag into the cafeteria area. Kyle Hayes continued to respond in the negative.

When asked if he observed any unusual activity in the cafeteria that date, Kyle Hayes responded in the affirmative. Kyle Hayes stated approximately "five minutes" after sitting down at his table, he observed a teacher, whom he identified as "Mr. Sanders," enter the commons area and begin "yelling." When asked to describe the teacher, Kyle Hayes stated the forenamed was "older" and was wearing a lighter colored shirt and jeans. Kyle Hayes stated he was also certain the teacher was wearing "glasses." As the interview continued, Kyle Hayes stated he was certain as to his identification of the teacher (referring to Mr. Sanders) as he had seen the forenamed pictured on television during a news report.

Kyle Hayes was next asked to describe the specific activity as it related to Mr. Sanders. Kyle Hayes stated he observed Mr. Sanders enter the cafeteria from the "west door" near the faculty lounge. Kyle Hayes stated Mr. Sanders was "running" at the time and began yelling for students to "get down, he's got a gun." Kyle Hayes stated Mr. Sanders repeated those commands several times as he proceeded in an easterly direction through the cafeteria. IO subsequently had Kyle Hayes identify the location where he first observed Mr. Sanders. Kyle Hayes subsequently affixed an "X" and wrote Mr. Sanders on the diagram where he had previously identified his location in the cafeteria. IO would note the location where he originally observed Mr. Sanders as close to the faculty lounge area, in addition to a western entrance to the commons area.

Kyle Hayes next reported to IO he forgot one point prior to seeing Mr. Sanders When asked to elaborate, Kyle Hayes stated just prior to seeing Mr. Sanders, he saw a group of people moving to the west windows of the commons area. Kyle Hayes stated he thought people were going to that location because there was a

"fight outside " Kyle Hayes stated at the time he had no other explanation for why groups of people were going over to the west windows of the commons area.

IO clarified with Kyle Hayes the first unusual event he observed in the cafeteria was when people began moving towards the west window and it was moments later, he observed Mr. Sanders in the cafeteria. IO subsequently asked Kyle Hayes to explain what occurred after Mr. Sanders began warning students. Kyle Hayes stated he recalled everyone, "drops to the ground." Kyle Hayes reported he next looked out towards the west windows of the cafeteria and observed a "brownish black smoke" coming from a vehicle parked in the south senior parking area. When asked to be more specific concerning the location where he saw the smoke, Kyle Hayes stated he believed the smoke was coming from one of the "first couple of cars" parked facing north in the south senior parking lot.

Kyle Hayes stated about the same time he made that observation, he observed one of the suspects enter the cafeteria near the same location where he originally had seen Mr. Sanders Kyle Hayes was speculating both Mr Sanders and the suspect had entered the cafeteria via a west door, near the faculty lounge area When asked to describe this suspect, Kyle Hayes stated he appeared to be a white male, approximately 6'1" in height, with a thin build. Kyle Hayes specifically described the suspect as "skinny," pointing out the aforementioned was "hunched over" as he proceeded to move into the cafeteria. In respect to the suspect's clothing, Kyle Hayes stated the suspect was wearing a dark colored, ski style mask, with holes cut out for the eyes, nose and mouth. In addition, the suspect was wearing a black "trench coat" with a black hat, which was worn backwards Kyle Hayes was unable to provide any additional description regarding the suspect. Pursuant to questioning, Kyle Hayes stated he could not recall seeing any weapons in possession of the suspect during the above observation.

When asked to describe the suspect's actions after entering the commons area. Kyle Hayes stated, "I don't know, I just saw him run in " Kyle Hayes stated, at that point, numerous people began following Mr. Sanders, who was now moving towards the stairs leading to the upper level of the school. Kyle Hayes explained it was his perception there was a mass exodus of the library at that point, and he could not provide any additional description of the suspect's actions, other than his initial observation. Kyle Hayes clarified he began following the group of people which were moving towards the stairs

Kyle Hayes explained as he followed the group (he along with numerous others) ran upstairs to the upper level of the school. When asked why he did not exit the school via the south commons area door, Kyle Hayes stated he was uncertain, adding, "I was just following the crowd."

Kyle Hayes explained after running up the stairs, and arriving in the upper level of the school, he recalled a female teacher (unable to identify) yelling to all of the students to "get in the classrooms." Kyle Hayes stated he entered the first classroom he saw with an open door. Upon arrival at that location, Kyle Hayes stated he believed there were approximately eight students (including himself) along with one teacher located in that room. To subsequently provided Kyle Hayes with a second diagram which depicted the upper level of the school. Kyle Hayes was asked to identify his path of travel after reaching the upper level area. Kyle Hayes subsequently drew an arrow to a room which he identified as the chemistry lab. See the aforementioned diagram for details.

Kyle Hayes was next asked to identify any others present in the room. Kyle Hayes stated he knew only two students by name. Kyle Hayes identified those students as Bartholomew Foster and Justin Albert (both ninth graders — Kyle Hayes went on to state there was another male student he recognized from his Spanish class whom he knew as "Brad" (also a ninth grader)[editor's note- Brad Miller] — Kyle Hayes reported he believed there were at least four other girls in the class who were possibly "juniors and seniors," but he did not know their names. When asked to identify the teacher, Kyle Hayes stated he thought the teacher's name was "Mr. Graves," but later indicated it was possibly Mr Craft(editor's note- it was Craft] — Kyle Hayes was unable to be more specific concerning that point

When asked what occurred after he entered the chemistry lab room, Kyle Hayes related it was somewhat chaotic Kyle Hayes stated, eventually, the teacher locked the door from the inside and placed a "barricade," later described as a "lab table," in front of the door In respect to a time frame, Kyle Hayes stated he believed it had only been "a couple minutes" after entering the chemistry lab when the door was locked and the barricade was put into place When asked what occurred after the barricade was put into place, Kyle Hayes stated it was approximately one minute later he was looking out the window of the chemistry lab from behind a table and observed the "same guy" (referring to the suspect he had seen in the cafeteria prior to going upstairs). Kyle Hayes pointed out when he saw that suspect for the second time, the aforementioned was not wearing a mask and had long, dark brown hair When asked how he knew it was the same Suspect, Kyle Hayes explained the individual was wearing the same clothes and had on the same hat (backwards) . Kyle Hayes went on to state he was positive that suspect was "Dylan." Pursuant to questioning, Kyle Hayes confirmed his identification of "Dylan" came from photographs he had seen of that individual on television after this incident.

When asked what the suspect was doing at the time he made the above observation, Kyle Hayes stated the forenamed was moving in an easterly direction down the hall and had stopped in front of the chemistry lab Kyle Hayes stated it was at that point he observed

the individual to be carrying a "shotgun" style weapon, which he believed had a wooden style stock. Kyle Hayes stated that suspect then pointed the weapon in his direction and fired one shot. Kyle Hayes stated he ducked at the time the weapon was pointed in his direction, but heard the gunshot and recalled being struck by "wood chips" from the table which was used as a barricade. Kyle Hayes reiterated at the time he heard the gunshot, "wood chips and glass were flying everywhere." IO clarified with Kyle Hayes the table used to barricade the door did not completely cover the window area, thus, allowing him a view out into the hallway.

When asked what occurred after the gunshot, Kyle Hayes stated he heard the chemistry lab door handle "jiggle." Kyle Hayes reiterated the door was locked, thus preventing the suspect from gaining entry Kyle Hayes stated he next heard laughter and then what sounded like and individual running eastbound down the hallway When asked how he could be certain about the suspect running, Kyle Hayes stated he could hear "feet pounding" which sounded like running.

Kyle Hayes next related after the above events, he along with all others in that room, took cover in the northeast corner. Kyle Hayes explained he along with the others had "set up desks in the corner that we were hiding behind." Kyle Hayes estimated over the next two hours, he heard numerous gunshots and explosions which he believed were coming from inside the building. Kyle Hayes stated after approximately two hours, he did not recall hearing any additional gunshots or explosions. When asked for additional information concerning that point, Kyle Hayes stated there was approximately a 20 to 30 minute time period where he heard most of the gunshots and explosions. Kyle Hayes was unable to be more specific concerning that point.

Kyle Hayes related after the two hour time period, he recalled the teacher in his class receiving a telephone call. Kyle Hayes explained most of the classrooms at Columbine High School had telephone access. Kyle Hayes stated after receiving that phone call, the teacher indicated he had just spoken with another faculty member in an adjoining classroom. The teacher then stated he thought it would be safer if everyone moved to that other classroom. According to Kyle Hayes, the teacher then instructed everyone to crawl through the storage area which led to the adjoining room. Kyle Hayes stated everyone complied with the teacher's request and, upon arrival in that room, believed there were nineteen total students with four adults. Kyle Hayes stated he did not know any of the additional students or adults located in that classroom. IO subsequently had Kyle Hayes indicate his path of movement into that room via the diagram. It should be further noted Kyle Hayes placed an "X" with an arrow at a location where he had seen the suspect, just prior to the shot being fired. See that diagram for complete details.





Kyle Hayes related after arriving in the adjoining science room, he along with the others present simply "sat around and waited " Kyle Hayes estimated during the next 30 minutes, it was possible he heard approximately five to six gunshots coming from inside the building. Kyle Hayes stated those last five to six gunshots seemed as though they were close to his location.

Kyle Hayes reported he was in that second science room for approximately one hour prior to being contacted by SWAT officers and escorted out of the building. Kyle Hayes stated to his knowledge, SWAT officers evacuated him (along with others present in that room) out a east entrance/exit of the school.

TO did confirm with Kyle Hayes the written statement which he signed dated 04/20/99 at 1540 hours, was actually prepared by a detective who had conducted a brief on scene interview. Kyle Hayes did indicate the written statement prepared by Det. Frank Rino, #74053, appeared accurate. To subsequently concluded his contact with Kyle Hayes. To would note the diagrams referenced in this report were initialed by both Kyle Hayes and TO and those diagrams will be maintained as evidence in this case. To will maintain care, custody and control of the above diagrams until they are turned over to the Jefferson County Sheriff's Office.





## **INVESTIGATION:**

On 05-25-99, at 1800 hours, I responded to 8059 West Hoover Place to contact and interview Candace Haywood. This interview was in reference to the shooting that occurred at Columbine High School on 04-20-99.

I interviewed Candace Haywood in the presence of her mother, Wanda Haywood. Candace Haywood told me on 04-20-99, at about 1110 hours, she got out of her Math class, which is on the second floor of the school, and this is also when her class ended. She then walked to her school locker (#1536), which is located near the main entrance of the school. Candace Haywood said after she went to her locker, she walked to the cafeteria, arriving at approximately 1115 hours. She said she looked outside of the cafeteria windows on the south side to see if the outside table that she usually sits at during lunch was available, and to see if her friends were located at that table. She said she did not see anything unusual upon looking out the windows, and said she saw that the table was available; however, none of her friends were out there. She said she saw some of her friends inside the cafeteria at a table near the south side windows. Candace Haywood showed me on a diagram of the cafeteria at the school, the table where she sat with her friends. She identified the table as being either "P," "O," "Y," or "Z" on the diagram. She said she was facing in a northwesterly direction from the table, and said the following friends were at the table with her: Elena (unknown

last name) [editor's note; Aleana Shultz], Lacey Hohn, Kitty [editor's note; Kathrine] Carlston, Nicole Boudreau, and Jennifer Barnes. Candace Haywood said a male, standing inside the west door of the cafeteria, began yelling to the students in the cafeteria to get down on the floor and get under the tables. She said she got under the table, as did her friends; however, they were laughing about it, and believed the incident was a Senior prank. She said Nicole Boudreau began to crawl away from the table in an easterly direction, so Candace Haywood said she grabbed her, pulled her back, and said to her, "Are you crazy?" Candace Haywood said she then saw several students jump up and begin running through the cafeteria in an easterly direction along the south side windows of the cafeteria. Candace Haywood said she also got up and ran, and ran past the bottom entrance of the stairway and behind a pillar next to the hallway. She said she stopped and saw the other students running up the stairway towards the second level of the school, so she did so also. She said when she got to the top of the stairs, she turned to her left and ran about 5 to 10 feet where three teachers from the high school (one female and two male teachers) were trying to stop the students from running in the halls, as they also believed the incident was a Senior prank. Candace Haywood said at that time, she heard three to four "pops" that she described as sounding like coming from a cap gun She said they sounded like they were coming from the cafeteria downstairs. She said these were the first shots she heard during the incident. Candace Haywood said she ran towards the main entrance, and was helping Jennifer Barnes run, because Barnes had high platform type soles on her shoes making it difficult for her to run. Candace Haywood said as she was running towards the main entrance, she saw a female laying on the floor who had fallen. so she jumped over the female. She said she then stopped and turned around to help the fallen female get up; however, the female had already gotten up off of the floor. Candace Haywood said she ran out of an east door of the school, across South Pierce Street, and onto the soccer field at Leawood Park. She said she looked for friends in the park for about five minutes, and then sat on a brick wall until the students in Leawood Park began scattering and running Candace Haywood said although she did not hear any shots, she ran also, going to a person's house, by the name of Lindsey. She said she later heard from other students that an unknown person wearing a black mask and a trench coat was shooting from Columbine High School towards the soccer fields in Leawood Park. She said she did not see this unknown person or hear any shots at that time.

Candace Haywood said she did not know Dylan Klebold or Eric Harris prior to the shooting. She said she did not know any members of the Trench Coat Mafia, and said the only thing she knew about them were that they always dressed in black clothing, stayed to themselves, and would gather under the stairs on the east side of the cafeteria. Candace Haywood said she

I showed Candace Haywood the photographs of the duffle bag and the propane tank which had been later recovered in the Columbine High School cafeteria. She said she did not see either item prior to or during the incident.

Candace Haywood said she left her backpack, described as a purple colored "Grand Lakes," with her student I/D inside of it, on the floor next to the table she was sitting at in the cafeteria. Candace Haywood said on 04-20-99, she was wearing "Candies" tennis shoes, tan in color, olive colored Cargo pants, and a brown plaid tank top with a collar. She said she did not hear the thought of the day over the Rebel News Network "RNN" on 04-20-99, but said she later heard the thought of the day was something to the effect of "You do not want to be here today." She said she does not have an Internet screen name because she does not use that lines. Candace Haywood said she believes she has seen students at Columbine High School with a double pierced eyebrow, but did not know their names. She said she would contact me in the future if she was able to learn the names of these students.


Candace Haywood said she has done fine dealing with this incident since it took place on 04-20-99; however, her mother, Wanda Haywood, has had a difficult time dealing with it. Wanda Haywood advised that she is currently visiting a therapist to help her through with this. I gave both Candace and Wanda Haywood one of my business cards and asked them to call me if they wanted to talk with a JCSO Victim Advocate in the future, and I told them I would make the necessary arrangements for them.

She said she believes Mallorey was at her school locker when the problems began in the Library. Candace Haywood said she did not know if Mallorey had been interviewed as of yet by law enforcement.

## INTERVIEW WITH ASHLEIGH HEESCH

On 5-18-99, Inv. Reker did conduct an interview with Ashleigh Heesch at her residence with her mother present.

Heesch states that she was in the cafeteria when a girl came in the west door of the row of doors that face south in the cafeteria and that the unknown girl was asking for help.

Heesch then heard 2 shots and then got under the table and after a minute then ran to the stairs and then to a room in the language arts rooms.

Heesch then went out a s.e. door of the building to a house on the corner of Pierce st. Heesch was sitting with Julie Brunaugh, Kim Dottenwhy, Brent Sessions and Emily Stewart, all of which have been interviewed.


Heesch stated that she had been in the cafeteria during second period and did not notice any unusual duffel bags at that time.

She also states that a girl whom she believes is named Bae Gattoni and works at the pretzel time at S.W. Plaza had an unknown girl state to her that she "was glad it happened" refering to the shootings.

Heesch also states that when she was running to the stairs that she glanced backwards and did see a gunman in a black trenchcoat in the cafeteria and he was holding what she felt was a pistol, and as she was running she was unable to provide a further description of this gunman.

Laverne Helm, 3663 South Sheridan Boulevard #K4, Denver, Colorado 80235, telephone (303)984-0460, a kitchen worker at Columbine High School, was interviewed at her home by Special Agent (SA) Ricky V. Wright regarding the incident that took place on 04/20/1999 at Columbine High School. After being advised as to the identity of the interviewing agent and the nature of the interview, Helm provided the following information:

Helm has been working as a kitchen worker at Columbine High School for the last two years. Helm's duties include cooking, cleaning, and serving. Helm normally works from 7:30 am to 1:30 pm. On the day of the shooting, Helm arrived at work at approximately 7:30 am and served breakfast until 9:30 am in the breakfast serving line. Helm did not recall seeing anyone bring in any large duffle bags that morning. Helm advised that the janitors have the responsibility of cleaning up in the commons area, but Helm thought it unlikely that any duffle bags or backpacks were in the commons area before the students came in first period. Helm had read in the newspaper that there was a bomb in the kitchen area. Helm did not believe that any large duffle bags could have been in the kitchen area, because of the traffic from the kitchen workers.

During lunch, Helm was serving lunch in the easternmost lunch line. Helm first became aware that something was going on, when she heard squeals and saw students running and climbing under tables. Someone yelled for everyone to get down because there was shooting. Some students ran behind the lunch lines. Helm and other members of the kitchen staff took cover in the laundry room located at the back of the kitchen area. Helm later learned that other students and members of the staff hid in the neighboring office. Helm advised that there were 18 individuals in her room, including teachers, students, and kitchen workers. Among the kitchen workers were Linda Last Name Unknown(LNU) [editor's note: Tibljas], Marlene Nederman(phonetic), and Sue LNU [editor's note: either Suzanne Dewlaney or Sue Laine].

The laundry room door is a heavy door and locked automatically. The laundry room is quite small and was very crowded. Helm and the others were in the room for approximately two hours and 20 minutes until a SWAT team came and rescued them. About 30 minutes after the shooting started, Helm heard voices

outside the door. Someone outside the room tried the door knob, but it was locked. Someone then knocked on the door and said to open the door because they knew there were people in the room. No one moved or answered the people outside the room. Helm could not distinguish how many individuals were outside the room. Approximately 30 minutes later, the same people came back and demanded the door be opened again. They did not shoot through the door and did not try to break down the door.

While Helm was in there, she could hear shots and occasional explosions. At one time, Helm heard one explosion which was louder than the rest. Helm still thought she heard shots until about ten minutes before she was rescued by the SWAT team.

# INVESTIGATION

On 081799 I telephonically interviewed Laverne Helm, a food services worker at Columbine High School. Laverne told me that she was at school on April 20<sup>th</sup> 1999. She was working in the Italian line cash register when the shooting began. She heard a "pop, pop". She thought it was a prank. She soon realized there was shooting going on in the school. She went into the laundry room near the kitchen and hid for three hours. She said that she was in the laundry room with eighteen others.

She had served Harris and Klebold in the cafeteria before. She only knew them because she had seen them frequent the cafeteria.

During the shooting incident she heard voices knock on the door she was hiding behind and said, "We know you are in there, come out." She did not know who was saying this. She reported to seeing none of the incident only hearing it.

he proceeded to the cafeteria area and remembers that he arrived around 11:12 a.m. I provided Jacob with a map of the cafeteria area and asked him if he could remember which table he sat at. After looking at the map he stated he was sitting at table FF After identifying where Jacob was seated, I then asked if he recalls seeing two large duffle bags or gym type bags. I described one as being blue in color and the other being an orangish/red bag, which were located in the cafeteria near where he was seated Jacob stated that he did not see the bags, nor did he see anyone bring the bags in.

Jacob stated that once he reached the table he placed his backpack on top of the table, basically saving his seat at the table, at which time he went to the food service line. After picking up his food and returning to the table, Jacob stated that he was facing west and could see out the west windows of the cafeteria. He describes hearing a loud explosion, which came from the parking lot, then describes a large "ploom" of smoke coming from a car. stating that he believed it was some type of car bombing. Shortly after hearing this, he remembers seeing the teacher, Dave Sanders, come running in the northwest doors of the cafeteria, telling the students to get down under their tables.

Jacob was asked if he could recall who else was sitting at the table with him during this incident. He stated that Chris Donnelly), telephone number (303) 972-8086, Tim Miller, telephone number (303) 979-0720, Jeff Morroni, telephone number unknown, Pat Vassar, telephone number (303) 933-9341, Kyle Hayes, telephone number (303) 979-0856, [editor:Joseph]Austin Steckler, telephone number (303) 933-1502, and Jon Stroble, telephone number unknown, were also seated at the table. Jacob describes that while he was on the floor, under his table, they started to hear gunfire coming from outside the building, at which time students started to exit from the cafeteria. He stated that as he was leaving he remembers grabbing his backpack and he started to run east towards the stairs out of the cafeteria As he went up the stairs to the main level of the school, he remembers that he started running down the east hall near the math rooms, away from the library. Jacob stated that in the mass confusion he was pushed and he fell to the ground. After he picked himself up off the floor he proceeded down one of the halls near the math rooms where he entered the math room just to the east of Ms. McWilliams' room. Also in the math room was a student by the name of Mike Kellogg, and another unidentified male.

Jacob stated that they did not remain in the math room for very long and he remembers just after the fire alarm sounded that himself and the other occupants inside the room quickly left the math room and continued east down the hall, out of the school.

where they ended up in Leawood Park. Jacob stated in the confusion and in his escape out of the school that he left his backpack in the math room. He described the backpack as being black in color, brand name was Northface. He stated he had a calculator Pro Tractor, several of his school books, and several papers with his name on them inside the backpack.

I asked Jacob if he saw any gunman while he was in Columbine High School. He stated he did not. I also reconfirmed that he did not see the two duffle bags or sports bags that I described earlier, which were located in the cafeteria.

Jacob was asked if he knew Eric Harris or Dylan Klebold. He stated he did not know those individuals and he did not know any other members who associated themselves with the "Trench Coat Mafia." I asked if there were any rumors heard at school which would reference anything was going to occur on April 20th. He stated that he did not hear anything and had no additional information to provide. Jacob was also asked if he knew that Eric Harris had a web site. He stated he did not, and again told me he didn't know much about the individuals at all.

Jacob was asked to describe his dress on the incident date. He stated he was wearing a black and brownish gold flannel shirt, khaki carpenter jeans, and he had white tennis shoes on. Jacob was asked if he left any other additional items at the school other than his backpack. He stated he did not.

After completing my interview with Jacob, I had him document where he was seated in the cafeteria and his exit route out of the school. A copy of that map is attached to this supplemental report.

# ADDITIONAL INFORMATION:

Prior to leaving Jacob's residence, I asked his mother and his step-father if they had any questions or any additional information for me. Sheryl Coalman proceeded to tell me about some individuals that live directly behind them to the west, identifying them as the Sowder's, in particular Jonathon and Melissa, who both attend Columbine High School. She stated that she was talking with a neighbor, Bianca Thompson, who lives at 5235 West Portland Drive, Littleton, Colorado, telephone number (303) 979-73 70, on Sunday, April 25, 1999 Sheryl Coalman stated that Bianca Thompson told her that neither Jonathon or Melissa Sowder



Hencke stated that he was in the cafeteria of the Columbine High School at 11:10 a.m. on 04-20-99. Hencke stated that he was with Jeff Barrett, Steven Pool, and Matt Conley. Hincke stated that they were seated in the first row of tables by the serving tine, but could not remember exactly which table.

Hencke stated that after about ten minutes at approximately 11:20, he heard a teacher, Mr. Sanders, come into the cafeteria and yell to students to get down, at which time they did. Hencke stated that after a few minutes, there was a mad rush for the stairways that lead toward the library to which they all proceeded to follow each other. Hencke stated that they ran toward the auditorium, then near the gym and exited the north west side of the school, believed to be in the Art Department area. Hencke stated that they ran toward Clement Park to the area where the students parked that are not allowed to park on school grounds Hencke stated that he heard two to three gunshots while he was in the cafeteria, but did not see any individual shooting, nor did he see anybody in trench coats that day.

Hencke stated that just prior to leaving, he heard the fire alarm goign off in the shoool.

Hencke stated that he had no further information concerning the incident at Columbine High School.

## ACTION TAKEN:

On May 14, 1999 the Reporting Agent Linda R. HOLLOWAY contacted Jason HENSLEY by telephone after speaking with his mother the evening before. Jason was asked to relate the events, as he could recall, of what he did and saw on April 20, 1999. He stated that his mother, Linda, arriving just before 1st period, drove him to school. His first class was gym, followed by English in the Language Arts wing, mathematics for the 3<sup>rd</sup> period and Spanish for 4<sup>th</sup> period.

He then went to A Lunch in the cafeteria. He sat near the Rebel store (around Table B) with Ben JOHNSON, David SCHULTE, and MATT FRIEND {editor's note: Matt's first name is Robert]. There were two tables of his friends in that area. He left his backpack on the ledge when he exited the cafeteria after the incident started. The first thing unusual that he remembers is when Matt FRIEND got up. He at first thought that a fight bad broken out when be heard someone say that there was someone with a gun.

Jason HENSLEY got under a table when instructed by a janitor. He was under the table for only a very short time when he and Ben JOHNSON ran out the door by the Rebel store and into the parking lot. He stated that it was not the senior parking lot that they ran through, but the lot adjacent to the senior's lot. He ran to a near house.

He never saw the two large duffel bags or anyone carrying them into the cafeteria.

He does not know any of the members of the TCM nor would be recognize them. He left behind his blue backpack on the west ledge which contained his math, Spanish vocabulary and assignment books, a calculator and various folders.

He was wearing blue jeans and a blue sweater that day. Other items owned by him and left at Columbine High School in his gym locker are white Adidas tennis shoes and gym clothing. He has a school locker that has a science book among other miscellaneous school items.

He does have access to the Internet and his screen name is "Credso2". He didn't know what an ICQ account is.


He didn't recall seeing or hearing any unusual announcements prior to the shooting, nor did he remember the "thought for the day".

On May 17, 1999, this investigator met with Brianna Hernandez at her residence. Present during the interview was her mother.

Brianna advised that on the day of the incident, she arrived in the cafeteria at approximately 11:15 a.m. having come from her residence as she had no fourth hour class. She was shown a sketch of the cafeteria and indicated that she had been seated at the table marked "U." She said others at her table were: Gina Rohde and Sarah Roasberry. She had only first names for the following: Sarah, Nichole, Emily, and Veronica. [editor's note: Sarah ehmeyer, Nicole est, Emily Hackett, eronica Griffith]

She stated that she observed no unusual activity in the cafeteria. She went over to the vending machines and that is when she first heard some noise which she was unable to identify. She said at that point, Mr. Sanders, who was by the service counter was telling everyone there to get down. Brianna said that she then heard what she thought was a gunshot coming from outside the cafeteria, possibly by the courtyard. She stated that she saw Dusty

Hoffschneider get up from his table (JJ) and together, they ran up the stairs to the upper level of the school. She believes that she saw an individual wearing a black trench coat outside of the Rebel Corner just as they started up the stairs. She could provide no other details about the person. She said that she ran down the hallway which is between the math and social studies hall, out the door at its east end, and into Leawood Park. After a short while, she left the park and found refuge in a nearby residence.







Travis's father was present during the interview.

Travis told me the following:

Travis is legally blind, color blind and light sensitive. He can see ten feet. Much past that, he looses fine detail and definition.

Travis was at school all morning from 6:46 am. He left somewhere between 11:25 and 11:35.

Travis was sitting a bit outside of the cafeteria, in the building. See diagram where "me" is marked. He had a view of tables e,s,w and x. The tables were 50 to 60 feet away.

He had been sitting on the floor. He'd just finished his sandwich and was drinking a can of pop, just watching people right in front of him. He heard somebody yelling. There were no words, He said that it's very loud in the kind of like a low scream. cafeteria during lunch with people talking and dishes clattering. He then heard people running, like a bunch of feet stamping. heard someone say, "Oh God." People started running over by where People started hiding behind the stone pillar, the Pepsi machine and around by where he was. Travis went to people at the Pepsi machine and asked what was going on. Somebody said that somebody was shooting people. Travis didn't hear gunfire. He could hear people saying to get down. He could now hear screaming from by the windows. He said that pretty much everybody in this section "mass turned" and went down the main hallway by the foreign language section. He said that he leaned down to get his back pack. As he leaned, he could see the lower landing. He saw someone. He couldn't tell if it was male or female, a gunman or a student. He couldn't tell what they were wearing. This person was running up the stairs.

Travis said that at the end of the foreign language hall, there is an indentation before the class. There, he heard someone say, "Don't go outside. Someone is throwing bombs." Travis went into an alcove and then into the last room on the end. He and two other girls (unknown who), went in and got under the table on the east sides of the room. He still had his back pack. He handed his back

pack to someone to get it out of the way. He's not sure, but thinks they were in that room for two to five minutes.

Travis said that while under the table, he heard gun shots. He said the shots fired once, then again in two or three seconds. He said that the shots sounded like they were coming from the library. He's heard gun shots at camp and on the 4th of July. He said that what he heard sounded like gun shots. He thinks that Miss Kelly may have been in the room with him. He saw her later and recognized her shoes. She was trying to dial 911.

Someone said that it was clear and told everyone to run out to the emergency door and straight across the sidewalk. He got up and left his pack pack in that room.

Travis said that going across the parking lot he saw Leigh Kamens, a student. She had on big clunky sandals, and she jumped over the wall. There was another girl in a leg brace. He helped her. They went past the fence.

Travis went to the seminary. Other people were there. Chris Stafford, another student, a junior, was at the seminary school. Chris's 5th hour class is at the seminary and he was there during the shooting. Travis said that he was in the seminary about 3 hours, give or take a half hour.

Travis said that the name of TCM was given to the group by other kids because of the trench coats they wore. He said that the TCM just sort of adopted the name.

I spoke briefly with Sharon Hill, Travis's mother. She didn't remember where she heard it, but she heard that one of the wounded boys saw 4 to 5 kids taking bombs out of their back packs and throwing them around. She had no further information.



Erin Powell Hoffman, DOB 04/08/1984, 6565 West Hoover Place, Littleton, Colorado, telephone (303)795-8457, was interviewed at her home in the presence of her parents, Raina Powell and Monty Hoffman by Special Agent(SA) Ricky V. Wright regarding the incident that took place on 04/20/1999 at Columbine High School. After being advised as to the identity of the interviewing agent and the nature of the interview, Hoffman provided the following information:

At approximately 11:10 am, Hoffman got out of English class and proceeded to her locker, locker #1090. From her locker, Hoffman went to the cafeteria. Hoffman's lunch time officially started at 11:15 am. Hoffman set her green Jansport bookbag at the lunchroom table (marked EE on diagram sketch) and then went to the cafeteria restroom. When she returned from the restroom, she sat down at the table to talk to her friends. Hoffman was sitting at the table with her back to the kitchen. Hoffman cannot remember everyone who was sitting at the table, but does remember that Kim Anderson, Jamie Klement, Kristin Cardwell, and Elizabeth Nolan were at her table. Cardwell set her book bag to Hoffman's right, but was in line at the kitchen when the commotion started. Hoffman does not remember if anyone was sitting to her left.

Shortly after she sat down, Hoffman heard William Sanders yell for everyone to get down. Sanders was crouched just outside the teachers lounge. Hoffman did not know what was wrong, but got under the table. Everyone else got down as well and those students who were closest to the windows started crawling away. Hoffman remembers seeing Nathan anderau crawl by her table. Everyone stayed down for less than a minute and then got up and started screaming and running in all directions. Some of the students ran down the foreign language hall and others ran into the auditorium. Hoffman ran up the stairs to the main level and then ran down the hall toward the math hall, which is in the opposite direction of the library. While running Hoffman could hear shots being fired from somewhere outside the cafeteria by the teachers lounge.

Once in the math area, Hoffman and three boys from the cafeteria ran into a class room in the southwest corner of the

math hall. They warned the teacher and the students in the classroom that shots had been fired and everyone in the classroom got down under the desks. After a few minutes, the fire alarm went off, but no one left the room. A few minutes later a teacher came and opened the door and told everyone to get out of the building. Everyone in the classroom exited out the door on the southwest corner of the math hall. They then ran across Pierce Street to Leawood Park.

Hoffman never saw any of the gunmen. Hoffman did not remember seeing any large duffle bags sitting in the cafeteria. Hoffman said it was not unusual for students to be carrying large duffle bags containing sporting equipment. Hoffman does not know who was sitting at the table behind her (marked RR on diagram sketch). Hoffman believes that Sarah Brown, Ben Smith, Jami Amo, Joe Dreaden, and Seth Dubois were also in the cafeteria at the time of the incident.


Hoffman did not know Eric Harris, Dylan Klebold, or any of the other members of the Trenchcoat Mafia.

# INVESTIGATION:

On April 30, 1999 at 0800 hours I contacted Dusty Hoffschneider at his home for an interview. Both his parents were present. Dusty then told me the following:

- He is a sophomore at Columbine High.
- \* When asked about Eric Harris, he said that he has never seen him before and did not know his name. The same went for Dylan Klebold.
- \* He has heard of and thought he was a student associated with the trench coat students. He also thought he was the one who always wore a green beret. He described the wearer of the green beret as a white male, 6', 160, thin with brownish-blond

hair past the ears, unknown if facial hair. When asked if that male might be a might be


- # He does not know any other person in that trench coat group.
- \* He has heard of the name, "Trench Coat Mafia" before and thought they were "no big deal." He would see them hanging out in the cafeteria behind the stairs.
- \* He said a friend of his named Greg Barnes told him that two or three trench coat students missed a class he had with them on the day of the shooting.
- \* When asked if he saw any of the trench coat students or the students whose names are mentioned above at the school the day of the shooting he said no.
- \* He saw no items out of place that day at school and in the cafeteria. When asked specifically, he said he did not see any duffle bags.
- \* After his 4th hour math class, 11:10 a.m., he went to his locker nearby and then down the stairs to the cafeteria. He dropped his backpack off at a table. He looked at the diagram and thought it was table JJ. (This matched the location his pack was found.) He then went to Rebel Corner for a soda. He came back to the table and sat there for lunch with; Joey Millazzo, Josh Buschmann, Pat Simington, Brad Pesicka, Ryan Ezzie, Mike Leary and Dominic Desaverio.
- \* He said around 11:20 a.m. four kids came running in the west door to the cafeteria and said that, "Someone got shot." He said teachers started to run around telling everyone to get down. He said Mr. Sanders ran in front of the lunch line from the west and over to the stairs.

- \* He got down by his table and saw smoke out in the parking lot to the west.
- \* He was wearing cargo shorts, sandals, and a blue polo shirt.
- \* He did not think the situation was serious. He then walked to the kitchen and entered via a door on the east side. He was with Pat, Josh, and Dominic. He saw that there were a lot of people "piling" into the back storage room off the kitchen. They then were standing in the kitchen and heard two big explosions. Smoke was then coming into the kitchen.
- \* They stayed in the kitchen for a few minutes and then crawled west through the kitchen to the west cafeteria door. He said that 10 minutes had passed by then.
- \* As they were going out that west door, they had to step over a wounded boy who was on his stomach in the doorway. He saw two more wounded kids in the area of the bottom of the outside stairs to the hill. They went up the stairs and saw another wounded kid up by the top of the stairs.
- \* They ran up the hill and encountered a cop who told them to run back south through the lot. They eventually ended up in Clement Park.
- \* He heard several gunshots while in the kitchen. He then smelled gunpowder. He knew this smell as he is an avid hunter.
- \* He never saw the suspects. He did see that there were several students still huddled in the southwest corner of the cafeteria as they were leaving.

This concluded my interview with Dusty Hoffschneider.

## OBSERVATION / INVESTIGATION:

On April 28, 1999 I was assigned to interview Lacey Marie Hohn. Lacey is a student at Columbine and was possibly in the cafeteria at the time of the shootings. Also Lacey may have seen the shooters. I contacted Ms. Candy Fisher, Lacey's mother, and made an appointment to interview her on April 29, 1999 at 1000 hours.

On April 29th at 0950 hours I arrived at 6342 South Spotswood Street and conducted the interview with Lacey Hohn.

Lacey said that she had been in the cafeteria on April 20th. She continued to say that she arrived in the cafeteria at about 11:00AM. She advised that she was sitting at one of the tables identified as "P", "O", "Y", or "Z" she was not exactly sure, but thought she was seated at the table identified as "O" on the diagram marked HOHN 1. Lacey continued to relate that she was sitting with:

- (1) Jane [editor- from other accounts it's likely Jennifer Barnes
- (2) Candice [editor- Havwood]
- (3) Nicole [editor-Boudreau]
- (4) Katie [editor- Carlston]

Lacey could not provide the last names of the subjects. Lacey advised that she did not see any duffel bag on the cafeteria floor when she arrived in the cafeteria. However, she related that there were many back packs on the floor when she got to her table. Lacey confirmed that she did leave her back pack in the cafeteria and described it as a yellow "wolf creek" and it contained some binders. She said that she had just put her books in her locker before going to the cafeteria.

Lacey reported that the first she knew there might be a problem was when all of the kids sitting in the north-west corner of the cafeteria began jumping under the tables. At about this same time she looked out of the window and observed Dylan (klebold) shoot a girl with a shot gun. Lacey stated she actually observed the shooting. She continued to say that the victim must have been on the ground as Dylan was leaning over when he fired the gun. This shooting occurred outside of the west cafeteria exit. Lacey stated that after the shooting she left her table and started toward the victim to see if she could help her, however, before going too far she paused and then retreated. She advised that she met Anthony Caruso and told him some had been shot. Lacey advised that she left the cafeteria by way of the lower level of the auditorium. Lacey said she believed the person who was shot outside the cafeteria was Rachel Scott.

Lacey stated that she went up the stairs in the north-east corner of the auditorium to the upper (main) level of the auditorium. Once in the upper level she and a boy she knew as "Scott" started to leave by way of the north-east auditorium door. As Scott opened the door they were fired upon from the west end of the hall. Lacey continued to say that they broke and ran across the hall, and at this time she saw two shooters at the junction of the north main level hall way and the library hall. She reported that she recognized one of the shooters as Dylan (Klebold) but she did not get a good enough look at the second person to know who he was. She advised that the second was wearing a black coat, not a trench coat but more like a jacket, and black pants. She advised that Dylan was wearing a black trench coat. Lacey said that they ran across the north hall and into the gym hall and while doing so were fired upon by the shooters.

Lacey said that they went into the gym where the girls dance combo was and then hid in the wrestling room for about five minutes. They then exited the school by way of the weight room. She ran into Clement park where she located her sister Penny. They waited for a friend, Carrie, and when Carrie arrived they all got into Evan's car and drove Evan's friends (Will) house. Lacey did not know Evan or Wills last name. She said that Carrie said she (Carrie) had walked out of the west main level door on her way to the "smokers pit" when she walked by two of the shooters who were about ready to enter the school. Lacey advised that she believes that Dylan walked up the outside stairs from the cafeteria enterance to the west, north hall enterance, and from there he and the second shooter entered the school. Lacey continued to say that Carrie said one of the shooters, she walked by, was wearing a white t-shirt and the second one was wearing a black trench coat and had a gun in his belt. Carrie related she thought the gun was a toy. Lacey identified Carrie as CARRIE KLAPPER she also provided a phone number of (303) 973-9241 for Carrie. Lacey identified to of the girls she met in the gym as Jessica Jones and Erin Brickley. Lacey also stated that she believed that the school principal was also standing in the gym hall.

Lacey stated that she could not provide any information as to who might have brought bombs into the school or had provided the guns. She continued to say that she has no contact with the Trench Coat Mafia and had heard no rumors about pending trouble on the twentieth. She continued to say that she was not familiar with the suspects computer names as she does not have a computer and does not use the internet.




Lacey looked through a series of photographic line ups and identified photo number three, in the display marked "#1" by this detective. She identified this person as Dylan. Lacey continued to look through the rest of the photographic displays but was not able to identify any of the other people displayed as the second person who had fired on her. She did say that the person depicted in photo number three was the same person who had shot the victim outside of the cafeteria. Lacey reported that she just did not get that clear of a look at the second shooter. She also said that the pictures in the displays were very old.

I asked Maiynda to explain what had happened on that day. Malynda said that she was in the cafeteria at about 11:25 a.m. and she heard, what she believed to be shots fired in the cafeteria area. I asked Malynda where the shots came from and she said she believed by the windows at the end of the cafeteria. Malynda pointed to windows which are on the rounded wall o, the cafeteria in the sketch. Malynda said she then heard someone yell "Duck and to get under the table, she did. Malynda said she then heard more shots and at this time Mr. Andres, Jr., told everyone to go to the auditorium. Malynda said they left the cafeteria and ran to the auditorium. Malynda said once in the auditorium, she ran towards the front of the auditorium and she heard someone pounding on the back door of the auditorium, trying to get in. I asked if she heard anyone say anything and she said, no, she did not. I asked her how long she was in the auditorium and she said approximately 15 or 20 minutes. Malynda said after being in the auditorium a short time, Mr. Andres, Jr., told everyone to run out of the auditorium. I asked Malynda how they left the auditorium. She said they ran through a hallway, which is by the cafeteria, to the hill outside of the school. I asked Malynda if she saw anyone shooting in the cafeteria or anywhere in the school and she said no, she did not. I asked her if she saw any type of explosives in the school and she said the only thing she remembered seeing was "black stuff" on the floor. When asked where she saw the "black stuff", she said in the lunch room and in the hallway. I asked Malynda if she could explain what the "black stuff" was and she said it looked like something that would come from a pipe bomb. I asked if she had ever seen this type of material before and she said, no, she had not. I asked her if anyone shot at her and she said no, they did not.

I asked Malynda if she saw anyone carry two duffel bags into the cafeteria and she said, no. I then asked if she had seen two duffel bags in the cafeteria and she again said no. I asked Malynda if she knows who Eric Harris and Dylan Kleboid were and she said "no". I asked Malynda if she had left anything in the cafeteria and she said just her "word wise" and her "lunch". I asked Malynda if she knew any of the Trench Coat Mafia members and she said "no". I asked her if she had heard any information since that day reference bomb making, buying guns or other suspects and she said "no". I asked what she was wearing or at day and she said she does not remember.



I asked Sarah if she could tell me what happened that day. Sarah said she was sitting with some friends at the table when she heard screaming coming from the area of table "UU". Sarah said she heard some person say to get down underneath the tables. Sarah said she got down and then raised her head and looked out the window and saw smoke outside. Sarah said she then heard, what she believed to be, an explosion outside. Sarah said after the explosion she heard one yell "get up and start running". Sarah said she did get up and run down the hall next to the cateteria, to the door to Leawood Park. I asked Sarah if she saw anyone with any type of explosives and she said, no. I asked Sarah if she saw two large duffel bags in the cafeteria and she said, no. I asked her if she had seen anyone carrying or in possession of large duffel bags and she again said, "No" I asked Sarah if she remembered seeing Eric or Dylan on Monday or Tuesday and she said, no, she did not see them. 🗓 asked her if she left anything behind in the cafeteria and she said she left a blue Eddie Bauer backpack with her school books at the table in the cafeteria where she was sitting. I asked her if she had talked to anyone from the Trench Coat Mafia on either Monday or Tuesday and she said, "No". I asked her what she was wearing that day and she said she had jeans on, and a blue, gray and white striped shirt. Tasked Sarah what hallway she ran down when she left the building and she said it was the one next to the main hallway. I asked Sarah if she uses the Internet and she said yes, she does. I asked what her screen name is and she said "Shroom space 719 space AOL space D.comm". I asked if she knows anyone with a double pierced eyebrow and she said, "No". I asked her if she remembers seeing or hearing any unusual announcements prior to the shooting that morning and she said, no, she did not. I asked if there's any further information that she could provide reference the Trench Coat Mafia and she said, "No." I asked Sarah if she had any further information reference the shooting that day and she said nothing that she could think of at the moment. I asked if she has heard any rumors or talked to anyone about any other suspects or making of bombs. She said no, she has not heard anything about anyone besides. Eric and Dylan, I gave Sarah a business card and asked that she call me with any further information. At this time the interview with Sarah was concluded.



I brought out a sketch of the cafeteria and asked her to show me where she was in the cafeteria. Michelle said that she was not seated at a table, but was standing next to one by the windows. I asked her what table she was next to and she said next to table "L". She then put an "x" next to the window where she was standing I asked Michelle if she could tell me what happened that day. Michelle said she was in the cafeteria at approximately 11:15 hours, coming from her Math class. Michelle said while standing next to the window she heard someone yell "Get off of me". I asked her where she heard this from and she said from outside by the wall with the doors and the windows. Michelle said she looked outside and saw two males, one on top of the other and she believed that both had been shot. I asked who these males were and she said one was John Tomlin. I asked if she heard these males say anything and she said that she heard John say that one of the Trench Coat Mafia had shot him. It asked if she saw anyone shooting anyone and she said no, she did not. I asked Michelle what happened next and she said she heard gunshots and then heard a teacher tell everyone to go into the Teacher's Lounge, where she hid by tables with other students. Michelle said that she could feel vibrations in the floor and walls from bombs exploding. I asked if she remembers how many she heard exploding and she said approximately a total of seven bombs. She said after the first bomb they heard while in the Teacher's Lounge, they ran to the kitchen and hid in a storage room. Michelle said the janitor told them the shooters were getting closer and for them to stay in the storage room. Michelle said there was approximately 18 students in the room. I asked Michelle if anyone tried getting into the storage room while they were in there and she said there was one person trying to get in and she doesn't know if it was a student of one of the shooters. Michelle said that person put a school ID underneath the door to show who they were, but they still did not let this person in, as they didn't know if that was really who was there or not. I asked Michelle if she remembers whose name was on the ID and she said, no, she did not. I asked if this person ever came back trying to get in again, and she said yes, approximately three times, but they never did let the student in. I asked Michelle if she heard any other gunshots while in the storage room and she said yes, she heard numerous shots and a total of approximately seven explosions. I asked Michelle if she knew where the shooters were and she said she believed they were in the kitchen, cafeteria and the library. I asked if there were any shots fired while in the cafeteria and she said, yes. I asked Michelle how long she was in the storage room and she said ximately two hours. I asked how she got out of the storage room and she said a SWAT team got them out and had them leave through a window that had been shot out in the Teacher's Lounge.





On May 5, 1999, this investigator met with Michael Huntington at his residence. Present during the interview were his parents, Kathy and Kerry Huntington.

Michael stated that he arrived in the cafeteria at approximately 11:05 a.m., having come from his fourth hour class which is off-campus. He said he had walked from that class, held in a house near the school and did not see anything unusual outside. He was shown a diagram of the cafeteria and was asked to indicate which table he had been seated at. He advised that he was not sure of the exact table, so he circled tables "M" and ""BB." He said that others at his table included: Daniel Grange, Spencer Wright, Aaron Wright, Casey Jackman, and Seth Dubois.

Michael advised that shortly after sitting down, he heard what he thought could have been gunshots coming from outside the cafeteria, from the northwest. He said that there were a number of shots but could not say with any certainty, the number of shots. He

did believe that the shots were not in quick succession. He said there was some time between each shot. He said he then heard someone yell "get down." He did not know who that person was. He said that he ran through the cafeteria and then up the stairs to a hallway that goes east, in between the social studies area and the math area. He exited the school and ran into Clement Park. He recalled that while he had been running up the cafeteria stairs, he heard five gunshots which were in rapid order. He could not determine where they came from.

Michael was unable to provide any further information.



On 5/5/99 I interviewed 14 year old CHS student Casey Jackman at his home in Littleton, Co. Casey's mother was present for this interview.

Casey stated that he was in the CHS cafeteria for "A" lunch which began at 11:20am on 4/20/99. He stated that he had come from science class and walked alone to the cafeteria. He arrived and ordered nachos at rebel corner. He sat down at his usual area with friends Mike Kellogg, Justin Alber and Phil Secrist. I showed Casey a drawing of the CHS cafeteria which depicted all the tables. I pointed out certain areas to help Casey understand the lay-out of this drawing. Casey pointed to table "M" near the west windows as the table he and his friends were seated at. Casey recalled he sat down with his back towards the windows, facing the cafeteria. He had just sat down when the commotion began.

He did not notice any unusually large duffle bags in the cafeteria, but stated that "everyone carrys a backpack". I advised Casey I was looking specifically for a larger duffle bag. He stated he did not see this. He also stated he did not see anybody suspicious carrying a large duffle bag earlier in the day, or the previous day.

Casey stated that around 11:30am he heard "pops" behind him and everybody stood up. Casey thought there was a fight. A janitor yelled for everyone to get down, which Casey did. He recalled hearing someone say that someone had been shot. Casey was not sure who said this.

He stated everyone began to run towards the steps. Casey stood up and ran towards the steps with a large group and upstairs into the main hallway. He recalled hearing "semi automatic" gunfire behind him as he ran up the stairs. He described semi automatic gunfire as "rapid type fire". He continued straight ahead with several students, and ran out of the building through the exit doors south of the main entrance. He did not encounter any gunman while exiting the building. He ran out, crossed Pierce street to Weaver street and ran into a home somewhere on Weaver street with other students. He then left this house and ran to Seth Dubois's house on Calhone place. Seth is CHS student and a friend of Casey's.



I went to lunch, got my lunch, sat down with my friends at a table. I took one bite and noticed that everyone was standing up. I looked over and figured it was a fight. All the guys got <u>under</u> the table, so I knew something was up. I kept looking and saw that a somewhat tall guy, black trench coat, black hat, with about chin length, wavy, brownish-blonde hair. I saw he had a black gun, unknown type, he was pointing it towards (kind of ) the ground at an angle. I heard the boom and saw the gun jerk. I got under the table and moved towards the stairs. I ran and Mr. Craft told us to come in there. We ran to the storage room and 5 of us crouched low. We heard numerous explosions in the first hour but there weren't any explosions for the last 2 hours we were there.

On 4/29/99 I interviewed 15 year old CHS student Nicole Janda at her home in Littleton, Co. Nicole's mother was present for this interview.

Nicole advised me that she was in the cafeteria at CHS when the shooting began around 11:25am. She had come to the cafeteria from the choir room to attend "A" lunch which stated at 11:15am. She and Carmen Deihl walked together to their table, then to the lunch line. She sat with 5 other CHS students: Carmen Deihl, Stephanie Wise, Megan Schoenbein, Kelli Carpenter and Robyn Sarafin. I provided Nicole a drawing of the cafeteria, which depicted all the tables and their location in the cafeteria. I pointed out specific areas, such as food line, kitchen and west windows of the cafeteria to give Nicole a better understanding of the lay-out in this drawing. Nicole looked at the drawing and pointed to table Z as the table she and her friends were seated at. She recalled that she was seated facing the kitchen and that Carmen was on her right. Nicole circled table Z on the drawing and initialed where she was seated.

Immediately after sitting down to eat, she saw everyone standing up to look out the west windows. She looked over and saw a tall (6') man wearing a trench coat, black backwards cap, wavy chin length brown/blonde hair pointing a gun at an angle towards the ground. Nicole saw the gun go off, describing this as a "jerking motion with smoke". She described the gun as black, about 12" long.

She got under her table with Stephanie and then ran upstairs with most of the kids running out. She ran into a science room, then into a storage room next to the science rooms. A few minutes later she heard boys laughing outside in the hallway and continued hearing gunfire and explosions. She did not recognize any voices, but believed it was 2 different people. At one point, she heard a girl screaming in the direction of the main hallway outside the science rooms.

She remained in the science storage area, hiding between 2 shelves until she was rescued by SWAT. She did not see the gunman upstairs, but did hear them laughing out in the hall.


Nicole could not say who the gunman was that she saw outside the cafeteria at 11:25am. She said it was to fast.

She thought it was another fight that they were watching. Then she heard loud bangs. She stated Mr. Sanders came into the cafeteria from the outside north west cafeteria exit door. Mr. Sanders yelled at everyone to get down. Shelly stated she and the others got on the floor under the table. She stated Mr. Sanders went back outside and then immediately came back in the cafeteria. They heard a lot of bangs and booms. Shelly stated that a lot of them thought it was a senior prank.

Shelly then heard some kids yell, "they have guns". She stated she and approximately 50 to 75 other kids. ran east through the cafeteria to the kitchen area. She stated the two auditorium doors were closed. Mr. Andres was on the other side of the doors and pushed them open for all the kids to come through. She stated she ran into the auditorium and ran to the upper level of the auditorium and out into the hallway (north east portion of the auditorium) She stated that she heard gunfire as she ran toward the front door but stopped when she noticed that the window had been shot out of the front doors. She looked back over her shoulder and noticed that the parrier was closed in the hallway to the west of the auditorium doors. She stated she was with a lot of other kids when they left out the north exit near the gymnasium. She then ran to Clement Park.


Shelly stated she had a backpack with her and carried it outside. She stated she was wearing a black skirt with a gray sleeveless vest and black sleeveless shirt underneath. She had on black boots.

At this point Shelly's mother, Donna Jenkins, added that Shelly's 18 year old brother, Brad, was in the west parking lot during this time. Brad was there to pick up a friend. 

- \* When asked about Dylan Klebold, he said he never has seen him in school and does not know him by face or name.






- \* He has seen two to three students who dress in trench coats but was not aware of the formal name of Trench Coat Mafia.
- \* He did not see Eric, Dylan, or any other trench coat students at the school the day of the shooting.
- \* He did not see any objects out of place or suspicious persons in the school or cafeteria that day. When specifically asked, he did not see any duffle bags in the school or cafeteria.
- \* He got out of his 4th hour earth science class at 11:10 a.m. He went to his locker by the science area and then to Rebel Corner for his meal. He then went into the cafeteria with his meal and sat at able in the middle by the south exit doors. Upon looking at the diagram, he thought it was table G or H. He was with Chris Masias, Lauren Tocci, Jocelyn (unknown last name [editor's note: Provo) and Jennifer Ribble. (Ribble and Tocci's backpacks listed at table G.)
- \* He then noticed that a janitor was telling everyone to "get down." The janitor was between the south exit doors and the tables. He got on the floor and then saw smoke coming from out in the west parking lot behind the cars. Everyone then ran out of the cafeteria. He went up the stairs. He heard what he thought were five gunshots. He then ran down the hallway to the east and out the doors in the southeast part of the school (foreign language area). This concluded my interview with Jared Jensen.

Ben told me the following:

He was at school all morning on the 20th of April. He has second hour free and went to the cafeteria at 8:30. He saw nothing unusual. He sat at table MM, and then went to his Spanish class.

Ben went back to the cafeteria for lunch at 11:10. He sat at a table close to the student store with Jason Hensley, Mike Foster, BJ [editor: William] Second, Brooke Allison and Braden Pollard.

Ben bought his lunch and then sat down. He'd been eating for about five minutes. The janitor told everyone to get under the table. Ben did. After about one minute, everyone started running out of the cafeteria. At first Ben though there was a fight. He didn't hear any gunshots. He ran out of the door by the student store. He went to "some guy's" house. He just knocked on the door and didn't know who lived at the house. He stayed there until he was told to go to the library.

Ben said that he never heard gun shots. When he got to the house, he heard what sounded like a bomb, and the windows of the house were shaking.

Ben left his blue Eastpack in the cafeteria. In the back pack was his math book and some C.D.s. His school ID was also in the pack.

He never saw the shooter(s). He didn't know Eric Harris or Dylan Klebold until he saw them on television. He didn't know what the TCM was all about until this incident. He had seen one guy, Robert Perry, in the halls last semester wearing a trench coat. Ben looked in his year book to get Perry's name. Ben said that he heard around school that


The day of the shooting, Ben had worn shorts and a red Old Navy shirt. Ben doesn't use the Internet. He knows no one with a double pierced eyebrow. He noticed nothing unusual on the RNN.

05/17/99,1010 hrs. Travis Jones was interviewed by Detective S.C. Shott #72049 (DPD) at his home. His mother, JoAnne was present and sat in on the interview.

Travis reported that he attended his 4th period class, which got out at 1110 hrs. He walked directly to the cafeteria area with his friend Quinn Boortz. They purchased lunch items at the Rebel Corner and sat at one of the three tables that were nearby. They were there for approximately five minutes when a janitor came up to them and told everyone to get down under the tables. Travis said that when he crouched down under the table he saw a flash of lights then a cloud of smoke coming from the senior parking lot. Approximately two minutes later he heard gunshots coming from the teacher's area of the cafeteria. At this time, students began running from the cafeteria in all directions and towards the parking lot. Travis said that he followed suit and ran to the parking lot out the main door by the cafeteria. He continued running until he got to the junior parking lot then he ducked down in an irrigation ditch and waited. He stayed there for several minutes until a teacher came by and told everyone to go home.

Travis said that he left his backpack on the floor near the chair where he was sitting and he did not take it when he fled. He described his pack as a black "North Face" that contained misc, schoolbooks and items. He said that when he ran from the school, Quinn Boortz was with him.

Travis said that he does not know Eric Harris or Dylan Klebold nor does he know any of the Trench Coat Mafia members. He did say that he was aware of the TCM and knew how they dressed and he has seen the group walking around at school. He could not recall if he saw any of the TCM members on the Monday prior to the shooting or on the day of the shooting. He did not see a duffel bag in the cafeteria and he did not see anyone bringing one in. Travis said that on the day of the incident, he was wearing a pair of green shorts, tennis shoes and an unknown type of shirt.

Travis said that after the incident and while attending Chatfield HS, he heard rumors that was involved and could have been one of the shooters. He could not recall the source of the information, however.

#### **NVESTIGATION:**

On 06-07-99, between the hours of 1507 and 1528, I had an opportunity to speak with Katherine Jorgensen in reference to the Columbine incident that occurred on 04-20-99. Also present at the interview was her mother, Julie Joregensen.

Katherine explained that she arrived at school on 04-20-99, at about 0805 hours, and her mother had dropped her off at the main entrance of the school. Katherine attended her normal scheduled classes telling me that her fourth period class is choir taught by Mr. Andres, Jr. After being released from her fourth period class, at about 1110 hours, Katherine proceeded to her locker, which is #800, and she described it as being right across from the library. After she went to her locker, Katherine said she went down to the cafeteria and arrived at about 1115 hours, where she placed her backpack on the table. I provided Katherine a diagram of the cafeteria at the school and asked if she could tell me which table she was seated at. Katherine, after looking at the diagram, told me she was seated at table "KK." I asked her who was seated at the table with her, and she told me her friends, Keira Odell and Nicole Ziccardi. After she placed her items on the table, she proceeded to Rebel Corner where she was going to get something to eat. After returning to the table, she told me her back was to the west windows of the cafeteria, and that she recalls a janitor over near the food service line, and he was yelling at the students to get down. Katherine also recalled that she heard someone yell, "They've got guns," but she couldn't provide any information who yelled that.

I asked Katherine if she had any idea why she was being told to get down under the table by janitorial staff. She said at first she thought there was a fight, and she recalls shortly after they got down under the tables, that the students who were over near the west windows of the cafeteria got up and started to run east. She told me she was one of the first parties out of the cafeteria, and after she left her table, she ran up the stairs to the main level of the school, and ran east down the math/science hallway. Once she reached the east doors, she exited from the school and ran over to Leawood Park. Katherine explained that once she reached Leawood Park she heard explosions, and they didn't stay at the park long, they went over to her friend. Lindsy Blair's, house where they sought refuge in her home.

Katherine was asked while she was in the cafeteria, or after she had exited from the school, if she ever observed any gunmen at the school. She said she never observed any gunmen, but she heard a couple of gunshots and heard what she thought were explosions.

Using the map of the cafeteria area, I asked her if she observed two large duffle bags, one being blue and the other being an organish/red color which were located in the central core area of the cafeteria. I asked her if she observed these bags or if she saw anyone bring the bags into the cafeteria. She was unable to provide any information about the bags.

Katherine was asked if she had observed anything out of the ordinary when she was at her locker prior to going down into the cafeteria at 1115 hours. She said there was nothing out of the ordinary which would have led her to believe anything was wrong. I also asked her if she had any idea what the phrase of the day was at school. She said she did not know it. I asked if there were any rumors prior to 04-02-99, of anything that was going to occur. She could not provide any information. She was also asked if she specifically knew Eric Harris or Dylan Klebold, or any associates of the Trench Coat Mafia. She said she did not know Harris or Klebold, and she did not know the Trench Coat Mafia existed until after this incident.

Katherine was asked if she could recall what she was wearing on 04-20-99 She said she was wearing a red tank top, a pair of blue jeans, and a pair of brown shoes. I asked her if she had left anything else behind when she left the cafeteria other than her backpack. She said there was no other personal property left behind.





Valerie stated that attended her 4<sup>th</sup> period gym class, which she got early because she did not have to shower. She arrived at the cafeteria at around 11:00AM and she met with her regular friends, who she identified as Lauren Beyer, Sara Filipiak, Julie Naslund, Alex Goldberg, Nicole Ray and Jennifer Munson. They all sat at their regular table she identified as table V on the seating chart.

Valerie said that she did not know that there was a problem until she saw Mr. Sanders run by and instructing everyone to get under the tables. She first thought that it was a senior prank and students started to get up to see what was going on. Someone yelled for everyone to get back down and she heard someone say that there were people with guns. Valerie said that when everyone started to run from the cafeteria, she followed suit. She ran out of the main entrance then up the stairs towards the library. She then ran down the hallway past the science and math classrooms then out a door on the opposite end of the cafeteria. She said that once outside, she jumped a fence, ran across S. Pierce St. and didn't stop until she got to Leawood Park. While in the park, she said that she could hear what sounded like gunshots coming from the school. She then ran to a nearby house to make a telephone call then she walked over and met her sister at the Leawood elementary school. Valerie said that while she was in the cafeteria, she did not hear any explosions or gunshots. The only shots she heard were when she was standing in the park. She did not see a gunman or anyone acting suspicious.

Valerie said that she does not know Eric Harris or Dylan Klebold personally. She said that she only knew them by sight seeing them at school. She was aware of the Trench Coat Mafia and knew that they dressed different wearing trench coats. She did not see Eric or Dylan on the Monday before the incident or on the day of the incident. She did not see a black duffel bag in the cafeteria prior to the incident nor did she see anyone bringing one in. Valerie said that she left her backpack in the cafeteria and it should be on the floor near where she was sitting. She described her pack as a black "North Face" and it should contain one text book and misc. school papers. She has not heard of any rumors or talk about any other suspects that could have been involved.






05/17/99,1110 hrs. Lindsey Kastanek was interviewed at her home by Detective S.C. Short #72049 (DPD).

Lindsey stated that she attended her 4th period Spanish class that ended at 1110 hrs. She walked directly to the cafeteria and sat at a table that she pointed out on the seating chart as table KK. She said that she could not recall who was at the table with her but she could remember that when she ducked under the table, Shannon Myers was under there with her. Lindsey said that she was unaware that something was happening unit she saw several students jump up at a table nearby. She first thought that there was going to be a fight. Then Mr. Sanders and a janitor came running by and were telling everyone to get under the tables. She said that while under the table, she did not hear any explosions but thought that she might have heard what sounded like gunshots. She said that when everyone began running from the cafeteria, she followed suit. She exited the cafeteria through the main door then she ran up the stairs, past the library then down a hallway passing the science rooms and math rooms. She exited the school through the doorway on the opposite end of the cafeteria, ran across S. Pierce St. and did not stop until she got to Leawoood Park. Lindsey said that she was in the park for approximately 15 minutes when a teacher came by and told everyone run from the area.

Lindsey said that she left her backpack in the cafeteria on the floor near the chair she was sitting at. She described her pack as a royal blue "Jansport" that contained misc. school books and papers. She said that she does not know either Eric Harris or Dylan Klebold. She has never heard of the Trench Coat Mafia and does not know any of the members. She did not see any duffel bags in the cafeteria prior to the incident nor did she see anyone bringing any duffel bags in.

Lindsey said that the only rumor she heard was while talking about the incident while attending Chatfield HS. She heard students saying that they saw a guy wearing a white T-shirt throwing bomb. She did not recall whom the student was who was talking about it.

At about 11:25 we heard a gun shot. I remember Mr. Sanders coming through the cafeteria doors yelling Get Down Get Down. I heard someone got shot! So immediately went into the cafeteria, then the teacher's lounge. Then with a few others Joyce Jankowski (teacher), Sue Caruthers (teacher), A teacher I didn't know [editor's note: Judy Greco], Sean Nossaman, Nick Foss, and me. About a half hour later they boosted me into the ceiling and the rest stayed put. I climbed across the ceiling to the other side. It took me about 5 minutes to get across the room. Then from the other side I saw someone point a gun at me and I fell through the ceiling and ran to a cop car. As far as I know the suspects are Dylan Klebold, Eric Harris, ------, and I think there might have been 2 others.

Timothy Earl KASTLE, DOB: 07/04/81, was contacted at his residence, 8973 Brandt Place, Littleton, Colorado on April 24, 1999 at approximately 4:30 PM. He was advised of the personal and professional identities of the writer and Agent Jerry Means of the Colorado Bureau of Investigation. KASTLE's parents, Earl and Kim KASTLE, were present during the interview.

KASTLE advised that he is a senior at Columbine High School. He advised that on April 20, 1999 he was in the cafeteria talking to a friend, Adam SANDS, who was seated by the west window of the cafeteria. KASTLE said that he was not planning to have lunch in the cafeteria, but just stopped by to see friends.

KASTLE stated that he suddenly heard two loud bangs, and then heard a teacher, Mr. SANDERS, shout at everyone to get down. KASTLE stated that he first went into the kitchen, and then into the teacher's lounge. He overheard someone saying that someone had been shot.

KASTLE went into the bathroom, where he was joined by students Nick FOSS and Sean NOSSAMAN, and teachers Sue CARUTHERS, Joyce JANKOWSKI and a female teacher whom he did not know [editor's note: Judy Greco].

KASTLE stated that when he went into the faculty lounge, he could see two bodies laying outside the window on the west side of the cafeteria. One of these subjects appeared to have had his face shot.

They locked the bathroom door, and heard numerous noises including loud bangs, screaming and the sound of people running. KASTLE stated that the sounds seemed to be coming from right outside the door.

Concerned that someone might come in to get them, they began to discuss climbing up in the ceiling to hide or escape. KASTLE climbed up into the ceiling, then assisted Joyce JANKOWSKI in getting up into the suspended ceiling area. JANKOWSKI moved to the west to an area just beyond the bathroom wall, over the area of the faculty lounge. JANKOWSKI then fell through the

ceiling, and into the lounge. She then scrambled back into the bathroom.

KASTLE stated that he crawled on top of a metal heating duct, and moved toward the kitchen, looking for a place to hide. As he did so, he knocked several ceiling tiles off in the area of a small bathroom which services the kitchen, and which is adjacent to the bathroom they had been hiding in.

KASTLE then began moving west, following the metal ductwork and then moving along a metal pipe held up by some wires. As KASTLE reached the area of the west wall, he looked back to the area over the bathroom in the kitchen area. As he did, he observed a subject in that area, whose head was just above the ceiling area. KASTLE said that the subject was pointing what he believed was a shotgun at him. He advised that he based this on the manner in which the subject pointed the gun at him. KASTLE stated that it was dark, and he could not see the subject well. He described the subject as having shoulder-length dark hair. KASTLE stated that he believed that the subject was Dylan KLEBOLD. He said he based this on the fact that the subject had not shot him, as KASTLE advised he is a friend of KLEBOLD's. KASTLE stated that the hair he described did not fit KLEBOLD, and nothing about what he observed of the subject led him to his conclusion that the subject could be KLEBOLD.

KASTLE kicked the ceiling tiles down where he was, and dropped through the ceiling. He landed in the faculty lounge next to the window through which he and others had earlier seen the bodies. KASTLE stated that at that time the window was intact. He then escaped the building via the door located just within the cafeteria area and ran to a marked police unit on the west side. He glanced toward the cafeteria area as he ran out, and did not see anyone inside. KASTLE stated that approximately one or two minutes later he saw Sean NOSSAMAN, Nick FOSS, and two of the teachers run out. FOSS later told him that he too had gone up into the ceiling area.

KASTLE recalled that at some point while they were in the bathroom area, Nick FOSS said that one of the shooter's was "the kid in the next class that wore glasses - Dylan". KASTLE also recalled a conversation with Nate DYKEMAN in which DYKEMAN commented that Eric HARRIS and Dylan KLEBOLD were not at school.

DYKEMAN told KASTLE that they had to be up to something, as they were never gone together in the past.

KASTLE described himself as being a friend of Dylan KLEBOLD's. He stated that he had talked to him the previous evening and were talking about some trades involving their fantasy baseball teams. He recalled that KLEBOLD talked about working a trade with Adam SANDS for player Roger Clemens. KASTLE characterized the conversation as being very normal, as was KLEBOLD's mood and demeanor.

KASTLE stated that he has known Dylan KLEBOLD for approximately three years, through school and their joint interest in fantasy baseball. KASTLE stated that he has had KLEBOLD in at least one class each semester since his second semester at Columbine High School.

KASTLE advised that there is a group of individuals who participate in the fantasy baseball league, and utilize a website belonging to Chad LAUGHLIN. KASTLE advised that the Internet address for the website is HTTP://members.AOL.com/orgasmo007. KASTLE stated that he only recently got an E-mail account, and has never received any E-mail on it. He advised that his screen name is "saltysquirts99", and his password is "wackit".

KASTLE stated that the "team owners" of the fantasy baseball teams included himself, Dylan KLEBOLD, Adam SANDS, Chad LAUGHLIN, Cliff ANDREWS, Ben HANSON, Dan PALMETER, Jason SANDS, Jason FRASIER, Justin PALMENTER, Chris HOWELL, and Dan HALSEY.

KASTLE stated that he talked to KLEBOLD on a daily basis and currently had a class with him in fourth hour. They are both involved in video production. KASTLE stated that he has heard media accounts about videos that KLEBOLD allegedly made which depicted events similar to what occurred at CHS on 04/20/99. KASTLE stated that he never saw any such video.

KASTLE stated that he is not a member of the group which has come to be known as the "Trenchcoat Mafia", but has another friend who is named Nate DYKEMAN. KASTLE stated that DYKEMAN worked with Eric HARRIS and KLEBOLD at Blackjack Pizza, and that DYKEMAN was KLEBOLD's best friend until DYKEMAN became involved with Kristi EPLING.

KASTLE stated that he had Eric HARRIS in his fifth hour class, and also spoke with him almost every morning. KASTLE advised that HARRIS kept to himself, and recalled HARRIS being upset about not having a prom date.

KASTLE was asked about KLEBOLD's hobbies and interests. He stated that KLEBOLD was into hard-punk music like Marilyn MANSON, and the German rock band KMFDM. KLEBOLD was also a Red SOX fan and a Roger Clemens fan. KASTLE stated that KLEBOLD was a good guy, and that what took place was definitely out of character for him.

KASTLE stated that he has never been to KLEBOLD's residence. He has never heard him discuss anything about guns, bombs, or mentioned things like the Anarchist Cookbook.

KASTLE recalled Nate DYKEMAN telling him that HARRIS and KLEBOLD never made it to their bowling class on the morning of the shooting. Chad LAUGHLIN also told him that as he was leaving campus and KLEBOLD was arriving, LAUGHLIN "flipped off" KLEBOLD in the parking lot.

KASTLE stated that he was interviewed on 20/20 at his residence. He said that while the crew was there, he overheard a female crew member saying that had brought a duffe bag to the school. He did not know who the female crew member had brought a duffel was.

On 05-06-99 at 10:00 A.M. Detective Terry Demmel, assigned with the Columbine Law Enforcement Task Force, contacted Columbine Senior student Timothy Kastle DOB 07-04-81 at his home for the purpose of an interview. Tim's mother Kim was present and stated that Tim had already been interviewed by the FBI but agreed to another interview. Timothy reported that on Tues, the 20<sup>th</sup> he had 4<sup>th</sup> period Newspaper class then went outside and talked with his friends Chad Laughlin and Jeffrey Marquardt. Tim reported that he couldn't find his friend Andy so he went inside the cafeteria. Tim was talking with his friend Adam Sands about baseball when Mr. Sanders came in and told everybody to get down.

Tim then ran into the kitchen briefly and then turned around and ran into the teachers lounge. Tim looked out of the windows and saw two students laying on the ground that were bleeding and appeared to him to have been shot. He could not tell if the students were male or female he stated. Tim stayed in the teachers lounge bathroom approximately 1 ½ hours with friends Nick Foss. Shawn Nossaman and teachers Sue Cruthers, Joyce Jankowski and another unknown female teacher [editor note: Judy Greco]. While in the bathroom Nick Foss boosted Tim up into the ceiling. While Tim was crawling up in the ceiling he knocked a ceiling tile loose that fell into what he thinks was the kitchen bathroom. He then crawled across some vent pipe material when a party stuck their head up through the hole and pointed a gun at him. Tim stated that he is not sure who the party was but that he thinks it was Dylan Klebold. Tim stated that he had known Dylan for the last 3 years; that both Eric Harris and Dylan Klebold were in his 5<sup>th</sup> hour Psychology class with teacher Tom Johnson and that he talked with them daily and considered them good friends; and that Dylan had been to his birthday party last year.

Tim felt that it was Dylan who stuck his head through the ceiling and pointed the gun at him and then eased back down without shooting him. Det Demmel asked Tim why he

thought it was probably Dylan that pointed the gun at him and did not shoot him with Tim relating that he had called Dylan Sunday evening the 18th at about 8:00 or 9:00 P.M. and that they had discussed a Fantasy League baseball game that they played with 10 other students. Tim explained that his friend Chad Laughlin played the role of the baseball commissioner or owner and that the people who played the game pretended that they traded players. He stated that in his conversation with Dylan on the 18th that Dylan had talked about trading someone for Yankee's pitcher Roger Clemens. Tim reported that Dylans attitude and demeanor seemed normal.

In discussing any drug use that Tim was aware of concerning Eric Harris and Dylan Klebold Tim stated that he was aware that Dylan took some kind of energy pills that he bought at the store.

Tim stated that Nate Dykeman was his best friend and that he had called and talked to Nate in Land of Lakes, Florida last night which was May 5th. Tim stated that Nate had been very close with both Eric Harris and Dylan but had recently gotten a new girlfriend by the name of Kristi Epling who, along with his job at the Firestone store located at Pierce and Elmhurst, had kept Nate occupied and busy. In asking what Nate had talked about in their phone conversation last night Tim stated that Nate thought that Eric and Dylan had probably carried their bombs into the school during a 2 hour block of time that they disappeared from the after prom party at the school. Tim himself was at the after prom party along with his mother Kim who acted as a chaperone. Tim said that he didn't realize that both Eric and Dylan had left from 2:00 to about 4:00 A.M. but that he did talk to Dylan about 4:00 A.M. about boxing with 5 pound gloves in a game that had been set up for the students. They decided not to box and then went separate ways. Tim stated that Nate had told him that both Eric and Dylan had disappeared from the party between 2:00 and 4:00 and that was his theory of when they may have carried materials into the school and hid them.

When Det. Demmel asked Timothy if Nate Dykeman had any prior knowledge that Eric Harris and Dylan Klebold were going to do something Tim replied that Nate had said he knew they were going to do something but that he did not know they were going to do what they did.

#### Narrative:

Interview with Matt Katzenmeier

On 5-3-99, Inv. Reker did conduct an interview with Matt Katzenmeier at his residence with his parents present.

In that interview Matt did relate that he was in the cafeteria at the vending machines near the west entrance and that he heard 2 shots and yelling in the parking lot and that Sean Graves had been shot as well as another person.

Matt observed 1 suspect by the west entrance to the library and this suspect was described as 6-3 w/m long brown hair and a black ski mask and black pants and with an unknown weapon.

Matt then saw another male described as 5-9 w/m with black trench coat and a black baseball hat turned backwards and that this person threw a pipe bomb towards the doors.

Matt also states that he observed an older light green car, possibly a Buick, driving around the senior parking lot and that it contained one person whom he did not know, but that the car "peeled out " of the parking lot when the shooting started.

Matt states that he then went back into the school via the west cafeteria door and went to the auditorium where he heard shots and then ran to the entrance by the wieght rooms and than out the building to the softball field, and that a Zach Piercy came out the door yelling to run that "they are shooting at us".

Matt states that he did not see the gunman come in the west door of the cafeteria.

Matt related that he heard shots or explosions in the school at the same time that the 2 suspects were outside the school.

A Nick Goodrich stated to Matt that a person was running down the language arts hallway trying to break windows out with a pistol handle and an unknown person stated to Matt that a person was in the main hallway at that time with a shotgun and that Matt did not feel it was the original 2 suspects.

Matt stated that Adam Beard is a friend of the Harris and Kliebold and that he feels that Beard knows more about the shooting. He also stated that a Micheal Bogaco Adam Beard, and an oriental student known as "Kintero" (sp?) [editor's note: Kentaro Kojima] all left school just prior to the shooting and Matt felt this was strange.

At this time the interview was terminated







Disposition: Judy KELLY SUBJECT: Teacher Columbine High School Ms. KELLY was interviewed on 05-25-99 at Charfield High School, about 12:30 hrs. KELLY had no information about any student who may have run from the room prior to the bell having rung to end 4th hour. She said that prior to the bell, the students lined up at the door as has been their custom in that class, and she said if one of them left before the bell, it was without her seeing. While interviewing KELLY, I asked if was in class on April 20, 1999 during 4th hour. Her initial reaction was that he was not in class that day, and said that he frequently did not attend class, but she was unsure due to the passage of time. When Lold KELLY that although two of the students who were in class that day told me that was not in 4th hour class, the attendance records support that he was in class; whereupon she reversed and said she thought was there. KELLY said that the senior who sat next to could probably tell us if he was in class that day. Her name is Crystal BRAGAZZI. (Lead generated). I followed up by re-contacting the source, Greg BARNES (cell phone number 720-951-2180 / new residence phone 303-984-0343). BARNES told me that the student who left the room early that day was Matt RIECKS. BARNES does not recall BROWN being in class during that period.

Prior investigation (Control number 3354) reveals that RIECKS is a peripheral associate of the TCM, and that he left class that day to go to the tech lab to get onto the internet prior to going to

lunch. He was just leaving the tech lab when the shooting started, and fled the building. RIECKS is best friend.

Judith Kelly, 8160 West Baker Avenue, Lakewood, Colorado 80227, telephone number: (303)989-2201, was advised of the identity of the interviewing agent and sergeant and the nature of the interview.

Information was received that Columbine High School counselor, Brad Butts and teacher, Judith Kelly were reportedly concerned about a creative writing paper Dylan Klebold wrote which detailed a planned shooting involving the Trenchcoat Mafia.

Kelly was advised that the above information was received and she voluntarily provided the following information:

Kelly stated that she is an English teacher at Columbine High School and Dylan Klebold was her student for a creative writing class. She advised that Klebold wrote a story for class as part of an assignment given to the students. Kelly reported that it was well written but very disturbing. She stated that she made a copy for the school counselor, Brad Butts and believes she returned it to Klebold after she graded it. She is not sure if she kept a copy which would be at the school. Kelly thought Klebold may have typed it on the school computer located in the Tech Lab. The teacher for the Tech Lab is Rich Long and the Lab Assistant is Peggy Dodd.

Kelly stated that the paper did not mention the Trenchcoat Mafia but remembers that it was about a man arriving in a town with guns who kills the popular type kids. The end of the story portrays this man or implys that this man is a God like figure. Kelly stated it was very well written, "literary and ghastly". She believes it was written in late February or early March of 1999. Kelly discussed the paper with Klebold stating its cruel and disturbing. She advised that Klebold replied that its just a story. She advised him she found it offensive. Kelly also stated she spoke to Klebold's parents at length about him handing in a disturbing story. Kelly stated that they did not seem worried and made a comment about trying to understand kids today. Kelly advised that her classroom is LA-8 (Language and Arts).

Following the interview, Kelly paged SA Lipka to add that she was not sure if Klebold actually wrote the paper or if he plagiarized it.

Subsequently, on 05/04/99, SA Lipka and Sgt. Conroy proceeded to Columbine High School crime scene and located LA-8 classroom. In the classroom, SA Lipka located the paper described above in addition to papers written by Eric Harris,
and Upon return to the Command Post,
SA Lipka provided these papers, in an evidence bag, to Lead Investigator, Kate Battan, on 05/04/99.


#### INVESTIGATION:

On 05-05-99, I met with Lara Kenney at her residence, reference the Columbine shooting. I explained to Lara that I was there to talk to her regarding the shooting and where she was during that time. I then showed Lara a diagram of the cafeteria and asked her to circle where she was sitting the day of the shooting. Lara circled table "NN" and placed an "x" where she was seated. I asked Lara if she could tell me what happened that day. Lara said she was coming from the Language Arts hallway and entered the cafeteria to do her homework. Lara said while she was sitting there, the cafeteria became very quiet and she heard someone tell everyone to get under the tables. Lara said she then heard Mr. Sanders yell at everyone to get under the tables and stay there. Lara said they stayed under the tables for a short time and then Mr. Sanders told everyone to run upstairs. Lara said she did run upstairs past the science and math rooms and left the building through a door at the end of the hallway. She then ran to Leawood Park. I asked Lara if she heard any shots or explosions. She said that while in the cafeteria she believes she heard three shots and when leaving the building, she heard six more shots. I asked if she heard any explosions and she said not that she recalls, that she was just running and trying to get out of the school asked Lara if she had seen any of the shooters and she said, "no". I asked Lara if she remembers seeing two large duffel bags in the cafeteria and she said "no". I asked her if she remembers seeing anyone carrying or in possession of two large duffel bags and she again said, "no". I asked Lara if she remembers seeing Eric or Dylan on Monday or Tuesday and she said "no," she didn't know who they were. I asked Lara if she had left anything behind in the cafeteria. She said she left her blue Jan Sport backpack. I asked Lara if she had seen or talked to any of the Trench Coat Mafia members on Monday or Tuesday and she said no, she did not. I asked if she had heard anything about any other suspects making bombs or buying

guns and she said "no. I asked what she was wearing that day and she said jeans, a blue tank top with a blue shirt tied around her waist. I asked Lara if she had any further information. She said she remembers hearing from someone (she does not know who), that there was another shooter in the school, who was wearing a white shirt, but she doesn't know who said that, and that's all that she's heard. I asked Lara if there was anything else that she can remember and she said no. I gave Lara a business card and asked her to call me with any further information and she said she would. At this time the interview with Lara was concluded.

### INVESTIGATION:

On 05/05/99, I met with Jamie Kettlewell at her residence, reference the Columbine shooting. I explained that I was there to talk to her about the shooting and to find out where she was during the shooting. At this time I brought out a sketch of the cafeteria and asked her to show me where she was seated. Jamie pointed to an area by the service line and said she was standing there waiting to pay for her meal. I asked Jamie if she had a backpack on at that time and she said no, she'd left everything over next to the wall by table "K". I asked Jamie what time she was in the cafeteria and she said approximately 11:20. I asked her to tell me what had happened that day. She said while she was standing in the service line, a male known as Chris (LNU) [editor's note: Chris Markham], ran into the cafeteria and told everyone to "get down" there was a "kid with a gun". Jamie said that she got down under a table and stayed for approximately 5 minutes. Jamie said she then got up from the floor and observed students running up the stairs. Jamie said she ran towards the bathroom area and heard approximately 5 or 10 students yelling to get out to the auditorium. Jamie said she went into the auditorium with numerous other students and while in there she remembered hearing, what she believed to be, the shooters pounding on the doors trying to get into the auditorium. Jamie said the shooters never entered the auditorium, that they finally gave up trying to get in. Jamie says she remembers a janitor coming into the auditorium, telling everyone to run for the commons area, into the business hallway, and leave the school. Jamie said that she did run through the commons area and exited the school. I asked Jamie if she remembers hearing any shooting and she said she believes she heard shooting from the student senior lot. Jamie said that she heard from someone (she doesn't remember who), that Eric was standing at the top of the stairway by the cafeteria, shooting into the cafeteria. Jamie says she remembers running through the commons area to leave the school and it was full of smoke like something was on fire. I asked if she heard any explosions and she said that she did remember hearing an explosion while she was running to the auditorium. I asked Jamie what happened when she was outside. She said she went toward the Clement Park area and met up with Tiffany Burk, who picked her and other students up in her car and left the area. Jamie said that she believed this to be "strange" that Tiffany Burk was at school at that time, because she was not there during school in the morning hours. I asked if she knew Tiffany Burk. and she said she had met Tiffany before, but Tiffany was being a "spokesman" for the girl who bought guns for Eric and Dylan, and that's the only reason she really knows of her at this time. I asked Jamie if she remembers seeing Eric or Dylan that day and she said, no, she did not. I asked if she had seen who the shooters were that day and she said, no, she had not. I asked her if she remembered seeing two large duffel bags in the cafeteria and she said no. I asked if she saw anyone carrying or in possession of two large duffel bags and she again said, no.



I asked if she left anything in the cafeteria and she said she left a brown Arizona backpack with her school books. I asked her if she had seen or talked to any of the Trench Coat Mafia members on Monday or Tuesday, and she said, "no". I asked her if she had heard anything reference any other suspects, bomb makers or gun buyers and she said she heard rumors that there were possibly 6 to 8 shooters and that there were suspects on the roof shooting, but that's all she'd heard. I asked Jamie what she was wearing that day and she said jeans and a white shirt. I asked if she could give any further information on the Trench Coat Mafia, and she said, no. I asked if she'd been in the cafeteria earlier that day and she said, no, she had not been. Jamie said that she does remember someone (can't remember who), told her that they observed a white male, very tall and thin, in the cafeteria with a German swastika on his arm. She said she may have just overheard someone talking about him. I asked Jamie if there was any other information she could provide to help with this investigation. She said she could not remember anything, but that she will call me if she remembers. At this time I gave her my business card. At this time the interview with Jamie was concluded.

On 5/6/99 I interviewed 15 year old CHS student Carder Kingsbury at his home in Littleton, Co. Carder's mother was present for this interview.

Carder stated he was in the CHS cafeteria for "A" lunch around 11:20am on 4/20/99. He had walked to the cafeteria from Mr Allison's wood class, near the administration area of the school. He walked alone and arrived at the cafeteria around 11:20am. He meet up with Travis Jones and Adam Hinchey near rebel corner. They sat at a table next to the student entrance south of the cafeteria. I showed Carder a drawing of the cafeteria which depicted all the tables. He said there are 2-3 tables directly across from the rebel corner store near the student entrance, which were not noted on the drawing. He placed an X and circled it, as to where he was seated with his friends. He recalled another table in this area, with a few CHS students sitting at it. Carder did not know their names.

He recalled that around 11:30am everybody in the cafeteria laid down, then stood up and began to run towards the steps that go upstairs. Carder stated he did not hear any gunshots, but knew that something was wrong. He recalled getting on the floor for a couple seconds, then he immediately ran out the student entrance doors and turned directly towards the junior parking lot. He and Adam Hinchey continued running and turned right on Pierce street. He looked back one time as he turned on Pierce street, but only saw students running behind him. He also recalled seeing a police car driving down Pierce


towards the school. Carder stated he did not see any gunman, or any suspicious people wearing trenchcoats inside or outside the building. He believed the group he was with, was some of the first people out of the building.

Carder stated he did not see any large duffle bags anywhere in the school as he walked towards the cafeteria. He did not see any large duffle bags in the cafeteria on 4/20/99, or the previous day. He had no more information on the shootings or on the TCM.

Carder left behind a black jansport backpack with books and notebooks in it. He could not recall what he was wearing that day.

#### ACTION TAKEN:

On May 6, 1999 the Reporting Agent Linda R. HOLLOWAY interviewed student Michael Edward KISH at his residence in Littleton. He was asked to relate what he did on April 20, 1999. He stated that he was picked up at his home by Mark RADTKE at 7:05 a.m. an arrived at the school between 7:15 and 7:20 a.m.

He went to the library where he played the game "blackjack" with Mark RADTKE, David SMITH, Kevin HANEY, Greg BARNES and Joel GOULD. He then went to his first trough fourth period classes as usual.

He went to the lunchroom at 11:13 a.m. and sat at table WW next to the northwest door. During lunch he sat with Ieremy MULLEN, Mark RADTKE, Tanya WORLOCK. Sean NASHMAN (sp) [editor's note: NOSSAMAN] and possible Mart WILSON (he was not sure if WILSON was there or not). He was talking and reading a magazine when he heard gunshots outside the cafeteria. He looked outside the window and saw a student shot (perhaps Sean GRAVES). He stepped about 6 inches outside of the door, intending to help the shot student when he heard a loud explosion. He got up against the inside cafeteria wall next to the door. He heard other gunshots and ran into the kitchen area and then into the barbroom adjacent to the kitchen. He observed several other students starting to run up the stairs as he ran into the kitchen.

Once inside the small bathroom, he and the other students turned off the light and put their feet against the locked door. Other students in restroom at that time were: Jeremy MULLEN, Bret KOSTALNICK (sp.), Dustin (unknown last name)[editor's note: GORTON], Fletcher (unknown last name)[editor's note: WOOLSEY] and another male and female who he couldn't identify.

They sat in the bathroom for about 2 hours. After they have been in there for about ½ hour, a fire started in the kitchen and the sprinklers started going off. He could tell that there were kids in the adjacent room. When they felt all was clear, they ran out of the bathroom and back through the kitchen and out the

cafeteria door (northwest door) and to where the police were waiting. He was interviewed by CBI Agent Larry Brown once he was outside of the school.

He does not remember seeing anything suspicious like large duffel bags or anyone carrying anything like the large duffel bag inside the cafeteria while he was there. He also stated that he knows by sight the two shooters (KLEBOLD and HARRIS) however, he does not remember seeing them anywhere in the school that day.

When asked what he left behind that day, he stated that he left a purple Xerox brand expandable file under table WW, on the floor. He was wearing a gray corduror shorts, a white tee shirt with Stanley Cup Champs written on the front and a Bronco orange baseball cap. He did not have a backpack that day.

He had heard from student Joel GOULD that when he was running from the school, he saw three kids hop in a jeep by the front entrance, near the teacher's parking lot.


When asked about his knowledge of the Internet, he stated that he uses the Internet at school and at friend's homes. His screen name is "BLADE" or "CASH". He has not ICQ number. He does not know anyone with a double pierced eyebrow.

When asked if he remembered seeing or hearing the Thought of the Day, he recalled that he may have been "TODAY IS NOT A GOOD DAY TO BE HERE - 4-20."

The only other comment he had was that he felt that the "jocks" pick on other people at the school. He did not remember anything else of significance.

On 4/27/99, Jamie Klement, DOB 9/25/83, 7590 West Caley Drive, Littleton, Colorado 80123, was advised of the identity of the interviewing Agent, and the nature and purpose of the interview. She was interviewed in the presence of her Mother and Father, James Klement, DOB 6/3/43, an Sandra Klement, DOB 12/19/47. She provided the following information.

On 4/20/99, Jamie Klement went to school at normal time, approximately 7:00 a.m. She went to all of her classes to include her science class which ended approximately 11:10 a.m. She then walked with her friend, Lindsay Greer to Lindsay's math class. Jamie then met her other friend Kim Anderson, and they both walked to the cafeteria for lunch. They were sitting attable ZZ. Other students sitting at the table included:

- 1. Lori Reynolds
- 2. Elizabeth Nolan
- 3. Lauren Maestas
- 4. Kristin Cardwell
- 5. Kim Andersen

Jamie went to the lunch line to purchase some food, and was on the line with Kristin Cardwell talking and waiting. They noticed that a boy possibly named Mark Opfer ran into the west door of the cafeteria, but didn't say anything. He ran past the janitor, and then was lost in the crowd. Students were standing up and looking out the windows on the west side. Jamie then saw someone fall next to the window outside. A second person then fell, and a pop which may have been a gun shot was heard. An object flew past the window, and two more shots or pops were heard. Bo Berry [editor's note: Michael "Bo" Baribeau], and Tyrone LNU [editor's note: Garrett] ran out the doors towards the parking lot, where smoke was observed. Chris Markham and ajanitor then ran in the cafeteria and began warning everyone to get down, because there was someone with a gun. At about the same time, Mr. Sanders also ran in and warned everyone to getdown. More shots were heard, and Kristin and Jamie crawled next to the area of the elevators near the kitchen. Jamie heard metalpinging over top of their heads. Mr. Andres Jr. then came in and told the students to get inside the auditorium. Andres wanted the students to stay in the auditorium. A large group of students disregarded this request and ran down the hallway on the



west side near the gym and exited the building. They then ran out across Pierce, and then back to Clement Park. A few minutes later, some more students ran to the park from the school, and said "run, they are coming". They ran farther into the park, and then Jamie, Kristin, and Christine Bell went to Bell's house.

Jamie didn't know Klebold, and only knew Harris from seeing him around school. She had said hello to Harris in the hallway, but that was the extent of it. She did not observe Klebold or Harris on either Monday or Tuesday. She really didn't know who was in the Trench Coat Mafia (TCM), but was warned the previous year in middle school to stay away from the TCM in Columbine High School. Jamie had seen TCM types around school, but did not know any of them.

Jamie Klement did remember something that caught her attention during the student morning news broadcast. The thought for the day stated something to the effect of "You'll wish that you weren't here today.

I responded to 3194 South Dudley Street to contact and interview Brandy Klingbeil, who was a student at Columbine High School. This interview was in reference to the shooting that occurred on 4-20-99 at Columbine High School.

At approximately 1100 hours on 5-24-99, I contacted Brandy Klingbeil, who told me that neither her father, witness Doug

Klingbeil, or mother, witness Valerie Klingbeil, were currently at home. Brandy Klingbeil said she would not be able to contact them, but said they would allow me to interview her about this incident without them being present.

Brandy Klingbeil said on 4-20-99, at about 1150 hours (she believed, but was not certain of the time) she went into the cafeteria at Columbine High School and was carrying her backpack (which she described as a blue Jansport with her name on it). She said she selected a cafeteria table to sit at. On the diagram of the Columbine High School cafeteria, Brandy identified table "S" as the one she selected. Brandy said she sat at this table facing in a north easterly direction towards the stairway that leads to the second level of Columbine High School. Brandy said she was with Amber Rosetta, Matt Bruce, Matt Hill, and Ben Schumann.

She also identified where these students were sitting at the table on the diagram.

Brandy Klingbeil said that Ben Schumann went to the Rebel Corner at the cafeteria, and when he returned to the table he said either he saw someone who had been shot or he saw someone get shot. Brandy Klingbeil said at this time a janitor told the students in the cafeteria to get down on the floor and underneath the tables. Brandy said the students at her table got under the tables and remained there for approximately one minute. Brandy said she heard other people screaming so she got up and ran up the stairway to the second level of Columbine High School with other students. When she got to the top of the stairs Brandy said she heard three shots that sounded to her like they were coming from the cafeteria downstairs. She said when she got to the top of the stairs she named to the right, but did not go past the library, instead made a fast left turn and went down a hallway, then exited the school through the doors by the math classrooms. She said when she had turned right at the top of the stairs and then turned left quickly she did not notice anything unusual or hear anything unusual that she could recall in the area of the library. Brandy said once she exited the school, she ran across South Pierce Street and into Leawood Park. She said she was running with several other students and when one of these students said they were going to run to one of their houses in the Leawood area, Brandy said she asked if she could go along with them, even though she did not know who these students were. She said she was told she could go with them.

Brandy Klingbeil said on 4-20-99 she was wearing blue jean shorts and a Columbine High School warm up jacket for soccer. This jacket is blue with red and white stripes on the sleeves and has a Rebel insignia on the back of it.

I showed Brandy Klingbeil photographs of the duffle bags and the propane tank that were later recovered in the cafeteria. She said she did not recall seeing either of these items prior to or during the incident. She also said she does not know of anybody who may be manufacturing explosive devices and/or possess firearms. She said she will contact me if she hears of anything like this in the future.


Brandy Klingbeil said she does not know Dylan Klebold or Eric Harris. She said she did not know any of the "Trench Coat Mafia" students or their names. Brandy said she knew of the "Trench Coat Mafia" and had seen them walking up the sidewalk at Columbine High School while she was at soccer practice. She believes she saw three of them walking together. She said she did not see anyone harassing the "Trench Coat Mafia" students, nor did she see the "Trench Coat Mafia" students harassing any other people.


Brandy Klingbeil said she did not know anybody with a double pierced eyebrow. She said she is aware that the Columbine High School Rebel News Network (RNN) has a thought of the day after the announcements in the mornings, however, she said she does not pay attention to them. She did not know what the thought of the day was on 4-20-99.

Brandy Klingbeil said she has been doing fine dealing with this incident since it occurred on 4-20-99, however, I left business cards for her and her parents and told her to contact me if any of them wanted to talk to a JCSO Victim Advocate in the future. I advised her I would make the necessary arrangements for them.

Lacy Koch, Dob: 05/02/83, 8210 West Calhoun Drive, Littleton, Colorado, was interviewed regarding her presence in the cafeteria during the shooting.

Koch was in the serving line getting lunch. She sat her tray down on a table. A little kid ran by her, yelling that there was a guy with a gun. She stated no one took him serious. Mr. Sanders and Mr. Kritzer then entered the cafeteria and yelled for everyone to get under tables. Koch then heard 6 or 7 pops from outside. She thought they sounded different than gunshots, but not explosions. She then heard louder show in the cafeteria. She ran to the stairway which leads upstairs to the library and auditorium. She ran up the stairs, turned to the left, and ran to the East exit of the school. She then joined other students and teachers at Leawood park on the East side of Pierce Street.

During her time in the park she overheard rumors that there had been a bomb threat earlier in the morning. She said a group of teachers were in the park, near an ambulance. At one point she thought Mr. Moore, a black teacher, was being shot at from somewhere. She said Mr. Moore appeared to be moving around to dodge fire.

Koch did not see the suspects and could not provide any information on them. She only saw people falling down outside the cafeteria and stated she tripped on several people who were falling while running from the school.

## **INVESTIGATION:**

On May 4, 1999, between the hours of 1048 and 1142, I had an opportunity to speak with Lacy in reference to the incident that occurred at Columbine High School on April 20, 1999. Also present during the interview was Lacy's aunt, Barbara Rice.

Lacy explained that she arrived at Columbine High School on April 20, 1999, at about 0715 hours, attending her normally

scheduled classes. Lacy stated that fourth hour she has a math class taught by Mr. Bundy. After she was released from her fourth hour class at 1110 hours, she proceeded down into the cafeteria for lunch, arriving around 1113 hours. Lacy stated that she did not observe anything out of the ordinary while she was walking to the cafeteria area. Lacy was provided a map of the cafeteria area and asked if she could tell me which table she was seated at. Lacy stated she was seated at table T with her friends, Kristen Schoenhoff and Jennie Smith. Lacy stated after placing her green backpack on a chair at the table she proceeded to the rest rooms, which are located near the kitchen area or near the lower entry doors into the auditorium. After leaving the rest room, Lacy proceeded to the food service line, where she got her lunch. As Lacy turned and walked towards the condiment table, which is near the food service line, she stated that she recalled that an unidentified student, who she believes was a freshman, came running from the vending machines, which are near the northwest door of the cafeteria, and the student was yelling, "Oh my God, get down, there's somebody outside with a gun." Again, Lacy stated that she did not know who this individual was. She recalls that shortly after this person entered into the school she remembers seeing Mr. Sanders and Mr. Kritzer come out of the faculty 'ounge and they were also telling students to get under their table.

Lacy explained that she crouched down and that she remembers seeing her best friend, Sarah Anderson, Tina Chavez, and Samantha Roman also crouched under the table, at which time she heard anywhere from six to seven gunshots, or as she described they sounded like firecrackers popping outside, and she could see people outside running in all different directions. As this occurred the students who were near the west side of the cafeteria started moving east and continued up the stairs to the main level in the school. Lacy advised that she followed the other students, heading out of the cafeteria, and remembers that once she reached the top of the stairs she remembers hearing gunshots and they were coming from the cafeteria area. Lacy explained there was a large group of students that had fallen in the hall, just to the east of the staircase, and that she had to maneuver around them. She continued east down the math/science hallway to the southeast exit of the school, where she ran from the school and went to Leawood Park. From Leawood Park, Lacy stated that she went to Josh Brinkley's house, but they were unable to get into his residence because he had forgotten his keys in the school, at which time they contacted one of Josh's neighbors and were allowed to stay for a brief period of time.

Lacy was asked while she was in the cafeteria area if she observed two large duffle bags or sports bags, one being blue in color. und the other being reddish/orange color. I explained to her that they were in the central core area of the cafeteria. Lacy could

not provide any information about the bags, telling me that she did not see them. Lacy was asked if she observed any gunmen while in Columbine High School or if she observed any gunmen after she had exited. She stated she did not,

Lacy was asked if there had been any rumors of something that was going to occur on April 20th. She stated that she knew April 20th was National weed or marijuana day, and she also explained that on the morning of April 20th she remembers hearing about a bomb threat.

Lacy was asked if she members of the Trench Coat Mafia, specifically Eric Harris or Dylan Klebold or any of their associates. She stated she didn't personally know any of them, and that she didn't know any of the associates, but she did mention that as apparently on a hit list that Eric Harris and Dylan Klebold had. Lacy was asked to describe her dress on the day of the incident in question. She stated that she was wearing a long sleeve, green Gap shirt. Underneath that shirt was a white tank top, black pants, and black sandals. Lacy described her backpack as being green in color and the brand name was "Nike."



At "A" lunch hour, 11:30 am, I don't know what came first a shot or explosion. We ducked down under the tables. I peered out through the windows into the parking lot and saw an explosion + some rising into the air. I saw kids all running up the stairs. We stayed under the table. Then we moved into the kitchen and hid in closets. I hid in the bathroom with others. Me + Dustin decided to peer out. I went out first and made my way where I could see into the cafeteria. I looked into the cafeteria and saw something burning on the ground- saw a flame. I went back to the door + met Dustin there. I looked out into the cafeteria + saw him dressed in black, appeared to be a male, + carrying a bomb, a black object in his arms. We darted back into the bathroom, waiting there. Dustin + I decided to leave. I looked out and saw it was clear. Dustin led all the people out.



Detective Polak interviewed Mr. Kritzer at his home. The following is the notes of the interview.

I taught my 4<sup>th</sup> period class. I walked to the cafeteria to get lunch. The lunch area for the teachers is just

outside the teachers lounge. I got my lunch and began walking through the middle of the lunch room to

go back to my office to eat. About half way through the room, I heard what sounded like shots. I thought

it was a prank. I looked out the west windows and saw people down on the hill. It became real tense

The janitor was telling people to keep down. It was decided that the threat was outside. The students


were told to get out. Most ran upstairs. He began to go upstairs when he saw two girls outside-going

Them to get down. He poked his head out the door and told them to go east. He was by the stairs when explosions started at the bottom of the steps. Possibly thrown from upstairs. He had noticed that there was a thud and then a couple second delay, and then an explosion. As a result he chose run and dive when one landed by him. He was hit in the calf by something but not injured. He ran to the kitchen and hid on the floor. Eventually they locked themselves into a closet with teachers and students. There were 14 in the closet. The janitors were in the cooler. They did hear foot steps and knocking on the door but the stayed in there until the SWAT let them out.

Eric Harris is a student in his 3 period class. He sits in the back corner. Rebecca Hines, a gothic, sits with him and Brooks Brown sits in front of him. He believes Harris was in class on Monday, but not Tuesday. He gave a test on Tuesday. If his test paper is not on the desk, then Harris was not there. He also could not recall if he marked him absent. Autumn Hettinger told him that she saw Eric Harris in the parking lot. His trench coat was covering something. She may have told him he missed the Tuesday test.

On 04-29-99 at 2:20 P M. Denver Police Detective Terry Demmel, assigned with the Columbine Law Enforcement Task Force, interviewed Columbine High School teacher Eric Kritzer by phone. Det. Demmel asked Eric if he had Eric Harris in his 3<sup>rd</sup> hour Philosophy Class to which Mr. Kritzer answered "yes; he did ". When asked if Harris was in class that day, Tuesday the 20<sup>th</sup> Mr. Kritzer stated that he didn't believe so but that he could possibly have been. Det. Demmel told Mr. Kritzer that student Vennessa Grimes had been interviewed and reported that both Eric Harris and been in class with her that day and had discussed Chinese Philosopy. Mr. Kritzer did not think that have any discussions that day but instead had a written test on Chinese Philosophy. Mr. Kritzer added that the one sure way to tell if the boys had been in class that day was to check the folder of test papers that was in the room.

In asking Mr. Kritzer if Eric Harris had made any statements or given any indication of behavior out of the norm he answered that Harris was a good student and that he would have to check his grade book to see where Harris stood as far as his grade was concerned.

Mr. Harris advised to get in touch with his 3<sup>rd</sup> hour class student assistant, Rebecca Hines; that she may be able to give some additional information on Eric Harris.

On 04-30-99 Det. Demmel spoke with Jefferson County Sheriffs Office Columbine High School Scene Commander Chris Andres advising him of the information. A short time later Jefferson Co. Sheriffs Commander Andres called Det. Demmel back with the information that they had gone to Mr. Kritzers 3<sup>rd</sup> hour Philosophy room and found the folder of test papers. He stated that both Vannessa Grimes and had taken the written test but that there was no test paper for Eric Harris.



We then barricaded the door and waited 1 hr 45 min until SWAT team got us out. I heard several shots from library upstairs and from cafeteria.
